### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Endicott Precision Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements. ### **Notes to Financial Statements**

#### NOTE A-DESCRIPTION OF PLAN

The following description of the Endicott Precision Inc. Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The plan is a 401(k) Defined Contribution Plan, with discretionary profit sharing contributions allowed, covering all full-time employees of the Company who have one year of service and qualifies for enrollment and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 197 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### Contributions

Each year, participants may contribute up to 12% of pretax annual compensation, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Independent Service Provider, Principal Life Insurance Co currently offers pooled separate accounts and an insurance investment contract as investment options for participants. The Company matches 50% of the employee's contribution up to 4% of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are invested in the manner selected by the employee. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In order to receive employer profit sharing contributions for a given Plan year, an employee must be employed by the Company on the last day of the Plan year.

##### Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100% vested after seven years of credited service.

### Participant Loans

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$40,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or roll the account total over to another qualified plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

## NOTE B-SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### Estimates

The preparation of financial statements in conformity with generally accepted accounting principles require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of pooled separate accounts are valued at quoted market prices which represent the net asset value of the accounts held by the Plan's Independent Service Provider, Principal Life Insurance Co. at year-end.

### Subsequent Events

Plan management has evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

## NOTE C-INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has available investment contracts with Principal Life Insurance Co. Principal Life Insurance Co. maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal Life Insurance Co. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Contract Value is the amount participants would receive if they were to initiate permitted transactions under the plan. Early termination fees are contingent upon the premature withdrawal of funds from the Investment Contract.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. During the 2024 reporting period, the Principal Stable Value Select Fund+ earned 2.40%. The assts in the account earned 2.40%.

#### NOTE D-RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by Principal Life Insurance Co. Principal Life Insurance Co. is the Independent Service Provider as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal Life Insurance Co. amounted to \$4,189. for the year ended December 31, 2024.

#### NOTE E-PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their contributions.

#### NOTE F-TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated August 7, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### NOTE G-CERTIFIED INVESTMENT INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from the Trustee that all of the information provided by them is complete and accurate.

The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified as complete and accurate by Principal Life Insurance Company, the Trustee, for the years ended December 31, 2024 and 2023:

#### NOTE H-FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Cash and Cash Equivalents*** – Valued at cost plus interest which approximates fair value.

***Mutual Funds*** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common/Collective Trust*** – Valued at the net asset value, based on the fair values of the underlying investments reported by the Trustee of the funds. Fair values for the underlying assets were based on either quoted prices in active markets or observable inputs or quotations from inactive markets.

#### NOTE I-RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
