Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor’s report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan’s financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. You have corrected all such misstatements.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Other Matters

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

On September 22, 2025, the Plan Sponsor approved the termination of the Plan. In connection with the termination, all Plan assets are expected to be distributed to participants and beneficiaries in accordance with applicable regulations. As a result, a significant decrease in plan assets is expected subsequent to December 31, 2024. The termination and related distributions represent a subsequent event that occurred after year-end and, accordingly, has not been recognized in the accompanying financial statements.



Notes to the Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of the STS of NYS, Inc. Profit Sharing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established for the purpose of providing eligible employees of STS of NYS, Inc. (the “Company”) and their beneficiaries, funds for retirement. An employee of the Company, who is not a union or leased employee or a non-resident alien or is otherwise covered by a collective bargaining agreement, can enroll in the Plan on the first or seventh day of the month following the date the employee reaches the age of 21 and has one year or 1,000 hours of continuous service with the Company. The Plan is managed through John Hancock Life Insurance Company of New York (“John Hancock”).

Effective January 1, 2024, the Plan was amended to revise the ADP/ACP Safe Harbor Eligibility provisions. Specifically, the amendment redefines the term “eligible employees” for purposes of safe harbor contributions. As a result of this change, highly compensated employees are excluded from the definition of eligible employees.

Contributions

Each year, eligible participants may contribute up to 100% of their eligible compensation, subject to the maximum Internal Revenue Service (“IRS”) limitations, during the Plan year. For calendar year 2024, the applicable dollar amount was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants are also permitted to make Roth deferrals (after tax). Participants direct the investments of contributions into a variety of fund investment options offered by the Plan.

In accordance with the provisions of the Plan document and ERISA requirements, the Plan provides for employer contributions which may include (a) discretionary nonelective contributions, (b) discretionary matching contributions, and (c) safe harbor contributions.

The Plan provides for discretionary nonelective contributions, which may be allocated to eligible participants at the direction of the Plan sponsor. Employer contributions are allocated to participants using the comparability allocation method, whereby contributions are divided among designated participant groups and then allocated to individuals within those groups. The allocation method is designed to comply with the nondiscrimination requirements of the IRC. Employer contributions are accrued in the accompanying financial statements based on amounts approved by the Plan sponsor for the plan year. For the year ended December 31, 2024, the Company approved a discretionary nonelective contribution of \$155,510, which was funded subsequent to year-end in 2025 and is included in the employer contributions receivable on the statements of net assets available for benefits.

The Company may make discretionary matching contributions to the Plan, as determined annually by the Company. The amount and formula of any matching contributions are not fixed and are subject to approval by the Company each year. Discretionary matching contributions are allocated to eligible participants based on the Plan’s provisions. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution.

Contributions (continued)

The Plan has a Safe Harbor provision as defined under IRC Section 401(k)(12). Under this provision, the Company is required to make a contribution on behalf of all eligible participants, regardless of whether the participant elects to defer. The Safe Harbor contribution is equal to 3% of eligible compensation (or as otherwise specified in the Plan document) For the year ended December 31, 2024, the Company made safe harbor contributions totaling \$4,376, which was funded subsequent to year-end in 2025 and is included in the employer contributions receivable on the statements of net assets available for benefits.

Participant Accounts

Participants' investments are self-directed from a choice of investments provided by the John Hancock. Each participant's account is credited with the participant and Company contributions, Plan earnings, and an allocation of administrative expenses. The participant's account is reduced by withdrawals, losses on investments, administrative fees, and any forfeitures. Allocations are based on a percentage of contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are fully vested in their own contributions and Company safe harbor matching contributions, plus actual earnings thereon. For discretionary nonelective and matching employer contributions, the following vesting provisions will apply:

A participant will become fully (100%) vested upon normal retirement, death or disability.

Forfeitures

Forfeitures of non-vested Company contributions may be used to restore previously forfeited account balances, reduce future Company contributions, or pay reasonable Plan expenses, in accordance with the provisions of the Plan document. As of December 31, 2024, and 2023 (unaudited), forfeiture balances totaled \$164,233 and \$52,672, respectively. During the year 2024 Plan, forfeitures were applied to offset prior-year employer contribution receivables totaling \$71,053.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, the Plan permits participants to receive a payout(s) in one of the following forms of distribution: lump sum, or installment payments.

Upon termination of employment, the Plan has a mandatory cash-out provision for participants with less than \$5,000 in their account, which does not require consent from the participant. In-service distributions are allowed for participants after reaching age 59 ½. The Plan allows for hardship distributions if certain criteria are met.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan, including recordkeeping, custodial, and trustee fees, may be paid directly by the Company or from Plan assets, as provided under the Plan document. Investment management fees are generally paid from Plan assets and are reflected as a reduction of investment income.

For the year ended December 31, 2024, administrative expenses paid directly by the Plan totaled approximately \$37,636. Additional expenses paid by the Employer on behalf of the Plan are not included in the accompanying financial statement.

NOTE 3: INFORMATION CERTIFIED BY JOHN HANCOCK

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock as of and for the year ended December 31, 2024.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the 2024 financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 5: TAX STATUS

The Plan is a non-standardized pre-approved profit-sharing plan with CODA and has received a determination letter dated June 30, 2020, indicating that the plan is acceptable under the IRC Section 401 for use by employers for benefit of their employees. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the Plan’s financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. The Company also reserves the right to amend, modify, suspend, or terminate the Plan permanently or temporarily, at such time as they deem appropriate. In the event of Plan termination or if the employer elects to discontinue contributions, the total value of each participant’s account will be fully vested.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
