We have performed audits of the financial statements of ABARTA, Inc. Deferred Compensation 401(k) Savings Plan for Non-Union Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the ABARTA, Inc. Deferred Compensation 401(k) Savings Plan for Non-Union Employees (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a participant-directed defined contribution plan covering substantially all full-time and certain part-time non-union employees of ABARTA, Inc. and its subsidiaries: The Cleveland Coca-Cola Bottling Company, Inc.; South Jersey Publishing Company; Coca-Cola Bottling Company of the Lehigh Valley; Coatesville Coca-Cola Bottling Works, Inc.; ABARTA Coca-Cola Beverages, LLC; and ABARTA Oil & Gas Company, Inc. (collectively, the Company or Plan Sponsor). The Company is the Plan administrator that controls and manages the operation and administration of the Plan. The Plan investments and participant loans are held by Fidelity Management Trust Company (Fidelity), the trustee.

A full-time employee becomes eligible to participate in the Plan immediately. The Plan includes an automatic enrollment policy for all newly eligible employees. Under this policy, if an employee does not submit a waiver, the employee is automatically enrolled in the Plan at a 5% deferral rate. The deferral rate will be automatically increased by 1% each subsequent year to a maximum rate of 6%.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Participants may contribute up to 60% of their annual eligible compensation to the Plan, subject to certain Internal Revenue Code (IRC) limitations.

In any calendar year in which a participant is age 50 or older, an additional catch-up contribution (limited to \$7,500 in 2024) may be made. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan provides for employer matching contributions of 50% of the first 8% of eligible compensation contributed to the Plan.

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

The Company may make discretionary contributions, as determined by the Company's Board of Directors, to the Plan. No discretionary contributions were made in 2024. The discretionary contributions made in 2023 totaled \$1,388,983.

### ***Participant Accounts***

The Plan administrator maintains separate participant accounts for each participant. Each participant's account is credited with their voluntary and rollover contributions and with an allocation of Plan earnings. Allocations of Plan earnings are based on actual earnings on participant-directed investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants' contributions and employer matching contributions and earnings thereon are fully vested at all times.

Company discretionary contributions are subject to a three-year vesting schedule.

Participants automatically become fully vested with respect to employer contributions upon attaining age 55, permanent disability, death, or death while on a leave of absence to perform military service.

### ***Benefits***

Upon termination of service due to death, disability, or retirement, or attaining age 59½, participants may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment distributions in substantially equal amounts over a period of time. If a participant's account balance is less than or equal to \$1,000 at the time of termination, the employee will automatically receive a lump-sum payment.

Subject to limitations of the Plan agreement, the Plan participant may apply to the Plan for a hardship withdrawal. A hardship withdrawal may be granted to a Plan participant for an event considered to be an immediate and heavy financial need of the participant, in accordance with the IRC.

At December 31, 2024 and 2023, there were no significant amounts allocated to accounts of individuals who have withdrawn from the Plan but have not been paid.

### ***Notes Receivable from Participants***

Participants may borrow up to the lesser of 50% of their individual vested account balance or \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 months. The minimum amount a participant may borrow is \$1,000. A participant may not have more than two loans outstanding at any time. Loan repayment terms may not exceed 60 months unless the loan is granted for the purpose of acquiring the participant's principal residence. In such instances, repayment can be over a reasonable time period that may not exceed 120 months. Loans are repaid ratably through payroll deductions over the term of the loan. The loans are collateralized by the vested interest in the participants' accounts and bear interest at a rate commensurate with local market rates for similar loans. Participant loans currently bear interest varying from 3.50% to 9.50%.

### *Forfeitures*

Forfeitures of terminated participants' non-vested accounts may be used to reduce future contributions made by the employer and to offset expenses incurred by the Plan. Forfeitures utilized to reduce employer matching contributions totaled approximately \$510,000 in 2024 and \$272,000 in 2023. The balance of forfeitures was \$2,000 and \$53,000 at December 31, 2024 and 2023, respectively.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are maintained on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

*Level 1* - This level consists of quoted prices in active markets for identical assets or liabilities.

*Level 2* - This level consists of observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* - This level consists of inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There were no transfers between levels during the year ended December 31, 2024.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year-end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

The Plan's investment in the Managed Income Portfolio (the Fund) is a public investment vehicle that seeks to preserve capital and to provide income over time.

The Fund is valued using the NAV provided by the trustee on the last day of the Plan's year-end, as a practical expedient for fair value. NAV is based on the value of the underlying assets owned by the trust, primarily corporate bonds, U.S. and foreign government agency bonds, mortgage securities, and money market funds, minus its liabilities, and then divided by the number of shares outstanding. The Plan's participants may exchange units in the Fund on a daily basis with minimal restrictions. The Plan is required to provide a one-year redemption notice to liquidate its entire share in the Fund. The Plan has no unfunded commitments relating to the Fund at December 31, 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain or loss includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Risks and Uncertainties***

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits, the statement of changes in net assets available for benefits, and participant account balances.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### *Administrative Expenses*

Administrative expenses are paid by the Company or the Plan, as provided by the Plan document.

### *Benefit Payments*

Benefits are recorded when paid.

### *Consideration of Subsequent Events*

Plan management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 15, 2025, the date the financial statements were approved and authorized for issue.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

## **5. Related Parties and Exempt Parties-in-interest Transactions**

Certain Plan investments are in funds and accounts that are managed by Fidelity Management Trust Company or their subsidiaries and affiliates. Participant loan processing fees are paid to Fidelity Workplace Services LLC, by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts.

## Notes to Financial Statements

As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Tax Status

The Plan Sponsor has adopted a pre-approved plan of Fidelity. Fidelity obtained a letter, dated June 30, 2020, in which the Internal Revenue Service stated its opinion that the form of the pre-approved plan of Fidelity is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has since been amended. The Plan administrator, the trustee, and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
