## INDEPENDENT AUDITOR'S REPORT

### **Opinion**

We have audited the accompanying financial statements of Cooper Hatchery, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits (modified cash basis) as of December 31, 2024 and May 31, 2024, and the related statements of changes in benefit obligations and net assets available for benefits (modified cash basis) for the short year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (modified cash basis) of Cooper Hatchery, Inc. Employee Benefit Plan as of December 31, 2024 and May 31, 2024, and the changes in its net assets available for benefits (modified cash basis) for the short year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cooper Hatchery, Inc. Employee Benefit Plan (Plan) provides only general information. Participants and others should refer to the plan document and summary plan description (SPD) for a more complete description of the Plan's provision.

In 2024, the board of trustees voted to move the plan's year end from May 31 to December 31. This change was adopted to align the plan's year end with the renewal of the plan's insurance agreements and Anthem's annual rate changes. The change resulted in a short period Beginning June 1, 2024, and ending December 31, 2024. Future reporting periods will follow the calendar year.

General - The Plan provides medical, dental, vision and prescription drug benefits to employees and their dependents of Cooper Hatchery, Inc. (Plan sponsor) who participate. The plan is self-funded for most claims; however, the Plan maintains a stop loss insurance policy which reimburses the Plan for individual claim expenditures over \$300,000 for the plan year. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Contributions are made by the participants at rates determined by the trustees for the benefits desired. Contributions are also made by retired and inactive employees under the COBRA provisions of ERISA and active employees as determined by the trustees. The Plan sponsor contributes the amount necessary, in excess of the participants' contributions, to timely fund all claims as they are presented for payment.

Administration – The Plan Sponsor provides and pays for management and administrative personnel who perform various functions for the Plan.

NOTE 2 - ACCOUNTING POLICIES

Basis of Accounting

These financial statements have been prepared using the modified cash basis of accounting. The modified cash basis of accounting means that contributions and other revenues are recognized when received and claims and other expenses are recognized when paid. Amounts incurred but not yet paid at year-end are reflected as benefit obligations.

Use of Estimates

The preparation of financial statements on the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the amount of reported benefit obligations. Accordingly, actual benefit obligations may differ from that estimate.

NOTE 3 - CONCENTRATIONS OF CREDIT RISK

The Plan maintains its cash balances in one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Accordingly, at December 31, 2024 and May 31, 2024 the uninsured cash balances were \$364,929 and \$1,691,543, respectively.

NOTE 4 - BENEFIT OBLIGATIONS

The Plan's benefit obligations were based upon estimates developed by the Plan's third-party administrator.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 was passed into law and effects plans providing prescription drug benefits to retirees. The Plan does not offer benefits to retirees and therefore is not affected by these provisions.

NOTE 5 - TAX STATUS

The Plan is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as exempt from income taxes. The Plan has obtained a favorable determination letter from the Internal Revenue Service and the trustees believe the Plan, as amended, continues to qualify and operate as designed.

The Plan does not believe there are currently any tax positions which have a reasonable possibility of change from taxing authorities. The Plan is subject to routine audits by taxing jurisdictions (DOL and IRS), however, there are currently no audits for any tax periods in progress. Accrued interest and penalties with uncertain tax positions, if any, are recognized as part of administrative expenses. There were no taxes or accrued interest or penalties related to the income tax position of the Plan as of December 31, 2024. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PLAN TERMINATION

Although the Plan sponsor expects the Plan to be continued indefinitely, it reserves the right to terminate the Plan at any time by action of the Board. If such termination occurs, it will be done in accordance with rules and regulations as promulgated under the Employee Retirement Income Security Act of 1974, as amended.

NOTE 7 - PARTY IN INTEREST

The Plan receives contributions from the Plan sponsor as discussed in Note 1. All funds contributed were used to maintain the plan and provide benefits for participants in the Plan in accordance with the provisions of the Plan Document.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements reflect information required by FASB Accounting Standard Codification 965-30 Plan Benefit Obligations. Accordingly, the financial statements were prepared using the modified cash basis of accounting in order to reflect the required disclosure regarding benefit obligations. However, the cash method of accounting is used for 5500 reporting purposes. Accordingly, the effects of benefit obligations are not included on the Form 5500.

NOTE 9 - AMENDMENTS & SUBSEQUENT EVENTS

In 2024, the board of trustees voted to move the plan's year end from May 31 to December 31. This change was adopted to align the plan's year end with the renewal of the plan's insurance agreements and Anthem's annual rate changes. The change resulted in a short period beginning June 1, 2024, and ending December 31, 2024. Future reporting periods will follow the calendar year. As such, the Statements of Benefit Obligation and Net Assets Available for Benefits is available in comparative form. The Statements of Changes in Benefit Obligations and Net Assets Available for Benefits is not available in comparative form as the two periods are not comparable in length.

Subsequent events were evaluated through October 10, 2025, which is the date at which the financial statements were available to be issued.
