Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Grayhill, Inc. Advantage Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Plan Description

The following brief description of the Grayhill, Inc. (the Company) Advantage Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established to enable eligible employees of the Company to share in a portion of the Company's profits and to defer receipt of a portion of their compensation for the principal purpose of providing benefits at time of retirement, disability or death. Employees become eligible to participate and become eligible for the Company matching contribution and profit-sharing contribution upon completion of 30 days of service. Employees are automatically enrolled after meeting the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant contributions: Each year, participants may contribute up to the lower of 25% of their annual compensation or the maximum allowable by the Internal Revenue Service (IRS). Unless the participant elects otherwise, new participants automatically defer 2% of their pretax annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Company matching and profit-sharing contributions: Non-discretionary Company matching contributions are made equal to a percentage or dollar amount of a participant's contributions, as defined by the Plan. Such amounts are credited among the accounts of participants who have made compensation deferrals during the year. Profit-sharing contributions are made at the discretion of the Company's Board of Directors. Contributions are allocated to the eligible participants' accounts based upon the rate of each participant's points, as defined by the Plan, to the total points of all eligible participants. Points are awarded based upon employee compensation and length of service. The total of Company matching contributions for the year ended December 31, 2024, was \$1,386,984. There were no discretionary profit sharing contributions related to 2024. Contributions are recognized when earned.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contribution and an allocation of: (a) the Company's discretionary profit-sharing contribution, if any, (b) forfeitures of terminated nonvested accounts, (c) plan earnings and (d) administrative expenses. Allocations are based on participants' account balances, compensation or points, as defined. Earnings include interest, dividends and changes in the fair value of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, as defined.

Vesting: Participants are immediately vested in their contributions and Company matching contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant's account is 20% vested per year beginning with year two and is 100% vested after six years of credited service. In the event of death, disability or retirement at designated ages, participants become fully vested.

Investment options: Upon enrollment in the Plan, participants may direct their account balances into a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options at any time.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding loan balance in the preceding 12 months or 50% of their vested account balance. Note terms range from one to five years or up to 10 years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account. The notes bear interest at rates that range from 3.25% to 8.50% at December 31, 2024, which is commensurate with local prevailing rates at the time of loan origination as determined by the Plan Administrator. Principal and interest payments are paid through payroll deductions.

Payment of benefits: If a participant terminates for any reason, the Plan provides that the participant may receive benefits in the form of a lump-sum or installments. Withdrawals are also allowed at any time for hardship reasons as defined in the Plan. Account balances less than \$5,000 at the date of termination are paid in a lump-sum upon termination.

Forfeited accounts: Forfeitures are allocated to the participants' accounts based upon the ratio of each participant's points, as defined by the Plan, to the total points of all eligible participants. Forfeitures may also be used to reduce Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42,310 and \$16,200, respectively. During the year ended December 31, 2024, no forfeitures were allocated to participant accounts.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

Investment valuation and income recognition: Investments are reported at fair value, except for the guaranteed income fund, which is at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividends.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for direct investments in fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent notes are treated as distributions based upon the terms of the plan document surrounding defaults.

Note 2. Significant Accounting Policies (Continued)

Excess participant contributions: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions adjusted for earnings.

Administrative expenses: Investment management and administrative expenses of the Plan are paid by the Plan as provided in the plan document. Certain other administrative expenses are paid by the Company on behalf of the Plan, without reimbursement.

Payment of benefits: Benefits are recorded when paid.

Accounting estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Empower Annuity Insurance Company (the Plan Trustee)

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee as of December 31, 2024 and 2023, that information provided to the Plan Administrator by the Trustee related to the following assets and income is complete and accurate related to the following assets and income. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income.

Note 4. Related-Party Transactions

The Plan's investments are held and managed by trustee. These transactions, therefore, qualify as party-in-interest. The trustees also perform administrative and recordkeeping services for the Plan. Fees paid by the Plan for the investment management services amounted to \$127,956 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services to the Plan. These employees did not receive compensation from the Plan for their services. The Company pays certain administrative expenses incurred by the Plan.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in inactive markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

Units of pooled separate accounts: Valued at the total of the net asset value (NAV) of the underlying investments held by the account at year-end. The Plan's interest in the pooled separate accounts is valued based on the information reported by the investment advisor.

Shares of registered investment companies: Valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investment from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 7. Investment Contract with Insurance Company

The Plan maintains an investment contract with Prudential Retirement Insurance and Annuity Company (PRIAC). PRIAC maintains the contributions in a general account. Prudential Financial, Inc. is no longer affiliated with Prudential Bank & Trust, F.S.B and PRIAC. The Plan utilizes an insurance product contract issued by PRIAC accordingly under power of attorney granted to Empower. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by PRIAC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals and administrative expenses. The guaranteed income fund contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The guaranteed rate of interest for 2024 was 1.82%. For purposes of crediting interest to participants, the rate for 2023 was 1.67%.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed income fund. Contract value, as reported to the Plan by PRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value within reasonable timeframes.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest and adjusted rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed semiannually by PRIAC.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Participants should refer to the investment contract for a list of such events. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There are no contract termination clauses or charges applied upon discontinuance to terminate the agreement prior to the scheduled maturity date.

Note 8. Tax Status

The Plan is a nonstandardized 401(k) profit sharing plan and trust. The prototype plan has received an opinion letter dated September 16, 2022, from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving this letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with applicable requirements of the Internal Revenue Code.

Note 8. Tax Status (Continued)

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
