Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of KBC, Inc. 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from Charles Schwab Trust Bank (Charles Schwab) as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE A – DESCRIPTION OF PLAN

The following description of the KBC, Inc. (dba Johnstone Supply) (hereinafter referred to as the Company) 401k Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan covering eligible employees of the Company who are age 21 or older. Employees who have completed one month of service are eligible to make salary deferral contributions to the Plan. Employees who have completed one year of service are eligible to receive employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to qualify under the applicable sections of the Internal Revenue Code of 1986, as amended.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, provided the contribution does not exceed limits established by law. Roth elective deferrals are also allowed by the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company may make discretionary matching contributions to the Plan and discretionary profit-sharing contributions. For profit-sharing contributions, if a participant is employed on the last day of the year or has 500 hours of service during the Plan year, the participant is allocated the profit-sharing contribution. For the years ended December 31, 2024 and 2023, no profit-sharing contributions were made to the Plan. The Company made discretionary matching contributions of \$741,890 and \$733,921 for the years ended December 31, 2024 and 2023. Participants direct the investment of their contributions, and employer contributions, into various investment options offered by the Plan.

Participants' Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Investment

Participants in the plan direct all employee and employer contributions in the various investment options. The Plan has a self-directed account whereby participants can choose their investment option outside of the regular investment line-up.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company matching contributions become fully vested after completion of five years of service. Company contributions also vest 100 percent upon normal retirement age, death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at local prevailing rates as determined by the Plan Administrator. Participants may not have more than two participant loans outstanding at any time. The interest rates for notes receivable for the years ended December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are repaid through payroll deductions, if available.

Payment of Benefits

Upon termination of service, retirement, disability or death, a participant (or his or her beneficiary) may elect to receive the vested portion of his or her account. In addition, participants may elect in-service distributions, including financial hardship distributions, as defined by the Plan.

Forfeited Accounts

Forfeitures from nonvested accounts can be used to pay plan expenses or used to reduce Employer contributions to the Plan. During the years ended December 31, 2024 and 2023, forfeitures were not significant.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Registered Investment Companies (RICs) (Mutual Funds, Exchange Traded Funds, etc.): Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Valued at quoted market prices of the investments held in the brokerage accounts. These are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – TAX STATUS

The Plan adopted a non-standardized form of a pre-approved plan sponsored by TD Ameritrade Trust. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision of liability for income taxes has been included in the financial statements. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

NOTE F – PLAN TERMINATION

Although the Company has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H – RELATED PARTY TRANSACTIONS

Plan assets are held in investment options managed by Charles Schwab. Charles Schwab is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan incurred expenses of \$102,246 and \$76,429 for investment advisory services to Professional Retirement Strategies and \$34,361 and \$27,993 for recordkeeping services provided by Newport Group, Inc. for the years ended December 31, 2024 and 2023, respectively. All transactions with related parties were conducted on terms equivalent to those prevailing in an arm's-length transaction.
