Note 1 - Description of the Plan

The following description of the AAHI 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for complete information regarding the Plan's provisions.

General - The Plan is a defined contribution plan for the benefit of employees of The Access to Advanced Health Institute (the Sponsor). All employees, except nonresident aliens, union employees, leased employees, and part-time/temporary employees (unless service requirements are met), are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other eligible plans. The Plan adopted an automatic enrollment feature under which new employees are automatically enrolled at a 2% pre-tax deferral rate unless they affirmatively elect not to participate in the Plan or elect a different deferral amount.

Effective January 1, 2016, the Plan was amended to add a safe harbor match provision. Effective January 1, 2023, safe harbor matching contributions equal 100% of the first 6% of eligible compensation deferred by participants. The Sponsor may also make discretionary nonelective contributions. There were no discretionary nonelective contributions authorized by the Sponsor for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Sponsor's nonelective contributions (if any) and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their salary deferrals and safe harbor matching contributions plus actual earnings thereon. Matching contributions made prior to 2016 and nonelective contributions vest ratably over three years.

Payment of Benefits - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive a distribution of their vested account balance. The distribution may be in the form of an annuity, a single lump-sum payment, installment payments, or a partial withdrawal. Participants may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals) upon attainment of age 59½. The Plan also provides for hardship withdrawals in accordance with provisions specified in the Plan document.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their entire vested account balance or \$50,000. The minimum amount required to be borrowed is \$1,000. The interest rate on such borrowings is equal to prevailing rates as determined by the plan administrator. Loan repayments, consisting of principal and interest, are made through regular payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may be extended up to ten years.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Investment Management and Administrative Expenses - The Plan's investment options are subject to investment and administrative fees based on a percentage of invested assets. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor.

Subsequent Events - The Plan's management has evaluated subsequent events through October 9, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts - The fair value of participation units in the pooled separate accounts is determined by The Standard Insurance Company (Standard) based on the valuation of the underlying investments at the end of the year. Net asset value (NAV) per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments. However, if the Sponsor terminates the group annuity contract with Standard, redemption restrictions may apply to the pooled separate accounts.

Note 4 - Fully Benefit-Responsive Investment Contract

The Sponsor entered into a guaranteed interest contract with Standard. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Standard which will never be below 1.0% annually. The crediting rate is reviewed on a quarterly basis for resetting.

Note 4 - Continued

The Plan's ability to receive amounts due in accordance with the contract is dependent on Standard's ability to meet its financial obligations. Standard's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the issuer or otherwise.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Therefore, the guaranteed interest contract is considered to be fully benefit-responsive and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus interest, less withdrawals and administrative expenses.

Certain events might limit the ability of the Plan to transact at contract value with Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, or corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the Sponsor's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, or failure to adopt the Plan in a reasonable period of time.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan invests in a group annuity contract issued by Standard. Standard is the recordkeeper and custodian of the Plan; therefore, transactions with the Plan's investments and payments from the Plan to Standard qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

Note 8 - Tax Status

The Sponsor adopted a Standard Retirement Services, Inc. pre-approved plan document. Standard Retirement Services, Inc. received an approval letter from the IRS dated June 30, 2020, which states the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan provides for various investment options, which in turn invest in a combination of investment securities such as stocks, bonds, and others. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the guaranteed interest contract issued by Standard. This investment represents approximately 7% and 10% of total Plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by placing its contracts with high-credit quality institutions.
