### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan, established on May 1, 1968, is a defined contribution plan covering substantially all employees of Ted Britt Ford Sales, Inc. and its subsidiaries (the Company), as well as affiliates of the Company and the Plan's participating employers: MGB Cycles, LLC , Orange Cycles LLC and ODHD LLC (newly formed in 2024) (collectively, the Companies). The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: Employees are eligible to participate and subject to auto enrollment once they have completed 60 days of service and are age twenty-one or older. Employees may enter the Plan on the first day of the calendar month coincident with or next following the date the eligibility requirements are met. Leased employees are excluded from participating in the Plan.

Contributions: Each year, participants may elect to make pre-tax or Roth after-tax deferral contributions up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). Under the Plan's auto enrollment provision, a contribution of 6% of compensation will automatically be elected, unless otherwise directed by the employee. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Companies may make the following contributions on behalf of participants:

A discretionary matching contribution as determined by the Companies. For 2024, the Companies contributed a discretionary matching contribution equal to 25% of employee deferral contributions (including catch-up), up to 2% of eligible compensation (as defined). The discretionary matching contribution for 2024 totaled \$465,253.

A discretionary non-elective contribution as determined by the Companies. The contribution is allocated pro-rata in the ratio that each participant's plan compensation bears to the plan compensation of all eligible participants. To share in the allocation of the discretionary contribution, a participant must complete 1,000 hours of service. Participants not actively employed at the end of the plan year will not share in the discretionary contribution, regardless of service, unless due to death, disability, or attainment of early or normal retirement age (as defined). The discretionary non-elective contribution for 2024 totaled \$150,000, net of forfeitures. This amount was remitted to the Plan in 2025 and is recorded as a receivable on the Statement of Net Assets Available for Benefits as of December 31, 2024.

Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs or QMACs were made for 2024.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

Participant Accounts: Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and the Companies' contributions into various registered investment companies (mutual funds) offered by the Plan. For those participants who do not make an investment selection, their contributions and the Companies' contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions and QNECs/QMACs plus earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Regardless of the vesting schedule, participants will become fully vested upon death, total and permanent disability or upon attainment of early or normal retirement age while an employee.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate of Prime + 2% and can only exceed a repayment period of five years for the purchase of a principal residence. Only two notes may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums only and are payable upon termination of employment, death, total and permanent disability or upon attainment of early or normal retirement age. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals, emergency personal expense distributions and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document.

Forfeitures: Forfeitures of the Companies' contribution portion of participants' accounts (due to participants' termination prior to full vesting) are to be used to reduce the Companies' contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$93,807 and \$69,261, respectively. During 2024, forfeitures of \$69,261 and \$51,404 were used to reduce the Companies' 2023 discretionary non-elective contribution and pay administrative expenses, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and Companies' contributions are recorded in the year in which the employee contributions are withheld from compensation or in which participant compensation is earned.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Fee Revenue: A fee holding account is funded by monthly revenue sharing credits paid by mutual fund companies based upon the Plan's assets invested in those mutual fund companies. The fee revenue is to be used to offset administrative expenses. At December 31, 2024 and 2023, the balance in the Plan's Fee Holding Account was \$133,910 and \$76,687, respectively. During 2024, \$37,497 in administrative expenses were offset by this fee revenue.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. Recordkeeping, investment advisory and audit fees, net of forfeitures and fee revenue, and fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income and fee revenue for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustee, Matrix Trust Company, a qualified institution.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed CCH Incorporated, DBA ftwilliam.com, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

NWPS provides certain administrative services to the Plan pursuant to the Retirement Plan Services Agreement (the Agreement) between the Company and NWPS. The Agreement provides for an annual recordkeeping fee, which includes a base fee plus a per participant fee and a custodial/trading platform fee which is based on a percentage of plan assets. The Plan or Companies may make payments to NWPS for administrative expenses not covered by these fees. NWPS also receives fees related to the administration of notes receivable from participants and participant distributions. Fees paid by the Plan to NWPS for 2024 amounted to \$52,069, net of forfeitures and fee revenue.

Global Retirement Partners, LLC (Global) provides certain investment management services pursuant to the 3(21) Investment Advisory Agreement (Agreement) between Global and the Plan. The Agreement provides for an annual fee based on a percentage of the market value of plan assets as reported by the trustee and is billed and payable quarterly. Fees paid by the Plan to Global during 2024 amounted to \$41,277, net of forfeitures and fee revenue.

**NOTE 7 - DELINQUENT CONTRIBUTIONS**

During the plan year ended December 31, 2024, employee contributions and loan repayments in the amount of \$4,210 were not remitted by the Company to the Plan within the required timeframe, as defined by ERISA. As such, these transactions constitute prohibited transactions and are reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a). Corrections on the delinquent employee contributions and loan repayments are expected to be calculated and remitted to the Plan during 2025.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 38% and 41%, respectively, of net assets available for benefits is invested in the American Funds Target Date Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

On September 23, 2025, the Plan was amended effective January 1, 2026 to add ODHD LLC as a member of the Company's controlled group, within the required two years from the date of formation.
