Notes to Financial Statements

Year Ended December 31, 2024

1. Description of plan:

The following description of Solar Industries, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan, established in January 1999, is a defined contribution plan which covers full-time employees of Solar Industries, Inc. (Sponsor) who are at least 18 years of age with three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant contributions:

Under the 401(k) provisions of the Plan, the participants may elect to defer a portion of their annual compensation, as defined by the Plan, up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participant contributions may be in the form of pre-tax or Roth contributions. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

Employer contributions:

The Sponsor makes a safe harbor match contribution which is defined as 100% of the first 4% of compensation elected to be contributed to the Plan by the participant. Employees must be deferring compensation into the Plan to be eligible for this match. The Plan also allows for discretionary matching and profit sharing contributions. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions. The Sponsor did not make a discretionary matching or profit sharing contribution for 2024.

Participants' accounts:

Each participant's account is credited with the participant's elective deferral, rollover and employer contributions, actual earnings thereon and charged with an allocation of administrative expenses. The basis for allocations is defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increment into any of several investment options. Participants may change their investment options at any time.

Vesting:

Participants are immediately vested in their elective deferral contributions, qualified rollovers, safe harbor match contributions, and qualified non-elective contributions plus actual earnings thereon. Vesting in the employer's discretionary contributions portion of the participants' accounts plus actual earnings thereon is based on years of credited service. Participants vest at 20% annually beginning with the completion of their first year in the Plan and are fully vested after five years of credited service or upon retirement at age 65, death, or disability. The Plan defines a year of credited service to be a plan year (January 1 through December 31) with at least 1,000 hours of service.

1. Description of plan (continued):

Participants' loans:

Participants may obtain loans from the Plan. Loans cannot exceed 50% of the vested balance of the participant's account (or \$50,000 if less), and must be a minimum of \$1,000. The loans must be repaid within five years unless the proceeds are used for purchase of a principal residence, in which case the loan may be repaid over a longer term. All loans will provide for the repayment of interest at a rate comparable to rates available at local lending institutions. Principal and interest may be paid through payroll deduction. The participant's individual account serves as collateral for the loan and in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statement of net assets available for benefits as notes receivable from participants.

Payment of benefits:

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his/her account, or if the participant is subject to required minimum distributions, they may elect installments under a systematic withdrawal plan. Participants with account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. Mandatory automatic distributions under the Plan in excess of \$1,000 may be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions.

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements (continued)

Year Ended December 31, 2024

2. Summary of significant accounting policies (continued):

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent event:

The Plan's management has evaluated the events that have occurred subsequent to December 31, 2024 through October 14, 2025, the date that the financial statements were available to be issued. The Plan's management has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor has adopted a non-standardized pre-approved profit sharing plan as published by Standard Retirement Services, Inc., who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan and related trust, as then designed, were in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

3. Federal income tax status (continued):

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The assets in the preceding tables were measured primarily using the market approach. Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: These accounts' assets are invested and reinvested primarily in mutual funds, which are valued using quoted market prices for similar assets in active or non-active markets. Each account is valued at its net asset value. The net asset value of the accounts' units is determined daily and includes adjustments for investment fees. The funds' daily net asset value is available at standard.com.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment certification:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Standard Insurance Company, a qualified institution.

6. Investment contract with insurance company:

The Plan entered into a benefit-responsive investment contract with the Standard. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Investment contract with insurance company (continued):

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield, based on both actual earnings and the interest rate credited to participants, was 1.67% for the year ended December 31, 2024. The crediting interest rate is based upon an agreed-upon formula, and is reviewed on a quarterly basis for resetting.

The guaranteed investment contract does permit the insurance company to terminate the agreement with 30 days advance written notice to the contract owner for reasonable cause.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may include the following: termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules, failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

7. Related party and party-in-interest transactions:

Exempt party-in-interest transactions:

The Plan paid certain expenses to the Standard Insurance Company and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party-in-interest transactions under ERISA.

Related party transactions:

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

8. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

9. Risks and uncertainties:

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
