Savings Plan for Salaried Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of Plan

The following description of the Timex Group USA, Inc. Savings Plan for Salaried Employees (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

(a) General

The Plan is a deferred compensation savings plan established under Section 401(k) of the Internal Revenue Code covering U.S. salaried employees of Timex Group USA, Inc. and certain affiliated entities (collectively, the “Company”) who are age twenty-one or older. Full-time employees are eligible immediately upon hire, while part-time employees are eligible upon the attainment of one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company’s Employee Benefits Committee has oversight responsibility for the Plan.

(b) Contributions

Under the provisions of the Plan, eligible participants may contribute by deferring any percentage of their eligible compensation for each plan year provided it is within the limits set forth in the Internal Revenue Code and Treasury Regulations thereunder. The Company will make a matching contribution in an amount equal to 50% of the first 6% of the participant’s contribution, provided the participant has reached one year of service. Participant contributions are subject to an Internal Revenue Code deferral limitation, which was \$23,000 in 2024 and \$22,500 in 2023. In addition, participants who are age 50 and over may make an additional pretax “catch-up” contribution subject to IRC limitations. The Company has continued to match only 50% of the first 6% of a participant’s elective deferral.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualifying plans (rollover contributions).

(c) Participant Accounts

Each participant’s account reflects the participant’s interest in the various investment programs of the Plan. Participants are allowed to direct their respective amounts into any or all of the funds which the Plan has available, subject to certain restrictions described in the Plan. The amount of benefits available to each participant depends on the value of the participant’s own account. Participant accounts are maintained by T. Rowe Price Trust Company (the “Trustee”).

(d) Vesting and Forfeitures

Participants are immediately vested in their contributions, plus earnings and losses thereon. The Company’s matching contributions, plus earnings and losses thereon, are 100% vested upon completion of three years of service. All nonvested forfeitures are used to reduce the contribution of the Company. For the years ended December 31, 2024 and 2023, the Company’s contribution was reduced by nonvested forfeitures of \$0 and \$0, respectively. The nonvested forfeiture amounts outstanding at December 31, 2024 and 2023, were \$113 and \$56, respectively.

(e) *Payment of Benefits*

At termination of employment, a participant may elect either to receive benefits currently or to have them deferred up to the later of attaining normal retirement age or two years after termination. Distributions are subject to age 73 regulations for participants born after July 1, 1949, as defined by the Setting Every Community Up for Retirement Enhancement (SECURE) Act. Distributions made to former participants who are not age 59-1/2 may be subject to an early withdrawal penalty. Actual payment of the benefits may either be applied towards the purchase of a single premium annuity or, if the participant elects, a lump-sum distribution. A participant may designate a person or persons to whom benefits under the Plan are to be paid if the participant dies before receiving all of such benefits.

(2) Summary of Significant Accounting Policies

(a) *Basis of Presentation*

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) *Use of Estimates*

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements and the additions and deductions during the periods reported in the financial statements. Actual results can differ from those estimates.

(c) *Trust Funds*

Under the terms of the Trust Agreement between the Trustee and the Plan, the Trustee manages funds on behalf of the Plan. The Trustee's primary responsibilities include payment of benefits and transferring funds in conjunction with the investment managers and the Plan Administrator.

(d) *Valuation of Investments and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year, and is recorded in the accompanying statements of changes in net assets available for benefits. The cost basis of investments used in the determination of realized and unrealized gains and losses on investments is determined through use of the average cost method.

(e) *Payment of Benefits*

Benefits are recorded when paid.

(f) *Administrative Expenses*

Certain costs of administering the Plan, such as personnel salaries, fringe benefits and Trustee and recordkeeper fees, are absorbed by the Company and, accordingly, are not included as administrative expenses of the Plan. Administrative expenses paid by the Plan primarily relate to investment advisory.

(3) Certified Investments

Certain information related to investments and disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (Trustee of the Plan).

(4) Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires entities to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price on the active market on which the individual funds are traded.

Common trust funds: Common trust funds are groups of investment similar to mutual funds in that they provide diversification by holding various equity and debt securities. The funds are valued at the net asset value ("NAV") of the units held, which is based on the daily published closing prices of the funds as reported by the common trust and is the basis for current transactions. There are no restrictions from the common trust funds, and there are no unfunded commitments as of December 31, 2024. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Group Annuity Contract with New York Life Insurance Company

The Plan has a traditional fully benefit-responsive investment contract with New York Life Insurance Company (New York Life) totaling \$11,977 and \$12,403 at December 31, 2024 and 2023, respectively. New York Life is obligated to guarantee principal and accumulated interest to the Plan through a group annuity contract. New York life maintains the contributions in a pooled separate account, which primarily invests in fixed income securities. The crediting rate is subject to change daily.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on New York Life's ability to meet its financial obligations. New York Life's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the New York Life or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with New York Life. Such events include (1) Plan termination, (2) layoffs, (3) early retirement programs, or (4) bankruptcy of the Company. The Plan Administrator does not believe that any events are probable of occurring that would limit the ability of the Plan to transact at contract value with either New York Life or the participants.

In addition, certain events may allow New York Life to terminate the contract with the Plan and settle at an amount different from contract value. For instance, if the Plan requests to terminate the contract without twelve months advance written notice, the Plan's contract balance may be subject to a market value adjustment in which New York Life will pay a single sum equal to the Plan's balance projected for a two-year period at the contract crediting rate in effect on the stated termination date and discounted back to the stated termination date. However, the Plan Administrator does not believe that it is probable that New York Life will terminate the contract with the Plan and settle at an amount different from contract value.

(6) Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. In the event of Plan termination, participants will become 100% vested in their employer contributions.

(7) Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, credit risk, and overall market risk, including global events, such as the coronavirus pandemic. Due to the level of risk associated with certain investments, it is possible that changes in the values of investment will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Federal Income Taxes

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment is exempt from income taxes. The Plan has obtained a favorable tax determination letter dated August 1, 2011 from the Internal Revenue Service. The Plan has been amended since receiving the determination letter, however, the Plan administrator and the Plan's tax counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan Sponsor is not aware of any source of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(9) Related Party Transactions and Party in Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any party providing fiduciary services for the Plan, any party rendering services to the Plan, the employer and certain others. Certain investments of the Plan are in funds managed by the Trustee and therefore these are considered party-in-interest investments. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Any direct or indirect expenses paid for by the Plan, as described in Note 1, are considered party-in-interest transactions.

(10) Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, which represents the date the financial statements were available to be issued and noted no other subsequent events that would have impacted the Plan's financial statements.
