Independent Auditors' Report

To the Participants and Trustees of
Patented Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Patented Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Patented Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan sponsored by Patented Acquisition Corp dba Think Patented (the Company and Plan Sponsor) and covers substantially all employees of whom are not subject to a collective bargaining agreement, unless that agreement specifically allows for participation. Matrix Trust Company serves as the Trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is qualified under the Internal Revenue Code.

Eligibility

Employees are eligible to participate in the before-tax component of the Plan upon 60 days of employment assuming one hour of service to the Company was completed in that time frame. Employees are eligible to receive an allocation of Company contributions after one year of service at the Company (defined as 1,000 hours of service).

Contributions

The Plan is subject to the Annual Addition Limitations set forth by the Internal Revenue Service (IRS) which allows participants to defer up to 100% of their salary until the maximum contribution has been reached. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or benefit plans.

The Plan has an automatic deferral election. 3% will be withheld if an election is not made by the date the participant becomes eligible.

The Company's discretionary matching contributions shall be determined by the Company with respect to each Plan Year. The Company elected to contribute matching contributions of \$59,011 for the year ended December 31, 2024.

The Company may also make a discretionary profit sharing contribution that is allocated to all eligible participants at the ratio that the participant's compensation bears to the total eligible compensation. There were no profit sharing contributions authorized for 2024.

Participant Accounts

Each participant's account is credited with the participant's own contributions, employer contributions, rollover contributions, and a share of the Plan's investment income and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed; however, the Trustee has complete control over the investment offerings made available to plan participants.

Investment Options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants.

Vesting

Participant vesting is based on service years. Participants are 100% vested in the voluntary salary deferral, rollover contributions, and non-elective contributions. The discretionary profit sharing contributions and discretionary employer-matching contributions vest according to the following schedule:

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts can be reallocated to all plan participants and treated as part of the Company contributions or used to pay plan fees. Unallocated forfeitures at December 31, 2024 and 2023, were \$8,990 and \$7,092, respectively. No forfeitures were used to offset the Company contributions in 2024.

Payment of Benefits

Participants become eligible for benefit distributions upon retirement, disability, death, termination of employment, or termination of the Plan. Additionally, the Plan provides for in-service distributions after a participant has reached age 59 ½ up to their fully vested account balance. Participants may also receive distributions from the employee deferral or rollover balance for qualified financial hardships. All benefit distributions are made in lump sum cash payments or rollovers to other plans. Benefit payments are recorded when distributed. All persons who elected to withdrawal from the Plan had withdrawn their balance prior to December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, results may differ from those estimates.

Notes Receivable from Participants

Participant loans are not permitted under the Plan.

Administrative Fees

Administrative fees are paid for by both the Plan and the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the Trustee of the Plan.

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and mutual funds - Valued at the closing price of the shares held by the Plan at year-end reported on the active market on which the individual securities are traded.

Common/collective trust funds - Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan had no unfunded commitments and no redemption restrictions related to common/collective trust funds at December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan, and certain administrative costs incurred by the Plan are paid by the Plan Sponsor.

The Plan's administrative expenses result from services rendered by parties-in-interest.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE G - INCOME TAX STATUS

The Company has adopted the CCH Incorporated Non-Standard Pre-Approved Profit Sharing Plan with CODA document which has obtained a favorable tax determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent amendments have been made to the Plan, and these changes have not been submitted for a determination letter. However, the Plan Sponsor believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date; therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I - NONEXEMPT TRANSACTIONS

During 2024, the Company inadvertently failed to deposit \$34,746 of participant deferral contributions to the Plan within the required time period described in 29 CFR 2510.3-102, as stated by the United States Department of Labor regulations.

NOTE J - CORRECTIVE DISTRIBUTIONS

The Plan failed to pass the Average Deferral Percentage Test for the Plan years ended December 31, 2024 and 2023. The accompanying statements of net assets available for benefits include a liability of \$57,377 and \$56,358 as of December 31, 2024 and 2023, respectively, related to the excess contributions payable to the participants. The Plan distributed these corrective distribution amounts to the participants within three months after the Plan's respective year end.

NOTE K - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
