

NOTE 1 - DESCRIPTION OF PLAN

The CBA Retirement Savings Plan (the "Plan") is a defined contribution pension plan for two commonly owned corporations: Universal Instruments Corporation and Hover-Davis, Inc.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted on November 13, 2006 and covers employees located in the United States that are 21 years or older, and whose customary employment is more than 20 hours per week. Employees located in the United States that are 21 years or older, and whose customary employment is less than 20 hours, are eligible after 1 year of employment. The Plan excludes employees who are non-resident aliens with no U.S. source income, are covered by a collective bargaining agreement or are leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may defer up to 50% of their eligible compensation but are limited to the annual threshold set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions, subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Hover-Davis Inc. matches up to 50% of each participant's deferral, up to a maximum of 6% of compensation. Universal Instruments Corporation matches 25% of each participant's deferral, up to a maximum of 6% of compensation. In addition, annual profit sharing contributions are made to the Plan at the discretion of the employer.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution, Plan earnings and losses, and forfeitures of terminated participants' non-vested accounts. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan is a participant-directed Plan.

Vesting - Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants are fully vested in the value of Company's matching contributions upon earliest of: completion of one vesting year of service, attainment of normal retirement age while an employee, or death or permanent disability while an employee. Participants are fully vested in the value of Company profit-sharing contributions if, while an employee, participants reach normal retirement age, die or incur a permanent disability. If they terminate employment before one of the conditions is met, their vested interest in the Plan will be based on their vesting years of service; 20% each year for the first four years, with 100% vesting at five years of service.

Payment of Benefits - On termination of service, a participant may elect to receive a lump-sum amount, annual installments, an immediate annuity contract, or to receive a portion of his or her vested interest in a single sum with the remaining portion in the form of an immediate annuity contract. If the value of the participant's vested interest is \$5,000 or less, the value is automatically distributed to the participant in a lump-sum amount.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by up to 50% of vested Plan account balance and bear interest at the prime rate, as defined, at the inception of the loan. Principal and interest is paid ratably through regular payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Forfeited Accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$32,318 and \$1,790, respectively. These accounts will be used to pay for plan expenses, reduce the profit-sharing contributions or employer matching contributions otherwise to be made for subsequent plan years. During 2024, forfeitures totaling \$60,807 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payments of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Unpaid participant loans are reclassified as distributions upon termination based on the terms of the Plan document.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Plan are recorded as a liability as of December 31, 2024 in the accompanying financial statements. The Plan remitted the excess contributions to the respective participants in the following year.

Administrative Expenses - The Company absorbs a portion of the operating expenses relating to the Plan. Fees related to participant distributions and the administration of the notes receivable from participants are charged directly to the participant's account and are included in administration expenses.

Subsequent Events - The Plan's trustees have evaluated events and transactions that occurred during the period from January 1, 2024, through October 14, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 unobservable inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 3 inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds – Valued at NAV of units of a bank common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts (“PSA”) – Valued daily based on market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. The PSA is classified as Level 2. The redemption frequency of each of these PSA is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan’s investment in PSAs.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive investment with Principal Trust Company (Principal). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully-benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values of the investment contracts at December 31, 2024 and 2023, were \$19,710,440 and \$11,605, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0.05%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in shares of a pooled separate account and guaranteed investment contract managed by Principal. Principal is the trustee of the plan, and therefore, these transactions qualify as parties-in-interest transactions. Fees paid by the Plan to Principal for investment management and other services amounted to \$117,808 for the year ended December 31, 2024. The investment management fees are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

NOTE 8 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 28, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with these investments, and the level of uncertainty related to the changes in the value of these investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
