Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of the Plan

The following description of the Wheels LLC Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

On October 27, 2021, Athene Holding Co. (Athene) acquired substantially all the stock of Frank Consolidated Enterprises, Inc. the Parent of Wheels, Inc, the Plan Sponsor and Administrator. Effective on the date of acquisition, Frank Consolidated Enterprises, Inc. and Wheels, Inc., converted to Limited Liability Companies. On November 21, 2021, Wheels LLC merged with Donlen LLC, an Athene affiliated company.

On December 1, 2022, Athene, through its subsidiaries Freedom Parent LP and Donlen LLC, acquired substantially all of the stock of LeasePlan USA and affiliated entities (LeasePlan USA), which was combined with Wheels LLC and Donlen LLC (collectively referred to as Wheels).

The Plan is a defined contribution plan established to provide retirement benefits for the employees of Wheels LLC, Frank Consolidated Enterprises LLC, Donlen LLC, and LeasePlan USA (collectively, the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On January 1, 2023, Donlen LLC Retirement Plan (the Donlen Plan), a 401(k) plan of an affiliated company, was merged into, and net assets of approximately \$36 million were transferred to the Plan. The Plan converted to a safe harbor plan providing for, among other things, 100% vesting of employer contributions when made. Employer matching contributions changed to 100% match of employee deferrals on the first 3% of compensation and then 50% match of employee deferrals on the next 2% of compensation. All other provisions of the Plan remain the same.

On January 2, 2024, LeasePlan USA, Inc. 401(k) Plan (the LPUSA Plan), a 401(k) plan of an affiliated company, was merged into, and net assets of approximately \$83 million were transferred to the Plan.

In March 2025, Donlen LLC's name was changed to Wheels Topco LLC.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Custodial Arrangement

The Plan has designated Fidelity Workplace Services LLC to perform recordkeeping services and Fidelity Trust Management Company (the Trustee) to manage the Plan's assets.

Participation

All employees of the Companies are eligible to participate in the Plan after 30 days of service. New employees are automatically enrolled in the Plan after 30 days of service, unless they affirmatively opt out of the Plan.

Employer Contributions

Employer contributions comprise a matching contribution and a discretionary contribution. Matching contributions are allocated to participants employed on the last day of each bi-weekly payroll period. Starting in 2023, employer contributes 100% of the first 3% of the participant's eligible compensation, and 50% of the next 2%. Prior to 2023, employer contributions were in the amount equal to 25% of the participant's contributions for that week, up to 5% of the participant's eligible compensation.

Employee Contributions

Employees who are automatically enrolled will have 5% of their eligible compensation contributed to the Plan. Any time after initial enrollment, employees may adjust their contribution to between 0% and 90% of their eligible compensation, as defined by the Plan. Roth elective deferrals are permitted, whereby participants may elect to make after-tax contributions. Employee contributions are deposited with the Trustee weekly. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Investment Options

The Plan offers various investment options selected by the plan administrator. Plan participants direct the investment of their accounts into these options. Employer contributions are deposited based on employees' investment elections.

Forfeitures

Forfeitures not otherwise reinstated are used to pay plan expenses with any excess used to reduce employer contributions.

Forfeitures were \$7,295 and \$68,370 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$10,139 and \$53,180 were held in the trust at December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of his or her employer's contributions and plan earnings. Each account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their own contributions and earnings thereon. As of January 1, 2023, employees are fully vested in employer matching contributions immediately. As of January 1, 2024, all prior employer contributions are fully vested.

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and supported by promissory notes payable to the Plan and bear interest at a fixed rate equal to the prime rate plus 1% at the inception of the loan.

Payments of Benefits

Upon normal retirement, early retirement, death, disability, termination of employment, or termination of the Plan, a participant or his or her beneficiary may elect to receive a lump-sum distribution or annual installments in either term or annuity forms. Alternatively, a participant or his or her beneficiary may elect to defer receipt of benefits until normal retirement age.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Payment of Benefits

Benefits are recorded when paid.

Contributions

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan's management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Notes 4 and 5 for further discussion of contract value and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

3. Investments

All investment information (except for fully benefit-responsive investment contracts) disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee. Fully benefit-responsive investment contract values are not certified by the Trustee. The value of such contracts were \$3,462,586 and \$0 for the years ended December 31, 2024 and 2023, respectively.

The Plan's investments (including gains and losses on investments bought and sold, as well as held, during the year, and including fully benefit-responsive investment contracts) appreciated \$27,171,226 and appreciated \$20,812,970, respectively, in fair value for the years ended December 31, 2024 and 2023.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds an investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less participant withdrawals, and administrative expenses. The Plan owns only the contract itself, and not the underlying assets.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, there are no events that allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

5. Fair Value Measurements (continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value:

Mutual funds: Valued at quoted market prices, which represent the net asset value of the shares held by the Plan at year-end.

Money market funds: Valued at quoted market prices representing daily floating net asset values.

6. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

The Companies have not expressed any intent to terminate the Plan; however, the Plan Sponsor has the right to do so at any time, subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in all of their plan accounts and will be entitled to distributions of their entire accounts according to the Plan and ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

9. Related-Party Transactions

The Plan holds shares of mutual funds managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

10. Subsequent Events

Management evaluated subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued. No events or transactions have occurred or are pending that would have a material effect on the financial statements, other than those disclosed.
