INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Equans Contracting Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal controls of the Plan. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the Plan to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental information in the accompanying Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, and Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Equans Contracting Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective September 1, 2022, the Plan was restated as the plan sponsor changed its name to Equans Contracting Services, LLC (the Company) and the Plan name changed to Equans Contracting Services 401(k) Plan. The Plan was originally established by ENGIE Energy Services Holdings Northeast LLC, now known as Equans MEP Services Northeast LLC on November 15, 2017, to provide savings benefits for employees. The Plan has six participating employers which include B-G Mechanical, Inc., Fred Williams Inc., H.T. Lyons, Inc., Engie Services, Inc., and MEP Services Northeast, LLC, and Equans US, Inc.

With the exception of union employees, nonresident aliens, inpatriates (other than an inpatriate employee who is subject to local employment terms and conditions), part-time, temporary or seasonal and leased employees, the Plan covers substantially all employees of the Participating Employers. There are no age or service requirements.

The Company acts as the Plan administrator and is responsible for the Plan. Empower Trust Company, LLC (the "Trustee"), marketed under the Empower Retirement brand (Empower), is the trustee of the assets of the Plan, and Empower Retirement serves as the record keeper of the Plan, maintaining individual accounts for each participant.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan. Effective August 1, 2020, all new eligible employees are automatically enrolled in the Plan to make pre-tax contributions, upon attainment of eligibility requirements, unless they elect otherwise. All employees including an employee who has been automatically enrolled is deemed to have elected to defer pre-tax contributions initially of 3%, unless they manually opt to select their own contribution amount. An employee's deferred contribution will increase by 1% each year until it reaches 10% of the employee's compensation unless the employee opts out of the auto escalation feature.

The Plan allows after-tax (Roth) contributions, subject to certain limitations under the IRC. Participants who have attained the age of 50 by the end of the calendar year are permitted to make catch-up contributions to the Plan. Participants may also contribute, or roll-over, amounts representing distributions from other qualified plans.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participants elective deferrals, including catch-up deferrals, each Plan year. In addition, the Company may make a discretionary nonelective contribution to the Plan to participants who have completed 1,000 hours of service in the Plan year and are employed on the last day of the Plan year. No nonelective contribution was made in 2024.

A participant who receives a qualifying distribution from a former employer's retirement or savings plan, or certain individual retirement arrangements (IRA), may contribute the distribution to the Plan, provided that such contribution qualifies as a rollover contribution in accordance with IRC Section 402 or is made by a direct trust-to-trust transfer. Alternatively, participant may elect to deposit any amount eligible to be rolled over within sixty days of receipt of the distribution.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of Company discretionary nonelective contributions and Plan earnings, and charged with withdrawals, allocation of Plan losses, and administrative expenses. Allocations are based on participant earnings, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each employee is responsible for directing his/her account.

Investments

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options. Company contributions are contributed according to the same allocation.

Vesting

Contributions attributed to elective deferrals, catch-up contributions, matching and rollover contributions are always 100% vested. Non-elective discretionary contributions follow a vesting schedule based on years of service. The vesting schedule is summarized as below:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer between the investment fund and the loan fund. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as defined in the Plan document, plus 1% of interest on the date of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment with the Company for reasons other than death, a participant is entitled to receive a distribution of the vested portion of the accounts in the Plan. In the event of a participant's death, 100% of the participant's account balance will be used to provide the beneficiary

with a death benefit. If employment is terminated and the participant has attained the later of Normal Retirement Age, which is age 65, or 5th anniversary of joining the Plan and their vested account balance does not exceed \$5,000, the payment will be made in cash in a single lump sum. If the participant's account balance is greater than \$5,000, lump sum and instalment payment distributions are allowed.

Participants may be entitled to receive a distribution prior to retirement. However, this distribution is not in addition to the participant's other benefits and will therefore reduce the value of available benefits at retirement. Generally, these distributions are only available if the participant has attained the age of 59½, or has incurred a financial hardship (enumerated in the Summary Plan Description).

Expenses

The Plan will pay some or all Plan expenses except for a limited category of expenses, which are paid by the Company.

Forfeited Accounts

If a participant terminates employment before being fully vested, the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay plan expenses or reduce matching and non-elective contributions. As of December 31, 2024 and 2023, the Plan's forfeited nonvested balance totaled \$45,193 and \$35,284, respectively. The Company used \$0 of the forfeitures to pay plan expenses and \$19,371 to offset Company match during the year ended December 31, 2024.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Risk and Uncertainties

The Plan utilizes various investment instruments that are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses

Administrative expenses of the Plan may be paid by the Company or the Plan, as provided in the Plan document.

Benefit Payments

Benefits are recorded upon distribution.

NOTE 3: FAIR VALUE MEASUREMENT

ASC 820, Fair Value Measurement, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

- Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets;
- Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and
- Level 3, which refers to securities valued based on significant unobservable inputs.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund (Putnam Stable Value Fund): The Putnam Stable Value Fund (the "Fund") is a common collective trust fund sponsored by Putnam Fiduciary Trust Company. The Fund is stated at fair value as determined by the issuer of the common collective trust based on the net asset value as a practical expedient of the underlying investments.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Company evaluates the significance of the transfer between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers between levels.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: INFORMATION CERTIFIED BY THE TRUSTEE

Certain information in the accompanying financial statements and Schedule of Assets (Held at End of Year) related to investments and notes receivable from participants, held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was certified by the Plans Trustee, as permitted by regulation 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5: EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Transactions with the Trustee and the funds they manage qualify as party-in-interest transactions. Investment management fees and operating fees paid by the Plan were included as a reduction of the return earned on each fund. Additionally, participant loans qualified as exempt party-in-interest transactions.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7: TAX STATUS

The Plan uses a prototype plan document sponsored by Great-West Trust Company. Great-West Trust Company received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by the taxing jurisdictions.

NOTE 8: DELINQUENT PARTICIPANT CONTRIBUTIONS

During the years ended December 31, 2023 and 2024, certain participant contributions were not remitted to the Plan within the timeframe prescribed by the Department of Labor's regulations. Plan management has calculated and deposited the applicable lost earnings associated with these late remittances. As of the date the financial statements were available to be issued, Plan management is in the process of filing the required Form 5330 with the Internal Revenue Service to complete the correction process.

NOTE 9: SUBSEQUENT EVENTS

For the year ended December 31, 2024, subsequent events were evaluated through the date the financial statements were issued.
