The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of the Elgin Industries, Inc. Employees Profit Sharing Plan (Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed 401(k) plan covering eligible employees of Elgin Industries, Inc. (Company). Employees are eligible to participate upon completion of one year of employment with 1,000 hours of service and attaining age 21. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

The Plan is funded by voluntary contributions of participants and matching contributions of the Company. Participants may contribute to the Plan through regular payroll deductions, an amount subject to limitations imposed by the Internal Revenue Code. Age 50 and over participants can contribute an additional \$7,500 in 2024. New participants or re-hired participants are automatically enrolled into the Plan at a contribution rate of 1% of pre-tax compensation, unless the participants opt out of the automatic enrollment. Effective January 1, 2019, automatically enrolled participants’ contributions will be automatically increased annually by 1%, up to a maximum of 3%. Participants may also roll over amounts representing distributions from other qualified employee benefit plans. The Company has an elective Roth contribution option and a discretionary employer match. No discretionary employer contribution was made for the year ended December 31, 2024. The Company made matching contributions of \$200,678 to the Plan for the year ended December 31, 2024. Matching contributions are based on the following:

<u>Participant Contribution</u>	<u>Company's Contribution</u>
Up to 2% of annual gross salary	25% of participant contribution
Greater than 2% and up to 4% of annual gross salary	25% of first 2% 50% of second 2%
Greater than 4% and up to 6% of annual gross salary	25% of first 2% 50% of second 2% 100% of third 2%

Investment Options

Participants must direct their salary deferral contributions and their Company contributions into a variety of registered investment companies and common or collective trust funds. Participants may also elect to invest amounts into certain GoalManager portfolio investment options which invest into a mix of the investment funds available to participants of the Plan. There are five portfolios models including conservative, conservative to moderate, moderate, moderate to aggressive and aggressive. Each portfolio model is intended for a different level of investment risk and potential return, and each portfolio model is rebalanced on a regular basis to maintain an allocation (percentage of stocks, bonds, and cash equivalents investments) within each portfolio and promote a diversified investment. Automatic enrollment contributions are invested in the GoalManager Moderate Portfolio Model, as defined in the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's discretionary matching contributions, administrative expenses, and plan earnings (losses). The Company's discretionary matching contributions are allocated to participants who are employed on June 30 and December 31 of each year and are based on each participant's contribution percentage of annual gross salary as described above. Plan earnings (losses) are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in participant and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's contributions becomes vested based on years of service. A participant is 100% vested after three years of credited service. In the event of death or disability, participants become fully vested.

Payment of Benefits

On termination of service, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time or a direct rollover distribution. A participant is also entitled to withdraw any part of his or her vested balance resulting from rollover contributions at any time. Participants may also withdraw pre-tax elective deferral or rollover contributions in the event of hardship due to an immediate and heavy financial need, as defined by the Internal Revenue Service. Effective January 1, 2022, participants may withdraw from any part of his or her vested account balance in the event of hardship except earnings on amounts attributable to elective deferrals. Also, effective January 1, 2022, participants are allowed to make in-service withdrawals from their vested account balance once they have reached the age of 59½.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company and the Plan. Additionally, certain employees of the Company provide administrative and trustees services to the Plan and are not reimbursed by the Plan for such services.

Forfeitures

The nonvested account of a participant shall be forfeited as of the date the participant has ceased to be an employee. Forfeitures are first applied to plan expenses which would otherwise be paid by the employer and any remaining amounts will reduce the earliest employer contributions made after the forfeitures are determined.

During 2024, forfeitures used were \$2,852. There were \$1,811 and \$2,852 of forfeited nonvested account balances available at December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices.

The common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions as of December 31, 2024. As of December 31, 2023, there were excess contributions payable of \$13,932 which were distributed to participants before March 15, 2024.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Note 3. Certification by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Noninterest-bearing cash and investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype profit sharing plan and trust sponsored by Merrill Lynch Pierce Fenner & Smith Inc. (Merrill Lynch). This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

Note 7. Party-in-Interest Transactions

Certain plan investments are managed by Merrill Lynch. Merrill Lynch provides record-keeping services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Merrill Lynch receives investment-related revenue from investment service providers for services Merrill Lynch provides to the funds. This revenue is used to offset certain amounts owed to Merrill Lynch and other third-party advisors for their administrative services to the Plan.

Investment-related expenses are included in net depreciation in fair value of investments. Administrative expenses paid by the Plan during 2024 totaled \$58,307.

Note 8. Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
