To the Trustees and Participants of  
Zschimmer and Schwarz, Inc. 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Zschimmer and Schwarz, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Nationwide Trust Company and American United Life Insurance Company (the "Custodians"), as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Zschimmer and Schwarz, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Zschimmer and Schwarz, Inc. (the “Sponsor”), and its affiliated company, Zschimmer and Schwarz Interpolymer, Inc., (collectively the “Employers”), who have attained age 21 and have completed 3 months of service. The Plan became effective January 1, 2015, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (“IRC”).

Contributions

Employees eligible to participate in the Plan (the “participants”) may contribute on a pre-tax or after-tax basis any amount of eligible compensation, as defined, to the Plan through a salary deferral arrangement, up to the limit prescribed by the IRC, which is adjusted annually by the Internal Revenue Service (“IRS”). Participants may also make rollover contributions, which represent distributions from other qualified retirement plans.

For eligible participants, the Employers make nonelective safe harbor contributions equal to 3% of the participants’ compensation.

Investment options

The Plan’s investment assets were held by Nationwide Trust Company as of December 31, 2023, and for the period from January 1, 2023, through March 15, 2024, by American United Life Insurance Company for the period beginning March 15, 2024, through December 31, 2024 (collectively the “Custodians”). Under an arrangement with the Custodians and upon enrollment in the Plan, a participant may direct employee contributions in any whole percentage increments in any of the available funds. Participants may change their allocation to the various investment options at any time via telephone or the internet.

Participants’ accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Employers’ contributions on behalf of the participant and (c) the earnings and losses of the participant’s investments and is charged with administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, rollovers, Employers’ safe harbor contributions, and earnings thereon.

Payment of benefits

Upon termination of service with the Employers, attainment of normal retirement age, or for reasons of death or disability, a participant may request a distribution in the form of a lump-sum or equal installment equal to the value of his or her vested account. Participants still employed with the Employers may withdraw all or a portion of their account balance upon attainment of age 59 ½ or for reason of financial hardship, as for reasons permitted under the IRC. A participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A terminated participant whose vested account balance is between \$1,000 and \$5,000 and who does not elect otherwise, will have their vested account balance distributed from the Plan directly into an individual retirement account in their name.

#### Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. A participant may have no more than one loan outstanding at a time. Loan terms range from one to five years, unless the loan is for the purchase of the participant's primary residence, in which case the term may be extended. The loans are secured by the balance in the participant's account and bear interest at a fixed rate as determined by the plan administrator. At both December 31, 2024 and 2023, the interest rates on outstanding loans ranged from 5.25% to 10.50%. Principal and interest are paid ratably through periodic payroll deductions.

#### Administrative expenses

Administrative fees relating to certain participant-initiated transactions are paid by the Plan and charged to the accounts of participants initiating the transactions. Recordkeeping and direct investment advisory fees are also paid by the Plan and are allocated amongst participant accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

#### Investment valuation and income recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments, except for fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation of fair value of investments.

#### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Subsequent events

The Sponsor has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodians, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedule.

The following information included in the accompanying financial statements and supplemental schedule was prepared and certified to be complete and accurate by the Custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

### 4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan held a guaranteed investment contract with Nationwide Mutual Insurance Company for the period from December 31, 2023 until March 15, 2024, and holds a guaranteed investment contract with American United Life Insurance Company ("AUL") as of December 31, 2024 and for the period from March 15, 2024 through December 31, 2024. Contributions under the contracts are maintained in the issuers general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute for net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by the Custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) the complete or partial termination of the Plan, 2) the establishment of, or material change in, any plan investment fund, or 3) an amendment to the Plan or a change in the administration or operation of the Plan. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contracts may be terminated by the issuer upon the Plan's establishment, activation, or material change to any plan investment fund that the issuers determine will prevent their ability to continue to operate the contracts under the current terms. Termination of the contracts may result in the settlement of the outstanding balance at an amount that differs from contract value.

The Nationwide Mutual Insurance Company contract had a guaranteed a minimum interest rate of 1%. Interest rates were adjusted quarterly. During the period January 1, 2024, until March 15, 2024, the interest rates ranged between 1.82% and 1.92%.

The American United Life Insurance contract does not have a minimum guaranteed interest rate. Interest rates are adjusted annually. During the period held, the interest rate increased from 1.25% to 1.50%.

## 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAC and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Pooled separate account: Valued at the NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024, the pooled separate account is measured using NAV as a practical expedient and not required to be included in the fair market value hierarchy.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 7. RELATED PARTY TRANSACTIONS

The Sponsor incurs certain costs on behalf of the Plan and provides recordkeeping services to the Plan at no cost.

Certain investments held by the Plan are managed by the Custodians. Accordingly, these transactions qualify as party-in-interest transactions as defined by ERISA.

## 8. INCOME TAX STATUS

The Plan uses a prototype document sponsored by One America Financial Partners Inc., who was informed by the IRS by letter dated August 18, 2020, that the Plan, as amended, is designed in accordance with the applicable sections of the IRC. The Plan has not obtained a determination from the IRS on its adoption of the prototype plan. In accordance with Revenue Procedure 2002-6, the Sponsor has chosen to rely on the opinion letter of the prototype plan. Subsequent to this opinion letter, the Plan has been amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress, and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

## 9. PLAN AMENDMENTS

Effective March 15, 2024, the Sponsor changed the Plan's custodian from Nationwide Trust Company, FSB to American United Life Insurance Company. With the change, the Sponsor restated the Plan document and adopted OneAmerica Financial Partners, Inc.'s prototype plan. The significant changes to Plan provisions include:

- Part-time, temporary, and seasonal employees are excluded from eligibility.
- The entry date has been changed from immediate to monthly.
- Post-severance disability continuation payments are excluded from Plan compensation.
- A separate deferral election is now allowed for irregular pay.
- The automatic distribution of vested account balances has increased from \$1,000 to \$5,000.
- In-plan Roth rollover contributions and in-plan Roth rollover transfers are now permitted.

## 10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.
