## INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Methodist Le Bonheur Healthcare 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

### 1. DESCRIPTION OF THE PLAN AND OTHER MATTERS

The following description of Methodist Le Bonheur Healthcare 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Solus Management Services, Inc., a wholly owned subsidiary of Methodist Le Bonheur Healthcare, which is included under the umbrella of Ambulatory Operations, Inc., a wholly owned subsidiary of Methodist Le Bonheur Healthcare. The Plan Sponsor is Solus Management Services, Inc. Any employee of Solus Management Services, Inc. is eligible to participate in the Plan. There is no service requirement to participate in employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan custodians are Fidelity Management Trust Company (Fidelity) and Lincoln National Life Insurance Company (Lincoln).

#### *Contributions*

Each year, participants may contribute a percentage of their pretax annual compensation, as defined by the Plan, subject to the limitations of the Internal Revenue Code (IRC). Additionally, participants age 50 or older or who will attain age 50 during the Plan year may make a "catch-up" contribution as defined by the IRC. Catch-up contributions represent employee compensation deferrals in excess of otherwise stated Internal Revenue Service (IRS) annual deferral limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The plan sponsor either contributes 100% or 50% of the first 6% of the base compensation that a participant contributes to the Plan depending on the classification of each participant and their participation status in the Methodist Healthcare Pension Plan (another plan administered by Methodist Le Bonheur Healthcare).

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution, an allocation of employer contributions, and allocations of Plan earnings and administrative expenses. Participants direct their accounts into one or more investment options. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may borrow from their vested interests in the Plan up to a maximum of \$50,000 or 50% of their vested interest, subject to certain restrictions. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. All loans must be repaid within 5 years except for those used to acquire or construct a principal residence, which must be repaid within 10 years. Principal and interest are paid ratably through monthly payroll deductions.

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in employer contributions plus actual earnings thereon according to the following schedule:

### *Payment of Benefits*

The Plan provides benefits based solely upon the amount contributed to participants' accounts and any allocated income, expense, and gains from investments. Vested benefits are generally payable on termination, retirement, or disability. A participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments.

### *Forfeited Accounts*

At December 31, 2023, forfeited nonvested accounts totaled \$33. There were no forfeited nonvested accounts at December 31, 2024. Forfeitures are used to pay administrative expenses or to reduce future employer matching contributions. In 2024, forfeited amounts of \$8,929 and \$1,225 were used to offset employer matching contributions and reduce plan expenses, respectively.

### *Investments*

Contributions are invested by the custodians in one or more of the investment funds offered in such proportions as each participant directs.

### *Rollovers*

Rollovers represent transfers into the Plan of distributions from other qualified benefit plans.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Management considers the fair value of investments to be a significant estimate. See Note 3 for discussion of fair value measurements.

#### *Investment Valuation and Income Recognition*

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. See Note 3 for discussion of fair value measurements. Net appreciation in fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Transactions are accounted for on a trade date basis. Dividends are recorded on the ex-dividend date, and interest is recorded when earned.

As described in the Financial Accounting Standards Board Accounting Standards Codification Topic 946, *Financial Services – Investment Companies* (Topic 946), investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate certain permitted transactions. Topic 946 is not applicable to the Plan since the investment contracts held by the Plan are not fully benefit-responsive. Therefore, investment contracts with insurance companies are presented in the statements of net assets available for benefits at their fair value.

#### *Notes Receivable from Participants*

Notes receivable from participants are recorded at amortized cost.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the plan sponsor are recorded in the year in which the employee contributions are withheld from compensation.

### *Expenses*

Administrative expenses are paid primarily by the Plan. Certain surrender charges and annual contract fees are deducted from individual accounts.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring accrual or disclosure.

## 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV of units of shares held by the Plan. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the Plan in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Contracts with insurance companies:* Valued at fair value by discounting the related cash flows based on the current yields of similar instruments with comparable durations.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. INCOME TAX STATUS

The Plan has not obtained a separate determination letter from the IRS stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has opined and informed the third-party administrator by a letter dated June 30, 2020, that the prototype plan was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity and Lincoln as of December 31, 2024 and 2023. Fidelity and Lincoln are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments of \$12,262 to the custodians, which were not covered by revenue sharing. The plan sponsor pays directly any other fees related to the Plan's operations. Notes receivable from participants are also considered party-in-interest transactions.

### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
