Opinion

We have audited the accompanying financial statements of Teamsters Local 348 Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF FUNDING POLICY

The Teamsters Local 348 Health and Welfare Fund (the Plan) is a fully insured multi employer health and welfare plan established to provide health and welfare benefits. The following description of the Plan provides only general information. Participants should refer to the Plan agreement and summary plan descriptions for further information.

GENERAL

The Plan was created by a trust agreement between Teamsters Local Union No. 348 (the Union) and participating employers. These trustees have the sole authority to administer the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

BENEFITS

The Plan provides health benefits (medical, hospital surgical, major medical, vision and dental), life insurance, disability benefits and death benefits to eligible participants and their beneficiaries and dependents. Eligibility is determined weekly by participating employers submitting contributions on behalf of employees. The Plan offers no hour banking for eligibility. Retired employees are eligible for similar benefits depending on the employer from whom they have retired.

Health claims of active and retired participants and their dependents and beneficiaries are provided under group insurance contracts. Death, accidental death and dismemberment, and short term disability benefits are covered by a group term policy.

CASH AND CASH EQUIVALENTS

The Plan's cash consists of cash on deposit with banks. Cash equivalents represent money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes.

CONTRIBUTIONS

Contributions to the Plan are made by participating employers pursuant to collective bargaining agreements with the Union. Individual contributions are primarily payments for continuation of health coverage.

OTHER

The Board of Trustees have the right under the Plan to modify benefits, funding arrangements, and contribution rates. The Plan may be terminated at any time based on the provisions in the Plan's Declaration of Trust and ERISA.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

POSTRETIREMENT BENEFITS

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees service rendered to year end, reduced by the actuarial present value of contributions expected to be received in the future from Plan participants. Postretirement benefits include future benefits expected to be paid for 1) currently retired or terminated employees and their beneficiaries and dependents and 2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligations is the portion of the expected postretirement benefit obligation that is attributed to that employee's service.

The actuarial preset value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claim-cost data to estimate future annual incurred claims cost per participation and to adjust such estimates for the time value of money.

INCOME TAXES

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the Internal Revenue Service and the Sponsor believes that the trust, as amended, continues to qualify and to operate as designed.

DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available.

Level 1 Fair Value Measurements

We currently do not have any level 1 financial assets or liabilities.

Level 2 Fair Value Measurements

The fair values of corporate bonds and U.S. government securities for which quoted market prices are not available are valued using pricing models maximizing the use of observable inputs for similar investments. This includes basing values on yields currently available on comparable certificates of deposit with similar credit ratings.

Level 3 Fair Value Measurements

We currently do not have any level 3 financial assets or liabilities.

NOTE F - BENEFIT OBLIGATIONS

Health costs incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the Plan to continue obtaining insurance coverage for benefits. Insurance premiums for future years in respect of the Plan's postretirement benefit obligation will be funded by Sponsor contributions to the Plan in those later years.

The postretirement benefit obligation at December 31, 2024 and 2023, principally health benefits, relates to the following categories of participants (including their beneficiaries and dependents):

The weighted health care cost trend rate assumption (see Note E) has a significant effect on the amounts reported. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by \$906,472 and \$952,793, respectively.

NOTE G - RELATED PARTY TRANSACTIONS

The Union is a participating employer in the Plan. The Plan has a lease agreement with the Union to rent office space and shared common areas in the Union building. The lease provides for monthly rental payments of \$1,200 and renews annually. Rental expense during the years ended December 31, 2024 and 2023 was \$14,400.

Certain Plan assets were invested in a brokerage account managed by Merrill Lynch. As described in Note A, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE I - CONCENTRATIONS

At December 31, 2024 and 2023, and at times during the year, the Plan has cash in banks in excess of Federally insured limits. At December 31, 2024 and 2023, the Plan had exposure of \$1,731,369 and \$954,381, respectively.

For the years ended December 31, 2024 and 2023, the Plan received 82% and 83% of its employer contributions from two and two employers, respectively. United Parcel Service accounted for 72% in 2024 and 74% in 2023, of the Plan's employer contributions.
