### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Lamoille Health Partners 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### (1) DESCRIPTION OF THE PLAN

The following description of the Lamoille Health Partners 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all employees of Lamoille Health Partners (the “Organization”), who have met the eligibility requirements as defined in the Plan document. The Plan was established on October 1, 2005. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees become eligible to make salary deferrals on the first day of employment. Employees who have reached age 21 become eligible to receive employer safe harbor nonelective and discretionary profit sharing contributions upon completion of one year and 1,000 hours of service.

Effective October 23, 2023, Lamoille Health Partners acquired Family Practice Associates, Inc. and their employees were added to the Plan. Eligibility and vesting from service with Family Practice Associates, Inc. are recognized by the Plan.

- (b) Investment Allocation – Participants direct all contributions to any investments offered by the Plan.
- (c) Employee Contributions – Participants may elect to contribute Roth and pre-tax deferrals up to 85% of eligible compensation as defined in the Plan, limited to a maximum amount as periodically set by the Internal Revenue Service (“IRS”). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.
- (d) Employer Contributions – The Organization’s contribution consists of a safe harbor nonelective and a discretionary profit sharing contribution. The safe harbor nonelective contribution is 4% of eligible employee compensation as defined by the Plan. Total safe harbor nonelective contributions totaled \$436,121 and \$393,398, for the years ended December 31, 2024 and 2023, respectively. Additional profit sharing contributions may be contributed at the option of the Organization. No such profit sharing contributions were made for the years ended December 31, 2024 and 2023.
- (e) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Organization’s safe harbor nonelective contributions and allocation of (a) the Organization’s discretionary contribution, and (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- (f) Vesting – Participants are immediately vested in their voluntary contributions, employer safe harbor nonelective contributions and discretionary profit sharing contributions, plus actual earnings thereon.

### DESCRIPTION OF THE PLAN (continued)

- (g) Benefit Payments – Upon retirement or termination, benefit distributions are paid in lump sum amounts. Normal retirement date is the first day of the month coinciding with or following the participant's 65<sup>th</sup> birthday. The Plan also provides for distribution upon attainment of age 59 ½, death, disability, and economic hardship.
- (h) Hardship Distributions – Hardship distributions are permitted from a participant's pre-tax and Roth elective deferral account.
- (i) Forfeited Accounts – Forfeitures are used to reduce administrative expenses and employer discretionary contributions during the Plan year. Forfeitures used to reduce plan expenses were \$0 at December 31, 2024 and 2023. There were \$5,772 and \$5,532 of forfeitures available to the Plan at December 31, 2024 and 2023, respectively.
- (j) Notes Receivable – The Plan allows loans to participants. The amount of any loan shall be at least \$1,000 and the total outstanding loan balances shall not exceed the lesser of (a) \$50,000; or (b) 50% of the individual's vested interest in their total account. The loan terms range from one to five years or for repayment within a reasonable time that the participant will use the loan for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear an interest rate commensurate with local prevailing rates as determined by the plan administrator.

### (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Administrative Expenses – In general, all Plan expenses, except certain recordkeeping and investment fees, are paid for by the Organization.

- (e) Benefit Payments – Benefit payments are recorded when paid.
- (f) Subsequent Events – The Organization has evaluated subsequent events through October 14, 2025, which is the date that the financial statements were available to be issued.

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC / Empower Annuity Insurance Company of America (custodian) has certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activities reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(4) INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. Contract value represents contributions plus credited interest, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### (5) TAX STATUS

The Plan is based on a prototype plan that received a favorable tax determination letter from the IRS dated October 1, 2021, indicating that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”), and was, therefore, exempt from federal income taxes. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### (6) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits.

### (7) WITHDRAWING PARTICIPANTS

There were no participant distributions requested in 2024, but not paid until 2025.

### (8) RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

### (9) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Organization has the right under the Plan to amend or terminate at any time any provisions of the Plan or the Plan in its entirety. Upon termination of the Plan, the custodian, once notified by the Organization of the termination date, will distribute to each participant their account balance on that date in accordance with the terms of the Plan.

### (10) FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

*Collective trust funds:* Valued at net asset value ("NAV") of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
