Basis for Opinion

Note 1: Description of Plan

The following description of the Villa Maria Health and Rehabilitation 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

General

The Plan is a defined contribution plan covering substantially all employees of Villa Maria Health and Rehabilitation Center, LLC, the adopting employer of the Plan, and its participating employers, including Avanti Home Health Service, LLC (previously known as Bay Area Health, LLC), Sky View Nursing Center, LLC, Villa Marina Health & Rehabilitation, and Beacon Ambulance Service, Inc. (collectively the "Companies"). Employees become eligible to participate in the Plan on the first day of each month following the attainment of age 21 and completion of one year of service during which they have worked 1,000 hours for full-time employees, and effective January 1, 2024, completion of 500 or more hours for three consecutive years or more than 1,000 hours during the plan year for long-term part-time employees (under SECURE 2.0). Prior to January 1, 2024, part-time employees were eligible to participate under the same criteria as full-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute pretax annual compensation up to the annual maximum contribution allowed by the Internal Revenue Service (IRS). The Plan also allows Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their accounts into various investment options offered by the Plan.

Contributions (Continued)

The Companies may make a discretionary matching contribution to each participant based on his or her elective deferral in a percentage determined by the Companies prior to the end of each plan year. To receive the discretionary matching contribution, participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year. For 2024, the Companies elected to contribute 50% of the first 6% of base compensation that a participant contributes, including catch-up contributions, to the Plan. Rollovers are not matched. Discretionary matching contributions were \$98,661, net of forfeitures applied, for the year ended December 31, 2024.

Additional nonelective amounts may also be contributed at the discretion of the Companies. No discretionary nonelective contributions were made for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' discretionary matching contributions, and allocations of (a) the Companies' discretionary nonelective contributions, and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary and rollover contributions plus actual earnings (losses) thereon. Vesting in the Companies' discretionary matching and discretionary nonelective contributions plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a maximum of two notes with a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at commercially reasonable rates of interest established by the plan administrator. Interest rates on existing loans range from 4.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive a lump-sum, installment payments, or partial withdrawals in amounts equal to the value of the participant's vested interest in his or her account if the balance is greater than \$5,000. If the participant's vested balance does not exceed \$5,000, they can only receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's vested account balance does not exceed \$1,000, a mandatory distribution will be made. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,592 and \$5,053, respectively. At the Companies discretion, these accounts may be used to pay plan administrative expenses or to reduce the Companies' contributions in accordance with the plan document. During the year ended December 31, 2024, forfeitures were used to reduce the Company's discretionary matching contributions and pay plan expenses by \$6,026 and \$5,219, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, revenue is recognized when received rather than when earned and expenses are recognized when paid rather than when the liability is incurred.

Use of Estimates

The preparation of the accompanying financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividend income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Valuation and Income Recognition (Continued)

Fully benefit-responsive investment contracts are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Companies and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionally to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 3: Fair Value Measurements (Continued)

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, fully benefit-responsive investment contract, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company Inc. (TFLIC) as of and for the year ended December 31, 2024, Transamerica Trust Company (TTC) as of December 31, 2024, and for the period from July 1, 2024 to December 31, 2024, and Reliance Trust Company (RTC) as of December 31, 2023, and for the period from January 1, 2024 to June 30, 2024, the Custodians of the Plan.

Note 5: Fully Benefit-Responsive Investment Contract

The Plan invests in the Transamerica Stable Value Core Fund with TFLIC, which is considered a fully benefit-responsive investment contract (FBRIC). TFLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TFLIC is contractually obligated to repay the principal and interest at a rate agreed upon with the issuer. The FBRIC is carried at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting. There is no stated minimum or maximum interest rate for the FBRIC. The FBRIC is backed by the general account of TFLIC. While TFLIC declares rates periodically and backs the principal and interest of the FBRIC, any guarantees are subject to the claims paying ability of the insurance company.

Certain events limit the Plan's ability to transact at contract value with TFLIC including plan termination and other events as specified in contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. TFLIC requires written notice of discontinuance of the contract and the effective date of discontinuance must be the first day of the a month not earlier than 30 days after receipt of notice of discontinuance.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Companies' discretionary contributions.

Note 7: Party-in-Interest Transactions

Certain plan investments were managed by TFLIC, TTC, and RTC, the Custodians; therefore, these transactions qualify as party-in-interest transactions.

The Plan paid investment advisory fees to Principal Securities, Inc. and administrative expenses to Transamerica Retirement Solutions, which are also considered party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Tax Status

The Companies adopted a non-standardized pre-approved plan document with an IRS notification letter which states the non-standardized plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
