## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Museum Associates 401(a) Retirement Plan  
Los Angeles, California

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Museum Associates 401(a) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Museum Associates 401(a) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established on August 1, 2000 by the Museum Associates (the "Employer") to provide retirement benefits for eligible employees, as defined in the Plan document. The Plan is administered by State Street Bank and Trust Company ("State Street"), the custodian, and Transamerica Retirement Solutions Corporation ("Transamerica"), the recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administrative Expenses**

The Employer pays most administrative expenses of the Plan. Certain asset charges and account fees are paid from participants' accounts.

**C. Eligibility**

Eligibility in the Plan is established when an employee has completed one (1) year of service and attained eighteen (18) years of age. To complete a year of service, a participant must have worked 1,000 hours or more of service during the year. The employee may become a participant in the Plan on the first day of the payroll period coinciding with or next following the completion of eligibility. The Employer also has a related 403(b) plan which is comprised of only employee contributions.

**D. Contributions**

Participants may elect to contribute, on a tax-deferred basis, from 1% to 25% of their annual compensation into the Employer's 403(b) plan, subject to Internal Revenue Code (Code) limitations. The Employer matches 100% of the participant's contributions up to 4% of the participant's annual compensation into the Plan, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions up to a maximum of \$7,500 into the Employer's 403(b) plan, subject to certain Code limitations.

**E. Participant Accounts**

Each participant's account is credited with the Employer's contributions and an allocation of Plan earnings. The Plan has various investment options from which the participants may select any combination for investment of their account balance.

**F. Vesting**

The vested portion of a participant's account attributable to the Employer's contributions is determined as follows:

In addition, full vesting occurs upon the death, retirement, or permanent disability of a participant.

**G. Forfeitures**

Forfeitures of participants' non-vested account balances shall be used to reduce future Employer contributions or pay Plan expenses. Forfeitures totaled \$38,209; \$1,995 in forfeitures were used to offset the Employer's contributions in 2024 and \$0 in forfeitures were used to pay Plan expenses in 2024. Forfeitures totaled \$3,927; \$19,749 in forfeitures were used to offset the Employer's contributions in 2023 and \$0 in forfeitures were used to pay Plan expenses in 2023. Forfeitures available for future use as of December 31, 2024 and 2023 totaled \$38,609 and \$2,262, respectively.

**H. Payment of Benefits**

A participant's benefits may be distributed at retirement, death, disability, or termination of service. The participant or beneficiary may elect to receive such benefits as an annuity, lump sum payment equal to the value of the vested interest in his or her account, or as a direct rollover. The participant may elect to defer the distribution for a specific period of time ending no later than the participant's normal retirement age. Hardship withdrawals are permitted.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

**D. Risks and Uncertainties**

The Plan holds a variety of investments, which are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - RELATED PARTY TRANSACTIONS**

State Street, Transamerica Life Insurance Company (“TLIC”) and Transamerica Financial Life Insurance Company (“TFLIC”) provide investment options offered under the Plan. Transactions in these funds, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

**NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street, TLIC, and TFLIC, the custodians of the Plan.

**NOTE 5 - GUARANTEED ACCOUNTS**

The Plan maintains a fully benefit-responsive group annuity contract with TLIC through guaranteed accounts. Contributions to the guaranteed accounts are maintained in TLIC’s general assets and credited for interest and charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The guaranteed accounts meet fully benefit-responsive investment contract criteria and are reported at contract value. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions within the terms of the Plan.

**NOTE 6 - INCOME TAX STATUS**

The Plan administrator has adopted a Transamerica prototype plan, which received an opinion letter dated March 31, 2014 from the Internal Revenue Service stating that the form of the Plan is acceptable under the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and net assets available for plan benefits would be distributed to the participants based on each participant’s interest in the Plan.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosures in the financial statements.
