## Report of Independent Auditors

The Plan Administrator of Biohaven Pharmaceuticals Inc. 401(k) Plan

We have performed audits of the financial statements of Biohaven Pharmaceuticals Inc. 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of the Biohaven Pharmaceuticals Inc. 401(k) Plan (the “Plan”) provides general information about the Plan’s provisions. Biohaven Pharmaceuticals Inc. (the “Company”) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

#### *(a) General*

The Plan is a participant-directed defined contribution plan covering substantially all employees of the Company that are age 21 or older. There is no minimum service requirement for participation and, in order to participate in the Plan, employees must affirmatively make such election. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *(b) Administration*

The Plan has multiple investment options for eligible employees. ADP Retirement Services was the recordkeeper for the Plan and Reliance Trust Company (“Reliance”) was the trustee of the Plan for the year ended December 31, 2023.

On April 1, 2024, Fidelity Workplace Services LLC became the recordkeeper for the Plan and Fidelity Management Trust Company (“Fidelity”) became the trustee for the Plan.

#### *(c) Participant Contributions*

Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan, on a pretax basis as a traditional 401(k) contribution and/or on an after-tax basis as a Roth 401(k) contribution. Eligible participants may contribute both pretax and Roth 401(k) contributions up to a combined maximum of \$23,000 in 2024, in accordance with the Internal Revenue Code (“IRC”) qualified retirement plan limits. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The maximum amount allowed for catch-up contributions was \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified plans. These amounts are considered to be rollover contributions.

#### *(d) Employer Contributions*

Participants are immediately eligible to receive a 100% Company match on the first 4% of eligible compensation that a participant contributes to the Plan on a combined pretax and Roth 401(k) basis. The matching contributions are made in cash and invested according to each participant’s investment elections. Participant pretax contributions and employer contributions, and earnings thereon, are not taxed until withdrawal. Contributions are funded after each semi-monthly payroll cycle, and the Plan allows for true-ups to contributions at year end under certain circumstances. Lastly, additional nonelective contributions may be contributed at the discretion of the Company. No such amounts were contributed for 2024.

#### *(e) Participant Investment Elections*

Participants direct their elective contributions and employer contributions among investment options offered by the Plan. Participants may change how future contributions are invested and/or how their current balance is invested on a daily basis.

#### *(f) Participant Accounts*

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances.

#### *(g) Vesting*

Participants are immediately vested in 100% of their account balance, including their contributions, Company matching contributions and their actual earnings thereon.

#### *(h) Participant Loans*

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, not less than \$500. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2% at the time granted. Principal and interest are paid ratably through monthly payroll deductions over no more than five years, except for loans to purchase a primary residence which must be paid over no more than 30 years. If a participant terminates employment with the Company, any remaining payments are due immediately. If the loan is not repaid, it will automatically be treated as a distribution to the participant. As of December 31, 2024, interest rates on loans outstanding range from 5.25% to 9.75%.

#### *(i) Payment of Benefits*

Upon separation from service with the Company due to death, disability, retirement, or termination, participants whose vested account balance exceeds \$5,000 may elect to take a lump sum distribution or roll over their account balance to another qualified plan or Individual Retirement Account ("IRA"), or receive installments, request a partial withdrawal or defer receiving payments until 72. Participants whose vested account balance is \$5,000 or less may elect to take a lump-sum distribution or roll over their account balance to another qualified plan or IRA. Participants who do not make an election with a balance of \$5,000 or less will automatically have their balance rolled over to an IRA.

Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

#### *(j) Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless other-wise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *(k) Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Excess Contributions*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 31 of the succeeding year.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance, the trustee of the plan as of December 31, 2023 and for the period from January 1, 2024 to March 31, 2024, and Fidelity as of December 31, 2024 and for the period from April 1, 2024 through December 31, 2024.

### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.
- Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

*Mutual funds:* Valued at the Net Asset Value (“NAV”) of shares held by the Plan at year-end which are quoted on an active market.

*Common/collective trust funds:* Valued at the NAV and reported by the respective funds at each valuation date. The NAV of these funds are deemed to have a readily determinable fair value.

### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 6. Tax Status

The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
