Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Optima Care Brentwood, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of the Plan

The Optima Care Brentwood, LLC 401(k) Plan (the "Plan") is a contributory 401(k) plan which was established January 1, 2024 to provide the opportunity to save for retirement on a tax-advantaged basis. The Plan sponsor is Optima Care Brentwood, LLC (the "Sponsor"). The following description of the Plan provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan. The Plan covers substantially all employees of the Sponsors and provides for a deferred compensation arrangement as described in Section 401(a) and 501(a) of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees of the Company, who are age twenty-one or older and have completed one consecutive year of service, as defined in the Plan document, are eligible to participate in the Plan. Employees subject to a collective bargaining agreement, leased employees and non-resident aliens are not eligible to participate in the Plan.

The age and service requirements were waived for any eligible employee who was employed on May 9, 2024.

Contributions

The Plan allows each participant to contribute a specific percentage or dollar amount of his or her compensation, as defined, up to the maximum annual amount allowed by law. Participants who are at least age 50 or will attain age 50 before the end of a calendar year, may elect to defer additional amounts (called "catch-up contributions") to the Plan as of the January 1st of that year. The additional amounts may be deferred regardless of any other limitations on the amount that can be contributed to the Plan. The maximum "catch-up contribution" that can be made in 2024 is \$7,500. The Plan includes an automatic salary deferral feature. Employees are automatically enrolled at 3% of gross salaries and will increase annually by 1% of compensation up to a maximum of 10%.

Employer Contributions

The Employer may, at its discretion, make a non-elective contribution to the Plan in any specific dollar amount or any percentage of elective deferrals. No non-elective contributions were made in the year ended December 31, 2024. The Employer may also make, at its discretion, qualified matching contributions. No such contributions were made in the year ended December 31, 2024.

Participant Accounts

The Plan is a participant-directed account plan. Each participant's account is credited with the participant's contribution and allocation of (a) the Sponsor's contribution and, (b) Plan earnings (losses), and charged with an allocation of the administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their voluntary 401(k) Accounts. The following vesting schedules apply to Employer Profit Sharing Contributions and Employer Matching Contributions:

Forfeited Accounts

Forfeitures result from a participants' termination of service prior to achieving full vesting in the Plan contributions. At December 31, 2024, there were no forfeited non-vested accounts. Forfeited non-vested accounts are first used to pay for the Plan's administrative expenses. Then, they are used to fund employer contributions.

Payment of Benefits

Upon termination of service, a participant is entitled to receive the value of his or her account in a lump sum or other payment methods.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become fully vested regardless of the vesting schedule.

Hardship Withdrawal

In cases of immediate and heavy financial need, as defined by the Plan, participants may be eligible to receive an emergency withdrawal from a certain portion of their vested account balance.

Notes Receivable from Participants

The Plan provides for participant loans of not greater than \$50,000. The minimum loan amount a participant may borrow is \$1,000. However, in no event may participants borrow more than 50% of their vested account balance. Generally, the participant must be an active employee to apply for a loan. Principal and interest is paid ratably through payroll deductions. Loans are repaid over a period selected by the participant; however, such a period may not exceed five years (with the exception of principal residence real estate loans which may be longer). There were no loans outstanding as of December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are deemed as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Investment Fees and Expenses

Several of the investment fund options are subject to investment fees based upon a percentage of assets invested, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's performance and thus are not separately disclosed in the accompanying financial statements. All other administrative expenses related to the plan may not be paid by the Plan. The Plan Sponsor may, in its discretion, pay any or all expenses. The amount paid by the Plan amounted to \$128 in 2024.

Date of Management's Review

In preparing these financial statements, the Company has evaluated events and transactions through October 14, 2025, which is the date the financial statements were available to be issued.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the assets or liabilities.
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

- *Pooled Separate Accounts (PSA)* – Valued at its net asset value (NAV) based on the market value of its underlying investments but the PSA NAV is not a publicly quoted price in an active market. Prices are validated through an investment analyst review process including direct interaction with external sources or review of recent trade activity. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

6. Related Party Transactions

Certain Plan investments are shares of mutual funds that were managed by The Lincoln National Life Insurance Company during the plan year ended December 31, 2024. These transactions are considered to be party-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Delinquent Contributions

In 2024, the sponsor failed to remit participant contributions in a timely manner. The sponsor identified 1 instance for a total of \$1,740, in which participant contributions were remitted to the Plan in violation of the Department of Labor (DOL) regulations. The sponsor calculated the amount of lost earnings and determined that the amounts were immaterial.


