**Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Wynshop Holdings II 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Wynshop Holdings II 401k Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter**

As discussed in Note 1 to the financial statements, the Plan terminated effective April 29, 2025. Our opinion is not modified with respect to that matter. Subsequent to the termination date, the Plan is no longer a going concern.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Wynshop Holdings II 401k Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

### (1) DESCRIPTION OF THE PLAN

The following description of the Wynshop Holdings II 401k Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all employees of Wynshop Holdings II (the "Company") age eighteen or older. Participants are eligible to enter the Plan and begin making salary deferrals after the completion of one month of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 11, 2024, the Plan name was changed to Wynshop Holdings II 401k Plan. Prior to this date, the Plan name was Mi9 Inc. 401(K) Plan. The Company name was changed to Wynshop Holdings II.

Effective May 1, 2024, the Plan was amended to credit service for employees who previously worked at Halla, Inc. as service under this Plan.

Subsequent to year-end, Instacart purchased Wynshop Holdings II and as such the Plan terminated in 2025. All contributions ceased as of April 29, 2025 and all assets were distributed by August 2025.

- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Employees can elect to make pre-tax 401(k) deferrals or after-tax Roth 401(k) deferrals. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans. All contributions are participant directed.
- (c) Employer 401(k) Matching Contribution – The Company contributes a match for each employee who enters into a salary reduction agreement. In order to receive the match, each employee must complete one month of service. In 2023 the Company adopted the safe harbor match making it 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.
- (d) Employer Discretionary Nonelective Contribution – The Company may make a discretionary nonelective contribution in an amount to be determined each Plan year. Employees must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive this contribution. There was no such contribution made during 2024 or 2023.
- (e) Vesting – Participants are immediately vested in their voluntary contributions, rollover contributions, and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of the participant's account plus actual earnings thereon is based on years of continuous service. A participant is 33% vested per year of credited service and 100% vested at the end of year 3. Upon normal retirement age, 65 years old, death or disability, a participant becomes fully vested.

- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.
- (g) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce employer matching contributions or allocated to remaining participants using a pro rata allocation method based on a uniform percentage of eligible compensation. Forfeitures available and used as of and for the years ended December 31, 2024 and 2023 are as follows:

- (h) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest is repaid ratably through weekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- (b) Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan Document.
- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

- (d) Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- (e) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Plan has evaluated subsequent events through October 15, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) PARTIES-IN-INTEREST

(5) TAX STATUS

The Plan is a prototype plan that has obtained a determination letter stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC). Generally the plan administrator and the Plan may rely on the determination letter as to the form of the Plan qualifying under the IRC (except as otherwise noted in the determination letter). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) WITHDRAWING PARTICIPANTS

There were no participant distributions requested in 2024, but not paid until 2025.

(7) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023

(8) FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

*Collective trust funds:* Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. We have performed audits of the accompanying financial statements of Wynshop Holdings II 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### (1) DESCRIPTION OF THE PLAN

The following description of the Wynshop Holdings II 401k Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all employees of Wynshop Holdings II (the "Company") age eighteen or older. Participants are eligible to enter the Plan and begin making salary deferrals after the completion of one month of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 11, 2024, the Plan name was changed to Wynshop Holdings II 401k Plan. Prior to this date, the Plan name was Mi9 Inc. 401(K) Plan. The Company name was changed to Wynshop Holdings II.

Effective May 1, 2024, the Plan was amended to credit service for employees who previously worked at Halla, Inc. as service under this Plan.

Subsequent to year-end, Instacart purchased Wynshop Holdings II and as such the Plan terminated in 2025. All contributions ceased as of April 29, 2025 and all assets were distributed by August 2025.

- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Employees can elect to make pre-tax 401(k) deferrals or after-tax Roth 401(k) deferrals. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans. All contributions are participant directed.
- (c) Employer 401(k) Matching Contribution – The Company contributes a match for each employee who enters into a salary reduction agreement. In order to receive the match, each employee must complete one month of service. In 2023 the Company adopted the safe harbor match making it 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.
- (d) Employer Discretionary Nonelective Contribution – The Company may make a discretionary nonelective contribution in an amount to be determined each Plan year. Employees must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive this contribution. There was no such contribution made during 2024 or 2023.
- (e) Vesting – Participants are immediately vested in their voluntary contributions, rollover contributions, and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of the participant's account plus actual earnings thereon is based on years of continuous service. A participant is 33% vested per year of credited service and 100% vested at the end of year 3. Upon normal retirement age, 65 years old, death or disability, a participant becomes fully vested.

- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.
- (g) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce employer matching contributions or allocated to remaining participants using a pro rata allocation method based on a uniform percentage of eligible compensation. Forfeitures available and used as of and for the years ended December 31, 2024 and 2023 are as follows:

- (h) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest is repaid ratably through weekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- (b) Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan Document.
- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

- (d) Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- (e) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Plan has evaluated subsequent events through October 15, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) WITHDRAWING PARTICIPANTS

There were no participant distributions requested in 2024, but not paid until 2025.

(7) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023

(8) FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

*Collective trust funds:* Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
