Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Hynes Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hynes Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

NOTE A - DESCRIPTION OF PLAN

The following description of Hynes Industries, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2024. The Plan covers all employees of Hynes Industries, Inc., Hynes Kokomo LLC, and American Roll Form Products (the “Company”), who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participant Eligibility and Contributions

The Plan provides that employees at the age of 18 and over are eligible to participate in the Plan after 3 consecutive months of service. Participants may make elective contributions up to 100% of their eligible compensation, not to exceed the maximum amount allowed under applicable income tax regulations. Participants can make catch up and Roth contributions as part of the plan. The Plan sponsor makes safe harbor matching contributions equal to 100% of participant salary deferrals that do not exceed 4% of compensation.

The Plan allows for rollover contributions from other retirement plans and certain IRAs.

Effective January 1, 2025, employees are automatically enrolled in the Plan and 3% of the employees' compensation is automatically withheld (“automatic deferral provision”) each payroll unless the employee makes a contrary decision.

Also effective January 1, 2025, the Plan added an automatic deferral escalation provision in which participants' elective deferrals increase by 1% at the beginning of each plan year up to a maximum deferral of 10%, unless the participant makes a contrary decision.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, the Company's discretionary nonelective contribution, the Company's discretionary matching contribution, Plan earnings and losses, and administrative expenses. Allocations of the Plan's earnings and losses are based on the proportion that each participant's account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

During the year ended December 31, 2024, no discretionary contributions were made by the Company.

NOTE A - DESCRIPTION OF PLAN (continued)

Vesting

Participants are 100% vested in their contributions, employer safe harbor matching contributions, and related earnings of the Plan thereon, if any. Vesting in the remainder of their accounts is based on years of service. Employer discretionary matching and discretionary nonelective contributions are based on the vesting schedule below:

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of the vested balance of their account. The receivables are secured by the balance in the participant's account and must bear interest at the prime rate plus 1%. During the year ended December 31, 2024, the notes had fixed rates ranging from 3.25% to 9.50% for the term of the note. Principal and interest may be paid through payroll deductions or by check.

Investments

All contributions, including employer safe harbor matching contributions and employer discretionary contributions are participant-directed into various investment options offered by the Plan. If the participant does not direct the investment of his or her applicable Plan accounts, then participant accounts will be invested in accordance with the default investment alternatives established under the Plan.

Payment of Benefits

Benefits are payable in an amount up to equal the value of the participant's vested interest in his or her account in a lump-sum payment. Hardship distributions are not permitted.

Forfeitures

If a participant is not vested upon termination, the nonvested portion of their account balance contributed by the employer and the earnings thereon are forfeited. Forfeited amounts are used to reduce employer matching contributions. Employer contributions were reduced by \$195,475 from forfeited nonvested accounts for the year ended December 31, 2024. The balance of forfeited nonvested accounts was \$322 as of December 31, 2024

Plan Termination

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

Accounting standards require that participant loans be classified as notes receivable from participants in the accompanying financial statements; however, the Department of Labor requires these to be classified as investments on the Form 5500 and on Schedule H, Line 4i – Schedule of Assets (Held at End of Year).

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustee, John Hancock Trust Company LLC.

NOTE D - FAIR VALUE MEASUREMENTS

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 fair value inputs are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted market prices in active markets for similar assets, quoted prices in markets that are not active for identical or similar assets and other market observable inputs such as interest rate, credit spread and foreign currency exchange rates observable in the marketplace or derived from market transactions.

Level 3 fair values are based on at least one significant unobservable input for the asset. Level 3 securities contain unobservable market inputs and as a result considerable judgment may be used in determining the fair values.

Certain investments are measured at fair value using the net asset value (NAV) per share, or its equivalent, as a practical expedient. These investments include commingled funds which may include money market funds, common collective trusts and pooled separate accounts which are typically valued using the NAV provided by the administrator of the fund. The Plan assets include money market funds and common collective trusts. In accordance with accounting guidance, these investments have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at quoted market prices on the last business day of the Plan year.

Money market: As a practical expedient, valued at the NAV of shares held by the Plan at year end.

Common collective trust: Units held in collective investment trusts are valued using the NAV of the fund, as a practical expedient. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective investment fund is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. The collective trust provides for daily redemptions by the Plan at reported net assets values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. These services are party-in-interest transactions. The Plan also invested in mutual fund investments which are owned and managed by John Hancock, the trustee of the Plan's investments. These transactions also qualify as party-in-interest transactions.

The Plan allows participants to borrow funds against their account balances. These transactions qualify as party-in-interest transactions.

NOTE G - RISKS AND UNCERTAINTIES

The Plan provides various investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
