Independent Auditors' Report

Opinion

NOTE 1 – SUMMARY OF THE PLAN

Plan Description

The following description of the American Bakery Company 401 (K) Profit Sharing Plan (the “Plan”) provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 1982 and qualifies as a defined contribution retirement plan covering substantially all eligible employees of Oakhurst Industries, Inc DBA American Bakery Company (the “Company”). This Plan was established for the purpose of providing retirement benefits to eligible employees in accordance with the Plan. The Plan is intended to satisfy the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

Oakhurst Industries, Inc. is the Plan’s sponsor and serves as plan administrator. Effective September 2023, Charles Schwab & Co., Inc. (“Charles Schwab”) replaced TD Ameritrade as the Plan’s investment custodian. As a result of this transition, all Plan assets previously held in custody at TD Ameritrade were transferred to Charles Schwab, which now serves as the Plan’s asset custodian (the “Asset Custodian”).

Effective January 1, 2024, the Plan was amended to permit in-service distributions only from contribution sources in which the participant is 100% vested. This amendment, as reflected in the Adoption Agreement, supersedes the prior restriction in effect since January 1, 2023, which prohibited all in-service distributions. The revised provision reinstates limited in-service distribution rights, conditioned on full vesting by source. The Plan Administrator must verify 100% vesting before approving any such distribution.

Participant Eligibility

Each of the Company’s employees is eligible to participate in the Plan if they have completed one year of service. Once the eligibility requirements have been met, employees may enroll in the Plan on the first day of the month following the day of the eligibility date. For the discretionary employer matching contribution, employees must complete 500 hours of service during the calendar year or be employed on December 31st to be eligible.

Contributions

The Company’s eligible employees may contribute up to the 402(g) limit and/or the Actual Deferral Percentage (ADP) test limit for highly compensated employees. The 402(g) limit for 2024 was \$23,000. Participants may also rollover amounts representing distributions from other qualified plans. In addition, all eligible employees who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, Code Section 414(v). For 2024, the maximum catch-up contribution limit was \$7,500.

Contributions (Continued)

The Company may make a discretionary matching contribution and Safe Harbor Matching contribution. Effective January 1, 2022, the Company adopted a Safe Harbor matching contribution formula providing 100% matching of participant elective deferrals up to 4% of eligible compensation. The matching formula remained unchanged during 2024. For the year ended December 31, 2024, the Company made total employer matching contributions (including discretionary profit-sharing contribution and safe harbor match) to the Plan on behalf of all eligible employees totaling \$500,000.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Investment Options

Contributions are not participant directed and are invested in a pooled fund as directed by the Company. The pooled fund is managed by the plan's investment advisor Edelman Financial Engines ("EFE").

Vesting

Participants are one hundred percent (100%) vested in their contributions plus actual earnings thereon. Participants become vested in their Company profit-sharing matching contributions account and any earnings as follows:

Effective January 1, 2022, Safe Harbor Matching Contributions will be immediately vested plus actual earnings thereon. Notwithstanding the above, a participant is fully vested in all contributions, upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

A participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The notes must be repaid within 5 years. The notes are secured by the balance of the participant's account and bear a reasonable rate of interest.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative costs and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant will be taxed on the entire amount of the outstanding loan (plus accrued interest) through the date of the default. The current interest rates on existing loans range from 5.25% to 10.50%.

Forfeitures

Amounts forfeited from terminating participants' non-vested portion of their Company matching contribution account and earnings on Company contributions are used first to reduce administrative expenses, then to reduce matching contributions. The forfeitures account balance at December 31, 2024 and 2023 was \$8,469 and \$26,108, respectively.

Payment of Benefits

Upon termination of service, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

In-service distributions will only be permitted if the Participant is 100% vested in the source from which the withdrawal is taken.

SECURE Act 2.0 Provisions

In December 2022, the Securing a Strong Retirement Act of 2022 ("SECURE Act 2.0") was enacted, introducing a broad array of mandatory and optional provisions. These changes are intended to enhance retirement savings opportunities, simplify plan administration, and improve participant outcomes. Participants are encouraged to review the updated Summary Plan Description and contact the Plan Administrator with any questions regarding how these changes may affect their benefits. Plan management continues to evaluate key SECURE 2.0 provisions and assess implementation of applicable optional and mandatory requirements. No provisions of the Act materially impacted the Plan's financial position, changes in net assets available for benefits, or related disclosures as of or for the year ended December 31, 2024.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”). A summary of the significant accounting policies applied in the preparation of the accompanying financial statements follows.

Accounting Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and deductions during the reporting period. Actual results could differ from estimates.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

The Plan’s expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value investments. The Plan incurred \$142,053 of administrative expenses during the year ended December 31, 2024.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments, bought and sold as well as held during the year. The mutual funds and exchange traded funds are recorded at quoted market prices.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Boards (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Investment Valuation and Income Recognition (Continued)

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds/Exchange Traded Funds: Valued at the daily closing price as reported by the fund. Mutual funds/Exchange Traded funds held by the Plan are open-end mutual funds/exchange traded funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds/exchange traded funds held by the Plan are deemed to be actively traded.

Interest Bearing Cash: Valued based on cost, which approximates fair value in a non-inflationary economy and is protected by the Federal Deposit Insurance Corporation (FDIC).

Non-Discrimination for Employee and Employer Contributions

The Plan, as required by the Internal Revenue Code (IRC), performs annual tests between highly compensated participants versus non-highly compensated participants to ensure that highly compensated participants are not disproportionately favored under the Plan. If the Plan fails the tests, it must refund excess deferral contributions or make a Qualified Non-Elective Contribution ("QNEC") for the non-highly compensated employees. Excess contributions that are refunded within two and a half months of the Plan year end are accrued as a liability on the statement of net assets available for benefits. The Company made no QNEC for the year ended December 31, 2024.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of Employee Retirement Income Security Act (ERISA). If the Plan is terminated, all participants will be 100% vested in their account balances.

NOTE 5 – TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 5 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by TD and Charles Schwab, the custodians of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Edelman Financial Services LLC is the Plan's investment advisor, and CMC Pension Professionals is the Plan's Third Party Administrator; therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 – PROHIBITED TRANSACTIONS

For the year ended December 31, 2023, the Company submitted late employee contributions totaling \$25,424, to the Plan. These late remittances are considered prohibited transactions by the Internal Revenue Service ("IRS") and Department of Labor ("DOL") and may be subject to penalties and interest. The loss of earnings on the aforesaid later remittances is computed to be \$221 to be contributed by the plan sponsor as QNEC contributions which has been accrued in the financial statements.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated and determined that no other events have occurred subsequent to the date of the statement of net assets available for benefits through October 15, 2025 the date which the financial statements were available to be issued, which require recording or disclosure in these financial statements.


