*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matters

#### **Note 1 - Description of Plan**

The following description of Crestek Deferred Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined-contribution retirement plan which covers all employees of Crest Ultrasonics Co., Uthe Technology, Inc., Piezo Kinetics Inc., Rinco Ultrasonics USA Inc., and Goodson & Wells Farms, Inc. (collectively known as the "Employer" or the "Company") who meet eligibility requirements. The Plan commenced effective October 1, 1985. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Oversight of the Plan is the responsibility of management. Management also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### **Eligibility requirements**

Employees at least 18 years of age are eligible to participate in the Plan after completing three months of service. Entry dates are the first day of each calendar quarter.

##### **Contributions**

Employee contributions are made in the form of tax-deferred salary reductions. Employees can elect to contribute a percentage of eligible compensation, limited to a maximum as determined by the Internal Revenue Service ("IRS").

For employees of the Company, other than Piezo Kinetics Inc., who elect to contribute to the Plan, the Company contributes 50% of employee's deferrals up to 6% of compensation. From January 1, 2024 to June 30, 2024, for Piezo Kinetics Inc. employees who elected to contribute to the Plan, the Company contributed \$0.03 for each dollar up to \$20,000 of compensation, and \$0.02 for each dollar of compensation from \$20,001 to \$30,000, for a maximum of \$800 per employee. Effective July 1, 2024, for Piezo Kinetics Inc. employees who elect to contribute to the Plan, the Company contributes 50% of employee's deferral. It is the policy of the Company to fully fund this discretionary matching contribution amount as of the last day of each calendar month. A discretionary profit-sharing amount may be contributed at the option of the Company's Board of Directors. There were no discretionary profit-sharing contributions during 2024.

A participant may, with the consent of the Plan administrator, make rollover contributions to the Plan at any time. Rollover contributions are assets transferred to the Plan from a qualified retirement plan in which the employee participated prior to his or her employment by the Employer. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participating employees are vested immediately in the value of their contributions and earnings on those balances. Participants become 100% vested in the Company discretionary matching and discretionary profit-sharing contributions and earnings thereon after one year of service with the Company. Participants are 100% vested when they retire, become totally disabled, or die. Total vesting also occurs if the Plan is fully or partially terminated, or if the Employer permanently discontinues contributions.

#### **Investment options**

Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Notes receivable from participants**

The Plan may approve loans to participants under the following circumstances: (1) loans will be for a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of the participant's vested account, (2) loans will include a reasonable rate of interest, (3) loans will be for a term of no more than five years (15 years if the loan is for the purchase of a principal residence), (4) the loans are secured by the balance in the participant's account, and (5) repayment is to be made in level installments through monthly payroll deductions. A participant may have two loans outstanding at any time.

#### **Payment of benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a period not to exceed the life expectancy of the participant and the participant's designated beneficiary. The Plan administrator may authorize lump-sum distributions for terminated participants with balances of less than \$5,000.

The Plan allows for automatic rollovers of account balances of terminated participants into an Individual Retirement Plan ("IRA") designated by the Plan administrator if the amount exceeds \$1,000 and does not exceed \$5,000 and the participant does not elect to receive the distribution or have the distribution paid directly to an eligible retirement plan.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$637 and \$606, respectively. These accounts will be used to pay administrative expenses and reduce future employer contributions. In 2024, no forfeited nonvested accounts were utilized to reduce employer contributions and \$3,417 of forfeited nonvested accounts were utilized to pay administrative expenses.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

#### **Investment valuation and income recognition**

The Plan's investments are stated at fair value and are held by Ascensus Trust Company (the "Trustee"), which has been designated as both the trustee and custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Contributions**

Contributions from Plan participants and the matching and profit sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### **Subsequent events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at amortized cost, which approximates fair value.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### **Note 4 - Related party transactions and party-in-interest transactions**

Ascensus Trust Company is the Trustee and custodian of the Plan's assets, and Ascensus, Inc. is the Plan's third-party administrator and recordkeeper. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment fund. Notes receivable from participants qualify as party-in-interest transactions.

#### **Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 6 - Tax status**

The prototype Plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the Trustee of the Plan.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the trust within the time frame specified by the DOL's Regulation (CFR 2510.3-102) during the Plan years ended December 31, 2022, 2023, and 2024, thus constituting nonexempt transactions between the Plan and the Company. The nonexempt transactions for the Plan years ended December 31, 2022, 2023, and 2024 were corrected in 2025.
