Note 1 – Description of Plan

General

The following description of the Clove Lakes Health Care and Rehabilitation Center, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan that was established on May 1, 1993 to provide benefits to eligible employees of Clove Lakes Health Care and Rehabilitation Center, Inc. (the “Company”). The Plan covers all regular employees of the Company who are non-union and age twenty-one or older. Participants are eligible to contribute pretax deferrals on the first of the month following hire date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may elect to contribute a percentage of pretax annual compensation, not to exceed IRS limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may provide a discretionary matching or profit sharing contribution during the year or at year end. During the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 25% of the participant contributions up to a maximum of 12% of base compensation totaling \$83,734. Contributions are subject to certain limitations as required by law.

Participant Accounts

Under the Plan, a separate account is maintained by each participant. Each participant’s account is credited with the participant’s contributions, employer contributions, allocation of Plan earnings, and charged with an allocation of the administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their fund balance a minimum of \$1,000 up to a maximum of the lesser of 50% of their respective vested balances or \$50,000, by executing a note in accordance with the Plan’s provisions. Participants are permitted to have one outstanding loan from the Plan at any time. The loans are secured by the balance in the participant’s account and bears interest at a reasonable rate determined by the trustees, as defined in the plan document. Principal and interest are paid ratably through payroll deductions.

Note 1 – Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions and all Company contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant will receive an amount equal to the value of the participant's vested interest in his or her account, in a lump-sum cash payment, partial withdrawals, or installments. For termination of service due to other reasons, a participant may receive the vested value of the interest of his or her account as a lump-sum distribution.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance, plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Corrective Distributions

Corrective distributions may be required in the event that employee contributions exceed contribution limitations of the Plan. These amounts are recorded as a liability as of the Plan's year end and reflected on the *statement of changes in net assets available for benefits as an offset to contributions.*

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

At December 31, 2024 and 2023, there were forfeited amounts of \$3,011 and \$3,531. These amounts are being held in a cash account designated to be used as payment of future Plan expenses.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless directly paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the management of notes receivable from participants are charged directly to the participants account. The fees paid by the Plan are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in the net appreciation or depreciation of fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Date of Management’s Review

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology that are observable, either directly or indirectly, such as quotes prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of the mutual funds were based on the net asset value of the shares as reported by Empower Retirement. The mutual funds held by the Plan are open-end mutual funds registered with the U.S Securities and Exchange Commission. The funds publish their daily net asset value and transact at that price. The annuities held by the Plan are considered to be actively traded.

Note 5 – Investment Contract with Insurance Company

In 2014, the Plan entered into a benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company, subsequently purchased by Empower Retirement (“Empower”). Empower maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and any specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$2,757,621 and \$3,149,682, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis or more often as needed for resetting.

Certain events limit the Plan’s ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) the market value account balance is not more than \$1 or the book value account balance is zero, (c) determination is made that it will not be able to continue to operate under the current terms following the Plan’s activation or material change to any Plan investment fund, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contract without the issuer’s consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Note 6 – Related Party Transactions and Party in Interest Transactions

Certain plan investments are managed and held by the Custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party in interest transactions.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8 – Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 – Delinquent Transmittals

During 2024 and 2023, the Company erroneously failed to remit certain employee deferrals and loan repayments to the Plan within the period prescribed by the Department of Labor regulations. The Company will compute the lost earnings on the deposits and remit the deposits along with a contribution for lost earnings to the affected participants' accounts.

Note 10 – Risks and Economic Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit. The current economic environment has increased the degree of uncertainty.
