Opinion

We have audited the financial statements of The Burdick Companies Medical Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section of our report. Notes to Financial Statements

Note 1 - Description of Plan

The following description of The Burdick Companies Medical Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan provides health and dental benefits covering substantially all active employees of Drivers Village, Inc. and RLB Development, LLC (collectively, the "Plan Sponsor"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health and dental benefits to all full-time employees of the Plan Sponsor and to their beneficiaries and covered dependents. Eligible employees can enroll in the Plan after satisfying a sixty-day waiting period. The Plan has established deductibles in the amount of \$330 per person and \$990 per family for medical benefits and \$50 per person and \$150 per family for dental benefits, per calendar year. After the participant has satisfied the medical deductible, the Plan will pay 80% of the charges for eligible medical expenses until the participant has incurred \$6,000 in eligible medical expenses during the calendar year. For the remainder of the calendar year, the Plan will pay 100% of the eligible medical expenses for that participant. After the participant has satisfied the dental deductible, the Plan will pay benefits up to a maximum of \$1,000 per calendar year for dental benefits.

Contributions - The Plan is funded by contributions from the Plan Sponsor and employees. Employees make contributions in set amounts for themselves and their dependents, determined periodically by the Plan Sponsor. Employees contributed \$755,300 and \$729,940 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor makes contributions sufficient to cover claims paid. The Plan Sponsor contributed \$1,586,982 and \$1,555,882 for the years ended December 31, 2024 and 2023, respectively.

Payment for claims - The Plan is generally self-insured and covered claims are paid directly by the Plan. Claims are processed by a third-party administrator, but the responsibility for payments to participants and providers is retained by the Plan.

Stop-loss insurance - The Plan has purchased a "stop-loss" insurance policy, which will reimburse the Plan for the amount of claims paid in a year that exceed a certain aggregate level as defined in the policy or exceed \$80,000 for the years ended December 31, 2024 and 2023, for individual participants per year. The stop-loss policy does not relieve the Plan from its obligations. Failure of the stop-loss provider to honor their obligations could result in losses to the Plan and/or the Plan Sponsor. The Plan evaluates the financial condition of its stop-loss provider to minimize its exposure to significant losses from the provider's insolvency. There are no losses recorded or anticipated due to failure of the stop-loss provider to honor their obligations. The Plan paid insurance premiums of \$351,630 and \$277,096 for the years ended December 31, 2024 and 2023,

respectively, related to the stop-loss policy. The trust recorded recoveries of \$395,948 and \$600,371 from the excess insurance carrier under the stop-loss policy for the years ended December 31, 2024 and 2023, respectively. A stop-loss receivable of \$54,302 and \$72,613 as of December 31, 2024 and 2023, respectively, is included in these recoveries, which was fully received from the stop loss carrier in 2025 and 2024, respectively.

Plan termination - Although they have not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Cash and cash equivalents - The Plan considers all money market funds and short-term investments with a maturity of three months or less when purchased to be cash equivalents.

Concentration of credit risk - The Plan maintains cash balances at one financial institution. Cash balances at the financial institution in excess of the amount insured by the Federal Deposit Insurance Corporation are subject to credit risk. The Plan had approximately \$989,000 and \$1,546,000 in excess of FDIC insured limits as of December 31, 2024 and 2023, respectively. The Plan has not experienced any losses in such accounts.

Administrative costs - Administrative costs, including recordkeeping and claims processing, are paid by the Plan (see Note 5). Legal and accounting fees are paid by the Plan Sponsor.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and benefit obligations, claims incurred but not reported, claims currently payable, changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Subsequent events - Management has evaluated subsequent events through October 3, 2025, the date that the financial statements were available for issue.

Note 3 - Income tax status

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan Sponsor believes that the trust, as amended, continues to qualify and to operate as designed. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the years ended December 31, 2024 or 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2021.

Note 4 - Benefit obligations

Benefit obligations include the Plan's liability for claims incurred as of year-end, but not reported and claims currently payable, which are for claims reported as of year-end, but not processed for payment. The Plan's liability for claims incurred but not reported is estimated by management utilizing a lag report provided by the third-party administrator, which summarizes those claims that were processed and paid subsequent to year end but were incurred prior to year-end. The Plan had \$58,570 and \$214,254 of claims incurred, but not reported as of December 31, 2024 and 2023, respectively, which are included in incurred, but not reported claims payable in the statements of net assets available for benefits and benefit obligations. Management believes that the amount estimated is adequate; however, the ultimate liability may be in excess of the amount provided. The methods of making such estimates and for establishing the resulting obligation are continually reviewed and any adjustments are reflected in current earnings. The Plan had \$10,577 and \$6,769 of claims currently payable as of December 31, 2024 and 2023, respectively.

Note 5 - Related party transactions

The Plan Sponsor has contracted with certain third-party administrators to assist with recordkeeping as well as claims processing, which qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping and claims processing amounted to \$152,064 and \$154,095 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses in the accompanying statements of changes in net assets available for benefits and benefit obligations. The Plan contracts with Dannible & McKee, LLP to provide auditing services, which qualifies as party-in-interest transactions. Fees for these services were paid for by the Plan Sponsor for the years ended December 31, 2024 and 2023.

Note 6 - Reconciliation of the financial statements to Form 5500

Furthermore, Form 5500 has certain investment balances and income items that differ from amounts shown on the accompanying financial statements. These differences relate to classification and rounding only and have no effect on the net assets available for benefits as of December 31, 2024 and 2023, nor changes in net assets available for benefits for the years then ended.


