If multiple separation dates are used, the actuarial present values take into account the probability of each separation event.



The above-stated benefits will be reduced by the Actuarial Equivalent value of the Participant's account, which is attributable to Employer contributions, other than any elective deferral contributions or Employer matching contributions, made to the RCI Builders, Inc. 401(k) Profit Sharing Plan subsequent to December 31, 2013. For this purpose, only Employer contributions, other than any elective deferral contributions or matching contributions, which do not exceed 5.0% of the Participant's Compensation for the applicable Plan Year will be considered. The Participant's account balance for the benefit reduction described above will not take into consideration Employer contributions which are made subsequent to the Plan Year ended December 31, 2022.
