Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Portland VA Research Foundation 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness Portland VA Research Foundation 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Portland VA Research Foundation 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, as listed in the table of contents, as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Plan Description

The following description of Portland VA Research Foundation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective April 27, 2021.

General

The Plan, which was established January 1, 1999, is a defined contribution plan covering substantially all employees of Portland VA Research Foundation (the Employer), who are age 21 years or older. Certain employees are not eligible to participate which includes employees covered by collective bargaining agreement and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective July 1, 2024, eligible participants enter the Plan on the first day of each month. Prior to July 1, 2024, eligible participants would enter the Plan on the first day of the Plan Year and the first day of the, first, fourth, seventh and tenth months of each Plan Year. Fidelity Management Trust Company is the Plan's trustee. The retirement committee oversees plan governance.

Contributions

Each year, participants may contribute up to 100 percent of annual compensation on a pre-tax or Roth (after-tax) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

The Company makes a non-discretionary matching employer contribution of 100 percent of the first 3 percent of the eligible participant's contribution contributed to the Plan and 50 percent of the next 2 percent of the eligible compensation contributed to the Plan. Participants are immediately eligible for the non-discretionary matching employer contribution once they participate in the Plan. The non-discretionary matching employer contribution for the years ended December 31, 2024 and 2023 were \$192,400 and \$159,948, respectively.

The Company may also make a nonelective employer contribution each year, which is 2 percent of eligible compensation. Participants are eligible for the nonelective employer contribution if they are active participants for the Plan Year and are employed by the Employer on the last day of the contribution period. The nonelective employer contribution for the years ended December 31, 2024 and 2023, were \$99,390 and \$76,296, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings on the participant's account balances. Participant accounts are charged with certain administrative expenses that are not covered by the Employer. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Plan Description, continued

Vesting

Participants are vested immediately in their contributions, non-discretionary matching employer contributions, and the nonelective employer contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum of \$50,000 reduced by the excess of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made or half of the present value of the participant's vested interest in their account. The loans are secured by the balance in the participant's account and will bear a reasonable rate of interest. The loan may have a term of no more than five years unless for primary residence purchase which extends to 10 years. Principal and interest are paid ratably through payroll deductions. A participant may only have a maximum of one loan outstanding at any one time.

Payment of Benefits

Upon retirement, disability, death, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts by lump-sum, installment payments or lump sum in property, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. In addition, participants may elect to receive withdrawals of part or all of the interest in their accounts related to prior rollover contributions at any time. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested. Hardship distributions are permitted subject to a \$500 minimum amount.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 3 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses and Fees

Administrative expenses of the Plan are generally paid by the Employer which are excluded from these financial statements. Certain fees such as recordkeeping and trustee fees for participants who are no longer actively employed by the Employer but with remaining balance to the Plan, annual account maintenance fees for participants enrolled in self-directed brokerage account, participant level advisory fees and fees related to distributions and notes receivable from participants are included in administrative expenses and charged directly to the participants' accounts.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are participant and employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: The Plan's investments are units of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Cash, interest-bearing: Valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Tax Status

The Plan is a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA (the prototype plan upon which the Plan is based) sponsored by FMR, LLC. The Plan has obtained an opinion letter dated June 30, 2020, in which the IRS informed the Employer that the Plan as then designed was in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, acting as the trustee for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the year ended December 31:

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Party-in-Interest Transactions

Certain Plan mutual fund investments are managed by Fidelity Management Trust Company, the trustee of the Plan, through its affiliate, Fidelity Investments Institutional, and therefore these transactions qualified as party-in-interest transactions. Administrative fees paid to Fidelity Investments Institutional for the year ended December 31, 2024 and 2023 totaled \$12,384 and \$4,540 respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Non-Exempt Transactions

During the year ended December 31, 2024 and 2023, participant contributions totaling \$116,266 and \$13,999, respectively, were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. As of December 31, 2024, \$91,904 of the 2024 and 2023 prohibited transactions were corrected by calculating lost earnings and interest on the non-exempt transactions, while \$38,361 of the 2024 prohibited transactions had not been corrected. The employer is taking the appropriate steps to correct these non-exempt transactions and has further implemented procedures to ensure that all future remittances are made within the prescribed time period.

10. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
