*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Father Bill's & MainSpring, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1 - Description of the Plan

The following description of Father Bill's & MainSpring, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering employees of Father Bill's & MainSpring, Inc. (the "Company") upon hire, with no specific age or service requirement to enter the Plan. Nonresident aliens and residents of Puerto Rico are ineligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### **Contributions**

Each year, participants may elect to contribute up to the maximum percentage of compensation and dollar amount permissible under the Plan document and limited by the Internal Revenue Code ("IRC"). Participants are eligible to designate all or a portion of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

In addition, under the Plan, the Company has the option of making discretionary matching contributions for any Plan year. Employer contributions for the year ended December 31, 2023 that were funded during 2024 were elected at 4% of participants eligible compensation. The Company may also make additional discretionary nonelective contributions, however, none were elected during the year. An employee is eligible for discretionary employer contributions after completion of one year of service, 1,000 hours worked per year and attaining age 21. An employee who is not employed at the end of the Plan year or has not met the eligibility criteria during the Plan year will not be eligible to share in allocations of employer discretionary contributions. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's discretionary contribution, if eligible, and Plan earnings. Additionally, participants are charged with an allocation of administrative expenses. Allocations are based on participant earnings, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus their actual earnings. Vesting in the Company's discretionary contribution plus actual earnings is based on years of service. Participants are 100% vested in the Company's contributions after three years of credited service. In the event of termination due to death or total and permanent disability, participants shall become 100% vested in the Company contribution portion of their account.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their account. The notes receivable are secured by the balance in the participant's account and bear interest at 1% above the prime rate as of the loan election date. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

On termination of service for any reason, a participant may elect to receive a lump sum amount equal to the value of his or her account, or installments. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For participants with a vested account balance greater than \$1,000, but less than \$7,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator, unless an election is made by the participant to receive the payment directly. Participants with a vested account balance greater than \$7,000 may receive benefits in a lump sum or defer payment of benefits until a later date.

Withdrawals from a participant's deferral contributions account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who have attained age 59½ are eligible to make in-service withdrawals, in accordance with the provisions specified in the Plan.

#### Forfeitures

Forfeitures of amounts not vested will be used to fund future Company discretionary contributions for the Plan year or may be used to pay Plan expenses. Forfeitures at December 31, 2024 and 2023 were \$0 and \$2,586, respectively. During the year ended December 31, 2024, \$3,245 of forfeitures were used for employer discretionary contributions.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("GAAP"). The primary differences from financial statements prepared under GAAP arise from accounting for contributions and administrative expenses on the cash basis. Accordingly, the accompanying financial statements are not intended to be presented in conformity with GAAP.

#### Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that could be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation include the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividend income. Income is recognized when received and expenses are recognized when paid.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any received interest. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Plan expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. As provided in the Plan agreement, the Company paid substantially all professional service fees rendered by parties-in-interest during the year for auditing, investment management services and other services.

#### **Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 4 - Investment contract with insurance company

The Plan holds a fixed annuity contract with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company) totaling \$2,036 and \$5,350 as of December 31, 2024 and 2023, respectively. Participants who choose to invest in this option make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of Empower Annuity Insurance Company of America on a year-by-year basis.

Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The minimum interest rate under the contract is 0%. Interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 5 - Related party and party-in-interest transactions**

The Plan investments include a fixed annuity contract managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, fees incurred and paid directly by the Plan for related transactions were \$35,740. The notes receivable from participants qualifies as a party-in-interest transactions; however, they are not considered prohibited transactions under 29 CFR 2550.408(b) of ERISA regulations.

#### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 7 - Tax status**

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

**Note 8 - Risks and uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits (modified cash basis).

**Note 9 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedule of Assets (Held at End of Year) (Schedule H, Line 4i) (Modified Cash Basis), was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance Company of America, the custodians of the Plan.
