### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Health Care Authority for Baptist Health Matching Dollar Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

**Note 1 - Plan Description**

The following description of the Health Care Authority for Baptist Health Matching Dollar Plan (the Plan), provides only general information. The Health Care Authority for Baptist Health, an Affiliate of the UAB Health System (the Company) is the Plan Sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is funded by employer matching contributions for the Company employees enrolled in the Company's 457(b), 403(b), and 401(k) plans. The Plan is intended to be a governmental plan as defined under Internal Revenue Code Section 414(d).

Eligibility - Physicians may enter the Plan immediately. All nonphysician participants hired on or after January 1, 2009 must complete three years of service. A year of service is credited upon completion of 1,000 hours of service during a plan year. Employees who are not eligible to participate in the Plan are the CEO and Executive Vice President of the Company, employees who are UAB Faculty Practice employees, employees of Outreach Management Services, Inc., and independent contractors. Certain other employees are excluded as described in the Company's 457(b), 403(b), and 401(k) plans. Effective October 8, 2012, limited benefit status employees are not eligible to participate in the Plan.

Employer contributions - The Company contributes a matching contribution based on a fixed contribution formula up to 6% of compensation. The fixed matching contribution formula is \$0.35 for every \$1 of the participant's salary reduction for employees with less than 10 years of continuous service and \$0.50 for every \$1 of the participant's salary reduction for employees with 10 or more years of continuous service. For the years ended December 31, 2024 and 2023, the matching contribution was \$3,866,548 and \$3,542,994, respectively.

Participant contributions - The Plan allows participants to make rollover contributions from a qualified plan prior to meeting the eligibility requirements for participation in the Plan.

Participant accounts - Each participant's account is credited with the participant's portion of the employer contributions and allocations of plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Vesting in the Company's contributions is based on years of continuous service. A participant is generally 100% vested after three years of credited service. Participants are always fully vested in their rollover contributions.

Payment of benefits - Upon discontinuance of service due to termination of employment, normal retirement (age 65), early retirement (age 55 and five years of service), death or disability, a participant or his/her beneficiary may elect to receive the value of the vested interest in his/her account. The normal form of payment of benefits is a lump sum. Optional forms of payments the participant can elect to receive are installments, partial withdrawals, or different forms of annuities.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,908 and \$492, respectively. These accounts may be used to restore participant's forfeitures, offset plan expense, and reduce future employer contributions. For the years ended December 31, 2024 and 2023, the use of forfeited nonvested accounts amounted \$3,940 and \$22,815, respectively.

**Note 2 - Summary of Significant Accounting Policies**

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan has guaranteed investment contracts with Transamerica Financial Life Insurance Company (TFLIC) and Variable Annuity Life Insurance Company (VALIC), which the Plan Sponsor has determined meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. See Note 5 for discussion of the investment contracts.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level 2:* Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Collective investment trust fund - Vanguard Fiduciary Trust Company Target Retirement Trust II:* Valued at net asset value based upon fair values of the underlying net assets of the trusts, as determined by the issuer.

*Mutual funds:* Valued at the net asset value of shares held by the Plan at year end as reported on the active market.

*Collective investment trust fund - Winslow Large Cap Growth:* Valued at the net asset value of the units held by the Plan at year end based on information provided by the issuer as of year end. The fund's investment objective is long-term capital appreciation by using a fundamental, bottom-up investment process which centers on identifying growth companies. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from that the reported net asset value. The net asset value per unit of the fund is calculated as of the close of business each business day by dividing the total value of assets, less accrued expenses and liabilities, by the number of units outstanding. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a withdrawal in excess of 20% of such Plan's investment, the Plan must notify the fund's Trustee directly, in writing, five business days prior to the applicable withdrawal date. The collective investment trust is a direct filing entity.

TFLIC guaranteed investment option (TFLIC GIO) - The Plan invests in a stable value product that guarantees principal and interest which has been determined to be fully benefit-responsive. The guarantees are provided through a group annuity contract issued by TLIC. The contract has a portfolio interest rate design in which all deposits are credited with the same interest rate, are credited on a daily basis and there is no set maturity date. The contract issuer is contractually obligated to repay the principal and interest at a specified rate. The declared rate shall be set periodically, but shall not be reduced for a period of at least 12 months following the reset date. The declaration rate may be increased at any time, but a reduction requires 45-day notice. In no event would the declared rate of interest be less than the contracts minimum guaranteed interest rate. The minimum guaranteed interest rate is 1.3%. The TFLIC GIO does not have a maturity date or penalties for qualified participant withdrawals.

Certain events within control of the Plan Sponsor could limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) mergers, (2) layoffs, (3) bankruptcy, (4) the creation of a competing fund, (5) employee communications that influence contributions to or withdrawals or loans from the plan option (6) the occurrence of an insolvency event, (7) the disqualification of the Plan, and (7) early retirement incentive programs. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

VALIC investment contracts - The Plan invests in investment contracts at VALIC which have been determined to be fully benefit-responsive investment contracts. The VALIC contracts consist of the Portfolio Director Group Fixed and Variable Deferred Annuity Contract. VALIC maintains the contributions in its general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan, with a minimum guaranteed rate of 3%. There are no reserves against the contract value for credit risk of the contract issuers or otherwise. The crediting interest rates are based on formulas agreed upon with the issuers. Such interest rates are reviewed monthly and reset at least as frequently as monthly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity dates.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 22, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 - Related Party Transactions**

Certain Plan investments are managed by TFLIC and VALIC. State Street Bank and Trust Company, TFLIC, and VALIC are the Custodians of the Plan investments. Therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment services are included in net appreciation (depreciation) in fair value of investments. Total Plan recordkeeping fees were \$49,565 and \$49,371 for the years ended December 31, 2024 and 2023, respectively.

**Note 10 - Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024 have been incorporated in these financial statements.
