Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AMG National 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AMG National 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of the Plan

The following description of AMG National 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan sponsored by AMG National Corp. AMG National Trust Bank is a participating employer in the Plan. The Plan is sponsored for the benefit of the employees of AMG National Corp. and AMG National Trust Bank (the Companies or Plan Sponsor) who have at least one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). AMG National Corp. is the Plan Administrator. AMG National Trust Bank is the trustee and custodian of the Plan. EPIC Advisors, Inc. serves as the Plan's record keeper.

The Plan was amended on December 31, 2023 to implement SECURE Act and other law changes and to as of January 1, 2024 add service award payments to employees as excluded compensation for Plan purposes, and to allow employees with at least 500 hours of service during the year to participate in the Plan the following year.

Contributions

Participation in the Plan is available to any full-time employee, and eligible part-time employees, of the Companies who are age 21 or older and has completed one month of service. Employees may enter the Plan the first day of the month following one month of service. Plan provisions allow participants to defer up to 50% of their eligible compensation as contributions to the Plan. The Companies' profit-sharing contributions are discretionary as determined by the Companies' Board of Directors. Employees who are employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year are eligible to receive an allocation of discretionary contributions by the Companies. Employee rollover and after-tax (Roth) contributions are also permitted. During any taxable year, participant contributions are subject to a limitation imposed by the Internal Revenue Service.

Participant Investment Account Options

The Plan currently offers a variety of mutual funds as investment options for Plan participants. The Plan also offers one money market fund as an investment option. Each participant has the option of directing his or her contributions into any of the separate investment options and may change the allocation daily.

Each participant's account is credited with the participant's contribution, discretionary employer contributions, and Plan earnings. Each participant's account is charged with an allocation of administrative expenses based on participant, activity, earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings or losses thereon. Vesting in the Companies' discretionary contribution portion of their accounts plus earnings or losses thereon is based on years of continuous service. A participant is fully vested after three years of continuous service. The nonvested balance is forfeited upon termination of service.

Notes Receivable from Participants

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum number of loans outstanding at one time by a participant is two. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence which are repayable over a period not to exceed fifteen years) through payroll withholdings with full or partial prepayments allowed. Interest on the loans is based on 2% above the prime interest rate as published from time to time in *USA Today*.

Payment of Benefits

Upon termination of service, an employee will receive a lump-sum amount equal to the value of his or her account, if it is less than \$7,000. If the account balance exceeds \$7,000 at the time of termination, the employee may receive the value of the vested interest in his or her account as a lump-sum distribution or defer payment until April 1 following the calendar year during which the participant attains age 73. For terminations due to death, employee or their beneficiary may receive the balance in his or her account as a lump-sum distribution. Participants are eligible for benefits under the Plan upon death, disability, or retirement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,248 and \$1,013, respectively. Forfeitures are used to offset Plan expenses or reduce discretionary matching contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income (Loss) Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at year-end. See Note 5 for discussion of fair value measurements of assets and liabilities at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions are recorded in the period that the Participants' payroll deductions are made. Discretionary contributions made by the Companies are recorded on an accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. There are no reserves for potential credit losses at year-end. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. Distributions payable to participants represent benefits approved for payment but not paid at year-end.

Administrative Expenses

Administrative expenses may be paid by the Companies or the Plan (as a reduction in Plan assets) at the Companies' discretion.

Note 3: Certification of Plan Custodian

The Companies have elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AMG National Corp., as Plan Sponsor, has obtained and agreed the following information included in the accompanying financial statements and supplemental schedule, in the process certifying that it is complete and accurate to the best of their knowledge:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits and related disclosures for the year ended December 31, 2024
- Investment information and notes receivable included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

Note 4: Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons. Participants pay loan fees to the Plan, which are then paid to the participating employer. In 2024 these fees totaled \$3,130. The Companies pay additional administrative fees and also provide certain administrative services at no cost to the Plan.

Certain Plan investments are shares of Company stock; therefore, these transactions qualify as party-in-interest transactions. The custodian of the Plan is an affiliate of the Plan Sponsor and therefore also a party-in-interest.

Note 5: Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Mutual Funds (Including Money Market Mutual Fund)

Mutual funds and exchange traded funds are valued at the net asset value (NAV) of shares held by the Plan at year-end and are included in Level 1.

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Mutual Funds classified as Level 2 or Level 3 as of the end of the Plan year.

Fair value determinations for Level 3 measurements of securities are the responsibility of the Plan Sponsor. The Plan Sponsor contracts with a pricing specialist to generate fair value estimates on an annual basis. The Sponsor challenges the reasonableness of the assumptions used and reviews the methodology to ensure the estimated fair value complies with accounting standards generally accepted in the United States.

Note 6: Plan Termination

Although it has not expressed an intention to do so, the Companies have the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any unvested employer contributions.

Note 7: Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan sponsored by AMG National Trust Bank. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
