**Note 1 - Description of the Plan**

The following description of the Ekaterra 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

*General* - The Plan was adopted January 1, 2022. The Plan is a defined contribution plan established by Unilever TEA MSO USA, LLC (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible employees of the Company.

The Plan covers substantially all employees of the Company. There is no eligibility service requirement with the exception of nonelective employer contributions in which the requirement is participants must have completed one year of service with 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

*Plan Administration* - The Plan is administered by Unilever TEA MSO USA LLC (the “Plan Administrator”). The duties of the Plan Administrator are to oversee the operations and administration of the Plan in accordance with the specific terms of the Plan, provide for prudent investment of Plan assets and keeping accurate records and reports. The Plan’s trustee, Fidelity Management Trust Company, (the “Trustee”), is responsible for the custody and management of the Plan’s assets.

*Contributions* - Participating employees and the employer make contributions to the Plan. A participant may make elective contributions (including ROTH), via salary deferrals, of their pretax compensation for the contribution period not to exceed \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants that are age 50 or older may elect to contribute an additional \$7,500 for 2024 and 2023.

Unless an eligible employee affirmatively elects otherwise, the employee's compensation will be reduced by 5% for each payroll period, and that amount will be contributed to the employee's 401(k) account. Unless an eligible employee elects otherwise, annually the deferral contribution will be increased by 1%.

The Company made a non-discretionary matching contribution on behalf of each eligible participant totaling 100% of the first 5% of the amount deferred by the participant for 2024. Additionally, the Company made a discretionary non-elective contribution on behalf of each eligible participant totaling 4% not to exceed 25% of their compensation.

The Plan allows employees who have received distributions from other qualified retirement plans to directly transfer or rollover their previous account balances into segregated "rollover" accounts of the Plan which will be non-forfeitable at all times.

*Investment Options* - Upon enrollment in the Plan, a participant may direct their contributions and any related earnings into any of a large mix of distinct active investment options. Employer matching and profit-sharing contributions are invested in accordance with the investment choices selected by each respective participant.

*Fidelity BrokerageLink Investments Fees* - The Fidelity BrokerageLink investment option allows a participant to establish a brokerage account with Fidelity, which provides the opportunity to select from various financial instruments. While there are no BrokerageLink annual account fees charged to participants, the investment options available through BrokerageLink have associated fees.

**Note 1 - Description of the Plan (Continued)**

Participant Accounts - Each participant's account is credited with the participant's tax-deferred contributions and employer contributions (if any), as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants immediately vest in their contributions to the Plan plus actual earnings thereon. Participants are immediately 100% vested in the matching employer contributions. Vesting in the Company's nonelective employer contributions is based on a 3 year cliff vesting schedule.

Benefit Payments - Upon a participant's termination of service, retirement, full and permanent disability, or death, the Plan will distribute to the participant or his/her designated beneficiary, a lump-sum amount or annuity equal to the vested value of the participant's account balance. Withdrawals from the Plan by active participants are also permitted for specific instances of financial hardship. In-service distributions will only be permitted if the Participant is 100% vested in the source from which the withdrawal is taken.

Forfeitures - Forfeitures may first be used to pay Plan administrative costs and then to reduce the employer's matching contribution to the Plan. During the years ended December 31, 2024 and 2023, forfeitures of \$875 and \$0, respectively were used to pay for Plan administrative expenses. During the years ended December 31, 2024 and 2023 forfeitures were not used to reduce employer matching contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$4,184 and \$4,438, respectively.

ERISA Fee Recapture Account - The Plan Administrator has adopted an ERISA fee recapture account to receive revenue sharing payments and pay administrative expenses. Excess funds within the account after payment of expenses are reallocated to participants as defined in the Plan. For the years ended December 31, 2024 and 2023, the Plan received revenue sharing payments of \$8,591 and \$8,340, respectively. The Plan did not pay administrative expenses out of this account for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, the ERISA fee recapture account balance was \$18,822 and \$9,502, respectively.

Administrative Fees - In addition to the Plan expenses as reported in the accompanying financial statements, the Company absorbed fees of the Plan for the year ended December 31, 2024.

Notes Receivables from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Note 2 - Summary of Significant Accounting Policies**

Basis of Accounting - The Plan's financial statements are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis with dividends being recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments - Benefit payments to participants are recorded when paid.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Recent Accounting Pronouncements - During the year ended December 31, 2024 and through October 15, 2025, there were no new accounting pronouncements issued by the Financial Accounting Standards Board (FASB) that will need to be adopted by the Plan.

**Note 3 - Fair Value Measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- 1) Quoted prices for similar assets or liabilities in active markets
- 2) Quoted prices for identical or similar assets or liabilities in inactive markets
- 3) Inputs other than quoted prices that are observable for the asset or liability
- 4) Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fidelity BrokerageLink investments: for the majority of Fidelity BrokerageLink investments, the Plan receives prices from a nationally recognized pricing service that are based on observable market transactions and includes these estimates in the amount disclosed in Level 1 (Fidelity fund, interest-bearing cash, external fund, unit and common stock).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Related-Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds and Fidelity BrokerageLink investments managed by Fidelity Investments. Fidelity Investments is an affiliate of the trustee and therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these accounts and the underlying investments comprising these accounts are open market transactions at fair market value.

Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan terminating, participants will become 100% vested in their account balances.

**Note 7 - Federal Income Tax Status**

The Company has adopted the Fidelity Management and Research Company Volume Submitter Pre-Approved Defined Contribution Plan (Fidelity Basic Plan Document No. 17 and the Adoption Agreement together comprise the Volume Submitter Defined Contribution Plan). The Internal Revenue Service has issued an opinion letter dated June 30, 2020 stating that the plan is acceptable under section 401(a) of the IRC. The Company is relying on the opinion letter (in accordance with Announcement 2001-77) that the Plan meets the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

It is not possible at this time to reasonably estimate the possible loss or range of loss, if any. The Plan further cautions that it is not possible to list such factors, and one should not consider the identified factors as a complete list of all risks and uncertainties.

**Note 9 – Reportable Transactions**

During the year ended December 31, 2024, there were no reportable transactions, loans in default or uncollectible, investment assets acquired and disposed of within the Plan or non-exempt transactions with parties-in-interest which would require supplemental presentation under United States Department of Labor regulations, except as disclosed in Note 10.

**Note 10 – Prohibited Transactions**

During the years ended December 31, 2024, 2023 and 2022, employee withholdings in the amount of \$2,982,235, \$2,758,380 and \$2,522,268, respectively, were late in being transferred to the Plan. As of report date, the Plan sponsor is planning to enter the Voluntary Fiduciary Correction Program (VFCP) to remit the lost earnings as calculated by using the Department of Labor guidelines for late deposits, to the Plan.

**Note 11 - Subsequent Events**

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
