Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Firetree, Ltd. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Firetree, Ltd. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

Notes To Financial Statements

NOTE A Description of Plan

The following description of Firetree, Ltd. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution plan covering substantially all employees who are 18 years of age or older, with six months of service and employed on a full-time basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year a participant may elect to make salary deferral contributions equal to a percentage of pretax annual compensation subject to the Internal Revenue Code Section 401(g) limits. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions for the plan year ended December 31, 2024 consisted of the following:

The Company will match 100% of the participant contributions but only up to the 2% optional range. The Company has made profit sharing contributions in the past equal to 2% of a participant's gross pay. A participant must complete a year of service during the plan year and be actively employed during the plan year to share in the discretionary profit sharing contribution. Employer contributions for the plan year ended December 31, 2024 consisted of the following:

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contributions and (2) plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. Participants' accounts may be withdrawn upon separation from the Company, death, disability, or retirement (regular age 65).

A participant may request a loan at any time, in accordance with the provisions of the Plan. Hardship distributions are not permitted by the Plan.

NOTE A Continued

Vesting

A participant's salary reduction and rollover accounts are immediately and fully vested. A participant's Company matching and Company profit sharing contribution accounts shall be vested according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan terms range from one to five years or greater than five years for the purchase of a primary residence. Principal and interest is paid ratably through monthly payroll deductions. Notes receivable are stated at their unpaid principal balance plus accrued unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administration of the Plan

The Plan's administration is performed by OneAmerica.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined, represents forfeitures. Net assets available for benefits include approximately \$1,082 and \$3,908 of unallocated forfeitures at December 31, 2024 and 2023, respectively. Forfeitures may be used by the Plan to pay administrative expenses or to reduce employer contributions. During the year ended December 31, 2024, forfeited nonvested accounts of \$21,593 and \$300 were utilized to offset employer contributions and administrative expenses, respectively.

NOTE B Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans and in accordance with the terms of the trust agreement.

NOTE B Continued

Investment Valuation and Income Recognition

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note C).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Contributions Receivable

As of December 31, 2024 and 2023, the Plan had \$169,450 and \$156,337, respectively, in contributions receivable from the employer.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administrative expenses paid by the Plan during 2024 are reported on the accompanying statement of changes in net assets available for benefits and are summarized as follows:

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE C Fully Benefit-Responsive Investment Contracts

The Plan entered into a group annuity contract (the Contract) with American United Life Insurance Company (AUL). The Contract offers a fixed interest investment option (the Fixed Option) through AUL's general account and a number of variable investment options through an AUL separate account.

As described in Note B, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balances at contract value.

Funds allocated to the Fixed Option are placed in the AUL general account where they are invested in accordance with AUL's general account investment policy. The objective of that investment policy is to maximize long-term, risk-adjusted returns. AUL's general account assets are predominately fixed-income investments (bonds, mortgages, and private placements). Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rate is based on the return AUL expects on new investments made by it and held within the AUL general account, and it will always equal or exceed the contractually guaranteed rate. All contributions received during the quarter will earn that declared interest rate until the end of the calendar year next following the current year. Each quarter's contributions and the corresponding interest rate are tracked together administratively in a separate quarterly interest rate pocket (Quarterly Pocket). At the end of the calendar year next following the current year, the Quarterly Pockets established in the current year are converted to an annual interest rate pocket (Annual Pocket). At the beginning of each year, a new interest rate is established and declared for each Annual Pocket. This rate is based on past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments. All benefit-responsive Plan benefit payments (as outlined in the Contract) made prior to contract liquidation are made at book value (principal invested plus interest earned).

Amounts allocated to a variable investment account within an AUL separate account are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received by AUL and the daily equivalent or any fee charged by AUL pursuant to the Contract. The value of each accumulation unit is published each business day. Each investment account is invested by AUL exclusively in shares of a specific mutual fund or other investment entities as directed by the contract holder and/or the participant.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) a full or partial plan termination, (b) the insolvency of the plan sponsor, or (c) aggregate terminations in any contract year exceed 20% of the full contract value as determined on the first day of that contract year. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

NOTE D Information Prepared and Certified By The Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate.

NOTE E Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE F Tax Status

The Internal Revenue Service has stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan, itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits

NOTE H Party-In-Interest Transactions

The Plan has not considered employer contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions. Certain plan investments are managed by AUL. AUL is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Revenue Sharing Formula:

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.
