Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Club Cal Neva 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Club Cal Neva 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Plan Description

The following description of the Club Cal Neva 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* –The Plan covers substantially all full-time employees of Sierra Development Company d/b/a Club Cal Neva (the "Company"). The Plan was adopted effective January 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Eligibility* – The Plan substantially covers all employees who have completed six months of service and are age eighteen or older. Participants are eligible for profit-sharing contributions after one year of service and 1,000 hours of service and must be employed on the last day of the Plan year. Participants are automatically enrolled into the Plan on the first day of the following month after completing the age and service requirements.
- c) *Employee Contributions* – Participants may elect to contribute up to 70 percent of either pre-tax compensation, after-tax compensation (Roth), or any combination of both types of contribution as defined in the Plan, up to a maximum of \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans.

The Plan includes an automatic deferral provision whereby 1 percent of annual compensation is automatically deducted and invested on behalf of the participant unless the participant elects a different deferral percentage, including zero. The automatic deferral provision includes a 1 percent increase each year to a maximum automatic deferral of 3 percent.

- d) *Employer Contributions* – Discretionary employer-provided matching contribution may be made to the Plan. The match, if any, will be a specific percentage of the elective contributions the employee makes to the Plan. The Company will determine the amount of the discretionary contribution, if any are made to the Plan each year. No such contributions were made for the year ended December 31, 2024 and 2023.

Discretionary employer-provided non-elective contributions (profit-sharing contributions) may also be made to the Plan. Allocations of these contributions to participants will be made in accordance with the formula selected by the Company as defined in the Plan. No such contributions were made for the year ended December 31, 2024 and 2023.

- e) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, if not paid by the Company. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- f) *Vesting* – Participants are vested immediately in their contributions, plus actual earnings thereon. Employer contributions are 20 percent vested after one year of service, and 20 percent for each additional year of service. Participants are fully vested after 5 years of service, or if they become disabled or die while employed with the Company.

In order to be credited with a year of service for vesting purposes, employees must complete at least 1,000 hours of service during the 12 months anniversary of the employee’s hire date.

- g) *Investment options* – Participants direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or internet.
- h) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant’s account and bear interest at the prime interest rate plus 2 percent. Principal and interest are paid ratably through payroll deductions.

- i) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may receive the vested accumulated value of their account in a lump sum distribution. Installment payments are made for required minimum distributions. Qualifications to receive a hardship distribution are outlined in the Plan provisions.
- j) *Forfeited accounts* – Forfeitures of nonvested balances may be used to pay plan expenses or reduce employer contributions. At December 31, 2024 and 2023, the forfeiture account balance was \$14,410 and \$20,027, respectively. During 2024 and 2023, forfeitures of \$8,500 and \$4,000, respectively were used to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Accordingly, actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation / depreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the audit report was issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits (with the exception of the Stable Value Compass Account, reported at contract value). The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan’s mutual funds are publicly traded and included in Level 1 of the fair value hierarchy.

Pooled Separate Accounts (PSAs) – PSA’s are privately managed through investment companies and are not publicly quoted. The Plan holds a PSA holding the Invesco Stable Value Trust, held through sub-accounts of an insurance company. The PSAs are valued using net asset value (“NAV”) as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments. The redemption notice period is daily.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions

Transamerica Financial Life Insurance Company (Transamerica) is the recordkeeper of the Plan and is also the trustee of the Plan's assets. Therefore, transactions between the Plan and Transamerica qualify as party-in-interest transactions.

Participant loan transactions are considered to be party-in-interest transactions because they are transacted with Plan participants.

8. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will immediately become 100% vested in their account.

9. Income Tax Status

Effective January 1, 2018, the Plan adopted a non-standardized form of a prototype plan. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
