Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Santé Group Companies 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A – DESCRIPTION OF THE PLAN

The following description of the Santé Group Companies 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all employees of The Affiliated Santé Group, The Rock Creek Foundation for Mental Health, Inc., Chester County Respite Network, LLC and PsyComp Care, t/a Santé Medical Associates (collectively, the Sponsor). There is no minimum age or service requirement for participation in the employee elective deferral contributions portion of the Plan. Employees are eligible to receive the employer matching contribution after reaching the age of 18 and obtaining 1,000 service hours. Effective October 1, 2024, employees are eligible to receive the employer nonelective contribution after reaching the age of 18 and completing 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The Sponsor's management, in conjunction with the Plan's advisors, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

2. Contributions

Each year, participants may contribute a minimum of \$200 up to the maximum allowed by the applicable laws. The contribution limit for 2024 under the Internal Revenue Code (IRC) was \$23,000 for participants under age 50 plus a \$7,500 catch up contribution for those aged 50 or older. Effective October 1, 2024, Roth in-plan conversions are also permitted. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor may elect to make discretionary matching contributions equal to 50% of participants' elective deferrals to a maximum of 4% of eligible wages. Effective October 1, 2024, the Sponsor may also make discretionary nonelective contributions equal to a uniform percentage of the participant's plan compensation. The discretionary matching contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. Contributions from participants and the matching contributions from the employer are recorded in the year in which the contributions are withheld from compensation.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and the Sponsor's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A – DESCRIPTION OF THE PLAN – Continued

4. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. Participants are vested 20% after two years of service, 40% after three years of service, 60% after four years of service and 100% after five years of service. Subsequent to year end, vesting was changed to 100% immediately unless a participant does not have an hour of service.

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 4.50%, based on comparable market rates offered by lending institutions for similar loans. Principal and interest is paid ratably through payroll deductions or directly by the participant.

6. Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary may elect to receive an annuity or a lump-sum amount equal to the value of the participant's vested interest in the participant's account. Hardship withdrawals are permitted by the Plan.

7. Forfeited Accounts

Forfeited non-vested accounts totaled \$8,302 and \$11,341 as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer matching contributions or pay administrative expenses. Also, in 2024, administrative expenses of \$-0- and employer matching contributions of \$18,959 were paid from forfeited non-vested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

3. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance companies. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

5. Contributions

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

6. Payment of Benefits

Benefits are recorded when paid.

7. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

8. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. See Note A.

NOTE C – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIANS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company (Lincoln) and American United Life Insurance Company (AUL), the custodians of the Plan.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets:
- Quoted prices for identical or similar assets or liabilities in inactive markets:
- Inputs other than quoted prices that are observable for the asset or liability:
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) as provided by the custodians and published daily. NAV is based on the fair values of the underlying mutual funds as determined by quoted market prices, less any liabilities.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan entered into traditional fully benefit-responsive guaranteed investment contracts with Lincoln and AUL totaling \$120,733 and \$123,058 as of December 31, 2024 and 2023, respectively. Lincoln and AUL maintain the contributions in their general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

Under the terms of the Lincoln contracts, Lincoln guarantees that for participants with Multifund Select contracts, interest on amounts allocated to the Fixed Account will be credited at an annual rate that is at least equal to 1.75% for years one through ten, and 3.0% for years eleven and later. For participants with Multifund Fixed contracts, interest on amounts allocated to the Fixed Account will be credited at an annual rate that is at least equal to 4.50% for years one through five, 4.00% for years six through ten, and 3.50% for years eleven and later. Interest is credited each business day at a crediting interest rate that is declared on a quarterly basis. The actual crediting interest rates were lower than the guaranteed rates so the guaranteed rates were applied. Under the terms of the AUL contract, interest is credited each business day at a crediting interest rate that is declared on an annual basis. The actual crediting interest rate was 1.25% and 1.75% for the years ended December 31, 2024 and 2023, respectively.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES – Continued

These contracts meet the fully benefit-responsive investment criteria and therefore are reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive guaranteed investment contracts because that is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln and AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events may include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

There are no events that would allow the issuers to terminate the contracts with the Plan and settle at amounts different from contract value. The guaranteed investment contracts permit the insurance companies to terminate individual participant accounts under the contracts in certain circumstances, but not to terminate the agreements prior to their maturity dates. The Lincoln contract expires on June 13, 2034 and the AUL contract does not have a defined maturity date.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their financial obligations may be affected by future economic and regulatory developments.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Lincoln and AUL. Lincoln and AUL are custodians for the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than as a direct payment. Total fees paid directly by the Plan were \$16,265 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – TAX STATUS

403(b) plans currently are not required to submit plans to the Internal Revenue Service (IRS) for determination. However, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2023, the Sponsor failed to remit in a timely manner certain remittances withheld from participants' paychecks for loan repayments and deferrals to the Plan aggregating \$20,180. Lost earnings on these deposits were calculated and remitted to Plan.
