Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Complete Discovery Source 401(k) Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2004. The Plan is a defined contribution plan with salary reduction features covering employees of Complete Discovery Source, Inc. (“CDS”) and its affiliates, Metropolitan Office & Computer Supplies, Inc. (“MOCS”) and Metropolitan Duplicating & Imaging Inc. (“MDI”) (collectively the “Sponsor”) who have satisfied eligibility requirements. In July 2018, all employees of MDI were transferred to CDS and MDI is in the process of winding down and will be subsequently formally dissolved. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Sponsor President and Trustee/Plan Sponsor Controller are responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Participants may contribute a portion of their annual compensation, in accordance with the provisions defined by the Plan on a tax deferred basis and limited to the maximum allowable in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, participants may make rollover and transfer contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2016, participants may stop an election to contribute at any time.

Effective January 1, 2014, the Plan Sponsor adopted safe harbor provisions, whereby the Plan Sponsor will make a matching contribution to eligible non-highly compensated participants, determined by their rate of elective deferrals (including catch-up contributions) up to 3% of eligible compensation and an additional 50% of the elective deferrals that exceed 3% of eligible compensation not to exceed 5%.

The Plan provides for discretionary employer profit sharing contributions. There were no discretionary profit sharing contributions in 2024.

Participant Accounts

Separate accounts are established and maintained under the Plan for each participant.

Each participant's account is credited with the participant's contribution, the Sponsor's safe harbor contribution, the Sponsor's discretionary profit sharing contribution, if any, and an allocation of the Plan earnings and charged with an allocation of Plan losses and administrative expenses.

Eligibility and Vesting

An employee is eligible to participate in the plan upon attainment of the age of 21 years and after completing 3 consecutive months of eligibility service (at least 250 hours in a 3 month period). Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Participants who have completed one year of eligibility service and 1,000 hours within the eligibility computation period are eligible for employer safe harbor matching contributions, which vest immediately. Participants who have completed 1,000 hours of service during the plan year and are employed by the Sponsor on the last day of the plan year are eligible for employer profit sharing contributions, which vest on a 2-6 year grading schedule.

Notes Receivable from Participants

Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one half of their account balance. The term of each loan may generally not exceed five years, unless the proceeds of the loan are to be used to acquire a principal dwelling unit which has a maximum loan term of 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined at the time of the loan application. Loans outstanding during the year had interest rates ranging from 4.25% to 9.5%, respectively, per annum. Loan payments are generally made through payroll deductions or directly from the borrower and any expenses related to loan set-up and maintenance are charged directly against the appropriate participant's account.

Payment of Benefits

Upon termination of service or disability, a participant may receive a lump sum distribution or rollover into a qualified plan, or combination thereof, in the amount of the participant's account greater than \$7,000. If the participant's account is less than \$7,000, the participant's distribution automatically shall be made in the form of a lump sum payment as soon as practical. In-service withdrawals are permitted once a participant has attained age 59 1/2. No installment payments are allowed.

Administrative Expenses

The Plan permits the payment of administrative expenses to be made from the Plan's assets. However, substantially all of the administrative expenses of the Plan are paid by the Sponsor without charge to the Plan.

Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, see next note). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor President and the Trustee/Plan Sponsor Controller determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit Responsive Investment Contract

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of net assets available for benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan and investment expenses are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - CERTAIN INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, who utilizes Transamerica as their recordkeeper. Transamerica provides statements related to the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at net asset value at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

In July 2022, the Plan entered into an investment contract related option, the Transamerica Stable Value Option, issued by Transamerica Financial Life Insurance Company ("TFLIC"), totaling \$1,458,751 for 2024 and \$1,342,973 for 2023. The contract underlying this investment option is considered to be fully benefit-responsive and therefore it is reported at contract value, which approximates fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest, less participant withdrawals, and administrative expenses.

TFLIC is contractually obligated to repay the principal and interest at a specified crediting interest rate that is guaranteed for six months. There is no minimum crediting interest rate. The crediting interest rate to participants for the contract as of December 31, 2024 was 1.65%. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on TFLIC's ability to meet its financial obligations. TFLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with TFLIC. A market value adjustment may apply to withdrawals, other than benefits as defined in the contract, at the request of the Plan. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Employer

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the TFLIC and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Transamerica is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments as well as administrative expenses.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA and the terms of the Plan. In the event of termination of the Plan, participants' accounts remain fully vested and non-forfeitable. The Sponsor determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

NOTE 8 - TAX STATUS

Effective July 1, 2022, the Plan adopted a pre-approved plan with Transamerica. The IRS has determined and informed the Plan administrator, by a letter dated June 30, 2020, that the form of the pre-approved plan is acceptable under the applicable sections of the IRC. The plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the pre-approved plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. However, the Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
