1. DESCRIPTION OF THE PLAN

The following description of Keystone Peer Review Organization, Inc. 401(k) Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger

Effective January 1, 2024, the Plan merged into the Acentra Health Retirement Plan. All assets of the Plan became assets of the Acentra Health Retirement Plan on January 1, 2024.

General

The Plan is a defined contribution plan covering substantially all employees of Keystone Peer Review Organization, Inc. (the Company or Plan Sponsor) who have completed thirty consecutive days of service and attained the age of eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Plan management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Contributions

Each year, participants may contribute from 1 percent to 60 percent of annual compensation, as defined in the Plan agreement, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may choose between two types of elective deferral options: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes 100 percent of the first 4 percent of compensation that a participant contributes to the Plan to qualify as a safe harbor plan. Eligible employees may receive contributions under the McNamara-O'Hara Service Contract Act (SCA contributions) after completing one hour of service on a project that is subject to SCA or similar state prevailing wage law. Prior to January 1, 2016, the Plan had a discretionary matching contribution provision. It was eliminated effective January 1, 2016, when the Plan's safe harbor provision was changed from 3 percent to an enhanced safe harbor match contribution.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Due to the plan merger described above, there were no contributions to the Plan for the day ending January 1, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor contributions, and Company SCA contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Due to the plan merger described above, there was no participant account activity, other than the transfer of assets to the Acentra Health Retirement Plan, for the day ending January 1, 2024.

Vesting

Participants are vested immediately in their contributions, Company safe harbor contributions, and Company SCA contributions plus actual earnings thereon. Vesting in the Company discretionary matching portion of their accounts plus earnings thereon is determined as follows:

Regardless of the vesting schedule, participants become fully vested upon death, disability, or retirement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by their highest outstanding loan balance on a Plan loan during the preceding 12 months. Loan terms may range from one to five years, or longer for a loan used to acquire a principal residence. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1.5 percent above the prime rate, on the date of distribution, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals. On termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The Plan may liquidate a participant's account if the participant has terminated and his or her account balance is below \$5,000. Withdrawals from the Plan may also be made upon circumstances of financial hardship or after reaching age 59 1/2 in accordance with provisions specified in the Plan agreement.

Due to the plan merger described above, there were no benefit payments for the day ending January 1, 2024.

Forfeited Accounts

At December 31, 2023, forfeited non-vested accounts totaled \$2,926, respectively. These accounts may be used to pay Plan administrative expenses and/or reduce future Company contributions.

Due to the plan merger described above, there were no forfeitures used for the day ending January 1, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement

date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

Due to the plan merger described in Note 1, there was no investment income for the day ending January 1, 2024.

Contributions

Contributions from Plan participants, Company safe harbor contributions, and Company SCA contributions are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 . If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, and a distributable event has occurred, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payments of benefits are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. INVESTMENTS

Voya Retirement Insurance and Annuity Company (Voya) held the funds for the Plan and maintained an individual account for each participant.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued using the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract (GIC) with Voya. The total contract value of the GIC was \$1,528,134 at December 31, 2023. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to

the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the rate specified in the contract. The crediting rate is reviewed on an annual basis for resetting.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan agreements (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

There is no maturity date on the contract.

7. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan offered pooled separate accounts and a guaranteed investment contract managed by Voya. Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules. All other transactions that may be considered party in interest transactions relate to normal Plan management and administrative services, and the related payment of fees.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

As described in Note 1, the Plan merged into the Acentra Health Retirement Plan effective January 1, 2024.

9. TAX STATUS

The Company has adopted a pre-approved plan provided by Lifestyle Retirement Company. The pre-approved plan received an opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. In addition, the opinion letter stated that an employer who adopts the pre-approved plan may rely on the opinion letter with respect to the qualification of its own plan under the IRC. Although the Plan has been amended since the pre-approved plan received the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
