To the Plan Administrators of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the American Textile Company, Inc. 401(k) Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of the American Textile Company, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was established January 1, 1985.

General

The Plan is a defined contribution plan established to provide retirement benefits for substantially all eligible employees of American Textile Company, Inc. ("Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

An employee becomes eligible to participate in the Plan for the purpose of salary reduction and employer match after completing sixty days of employment. Employees may choose to increase (subject to the limitations discussed below), decrease, or stop contributions by filing the appropriate form with the Plan administrator. In addition, unless and until an eligible employee files a contrary election either to contribute at a rate other than 3% or to not participate in the Plan, the eligible employee is automatically enrolled into the Plan. Participants who are automatically enrolled into the Plan contribute 3% of their compensation into a Vanguard Target Retirement Fund commensurate with their projected retirement date. The deferral rate for participants that are automatically enrolled into the Plan is increased by 1% each year until a deferral rate of 5% is achieved.

Contributions

Participating eligible employees may elect to contribute up to 100% of their annual compensation, as defined in the Plan and subject to Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 by the end of the Plan year may also contribute catch-up contributions (limited to \$7,500 for both 2024 and 2023). Deferred salary contributions are reported as participant deferrals in the financial statements. In addition, participants who receive qualified distributions from another qualified plan may be able to rollover such distributions into the Plan.

Eligible participants receive Company matching contributions of 50% of the first 5% of the participant deferrals, which are reported as employer contributions in the financial statements.

Participants direct all contributions into various investment options offered by the Plan as discussed in Note 2.

NOTE 1 - PLAN DESCRIPTION (continued)

Participant accounts

Each participant's account is credited with the participant's deferred salary contributions and allocations of the Company's matching contributions and Plan earnings based on the investment options elected by the participant. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become 20% vested in the Company's matching contributions upon the completion of two years of service. Vesting increases 20% annually until 100% vesting occurs.

Administrative expenses

Administrative expenses that are not paid directly by the Company are paid out of Plan assets and reflected as administrative expenses in the statements of changes in net assets available for benefits.

Payment of benefits

Participants are entitled to withdraw any portion of their vested account prior to retirement due to disability, termination of employment, death, or hardship. Upon reaching normal retirement age, participants may elect distributions from their accounts via lump-sum cash payments or various installment methods.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

Loans

The Plan does not permit loans to participants.

Forfeited accounts

Forfeitures may be applied as reductions of Company matching contributions or administrative expenses. As of December 31, 2024 and 2023, there were \$20,049 and \$4,052, respectively, of non-vested forfeited amounts. During 2024 and 2023, employer contributions were reduced by \$162,378 and \$81,917, respectively, from previously forfeited non-vested accounts. Forfeited non-vested accounts were not used to reduce administrative expenses during 2024 or 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment valuation and income recognition

The Plan’s mutual fund investments are stated at fair value, determined by quoted market prices. The Plan’s investment in a pooled separate account is tracked by participation units in sub-accounts offered by Transamerica Life Insurance Company (“Transamerica”), with each sub-account representing a mutual fund investment option. Each sub-account holds shares of a single underlying mutual fund, and the sub-accounts reinvest any mutual fund distributions received into additional shares of the underlying mutual fund. Thus, no distributions of dividends or interest are made to the participation unit holders. The participation unit values are adjusted daily by the custodian to reflect investment results based on the quoted market prices of the underlying mutual funds for the sub-accounts. The Plan’s investment in the C.M. Life Insurance Company Pension Series Universal Life is presented at its cash surrender value as determined by Mass Mutual Insurance Company.

Investment transactions are accounted for on the trade date. Interest income is recorded as earned. All realized and unrealized gains and losses on investments recorded at fair value are included in net appreciation in fair value of investments reported within the statements of changes in net assets available for benefits.

The Plan provides for investment options that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of benefits

Benefits paid to participants are recorded when applications for withdrawals are processed and paid.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 14, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Plan is operating under a prototype non-standardized defined contribution pre-approved plan of Transamerica Retirement Solutions LLC. The most recent opinion letter for the prototype non-standardized defined contribution pre-approved plan is dated June 30, 2020. In this letter, the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, is in compliance with the applicable requirements of the IRC. Although amendments to the Plan have been made since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

In accordance with U.S. GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for periods prior to 2021.

NOTE 4 - INVESTMENTS

Fair value measurements

Market price observability is affected by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. Investments measured and reported at fair value are classified and disclosed in one of the following categories based on the extent of market price observability.

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The Plan’s investments in mutual funds and an interest bearing cash account are classified as Level I.

Level II – Pricing inputs are other than quoted market prices included in Level I, however are observable, either directly or indirectly for the investment. The Plan’s investment in a pooled separate account is classified as Level II.

Level III – Pricing inputs are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. The Plan’s investment in an insurance policy is classified as Level III.

Life Insurance Company Pension Series Universal Life, were held under an arrangement with Transamerica Trust Company.

The investment information contained in the financial statements and Schedule of Assets Held at End of Year, with the exception of the C.M. Life Insurance Company Pension Series Universal Life, has been certified as accurate and complete by Reliance Trust Company and Transamerica Trust Company, the custodians of the Plan's assets, for the respective periods, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA.

NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan has contracted with a related party to provide discretionary investment management services to the Plan. Fees paid by the Plan for these services amounted to \$56,062 and \$48,717 for the years ended December 31, 2024 and 2023, respectively. The Plan's investment in the interest bearing cash account is managed by Transamerica Trust Company and therefore qualifies as a party-in-interest transaction. The Plan also pays administrative expenses and fees to Transamerica that qualify as party-in-interest transactions. These party-in-interest transactions are not deemed prohibited because they are covered by statutory and administrative exemptions from the IRC and the rules of prohibited transactions of ERISA.

NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company identified \$26,030 of participant contributions that were remitted to the Plan in an untimely manner during the year ended December 31, 2024. As of December 31, 2024, the Plan was owed lost earnings totaling \$3,869 related to 2024 ultimately remittances, which is recorded within employer contributions receivable on the 2024 statement of net assets available for benefits. During 2025, the Company reimbursed the Plan on behalf of the affected participants for the lost earnings related to these late contributions and corrected these prohibited transactions outside of the Voluntary Fiduciary Correction Program.
