## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
REACH, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the REACH, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

### NOTES TO FINANCIAL STATEMENTS

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of the REACH, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information regarding the Plan's provisions.

##### General

The Plan was established on July 1, 2004, as a defined contribution plan covering employees of REACH, Inc. (the Company) enrolled who are age 21 or older and have 6 months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

Each year, participants may contribute up to the legal limit of pretax annual compensation as defined in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan removed its auto-enrollment provision effective March 1, 2021. The Company contributes 100% of the first 3% of base compensation that an eligible participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the discretion of the Company's board of directors. The Company's profit-sharing contributions to the Plan are allocated to all eligible participants based on the participant's earnings. An employee hired January 1, 2022 and thereafter will become eligible for matching and profit-sharing contributions after they have satisfied the attainment of age 21 and completion of 6 months of service.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contribution and (2) Plan earnings. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Distributions from the Plan are made when a participant retires, dies (in which case, payment shall be made to his or her beneficiary, or if none, his or her legal representatives), or otherwise terminates employment with the Company. Hardship withdrawals are permitted under certain circumstances.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon, while vesting in the Company's matching and profit-sharing contribution is based on years of credited service. A participant is 100% vested after four years of credited service.

##### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive benefits in various methods. Participants should consult the Plan agreement for detailed information concerning distribution options.

##### Forfeited Accounts

At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$17,681 and \$14,708, respectively. Forfeited accounts will first be used to reduce Plan expenses and the remainder will be used to reduce employer contributions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the Guaranteed Investment Contract account which is valued at amortized cost based on participant contributions plus accrued interest. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the cash basis. Net change in the fair value of investments includes the Plan's gains and losses on investments bought, and sold, as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain administration items, including notes receivable from participants, are charged directly to the participant's account, and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts in the financial statements and the accompanying notes. Actual results may vary from these estimates.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Date of Subsequent Review

Management has evaluated subsequent events through the date of the Independent Auditor's Report, which is commensurate with the date which the financial statements were available to be issued.

**NOTE 3 – GUARANTEED INVESTMENT CONTRACT**

The Plan has entered into a fully benefit-responsive investment contract with Standard Insurance Company (Standard) totaling \$255,221 and \$259,009 as of December 31, 2024 and 2023, respectively. Standard maintains the contributions in its general account. The account is

credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer, Standard, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit Standard to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or delegation of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan Administrator does not believe that the occurrence of any such events is probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **NOTE 4 – FAIR VALUE MEASUREMENT**

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure*, defines fair value as the exchange price that would be received on the measurement date to sell an asset or the price paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. FASB ASC 820 also establishes a three-level fair value hierarchy that describes the inputs that are used to measure assets and liabilities. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan can access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets in active markets;
  - Quoted prices for identical or similar assets in inactive markets;
  - Inputs other than quoted prices that are observable for the asset;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Investments in the pooled separate account are valued at the Net Asset Value (NAV) of shares held by the Plan at year end. The NAV is based on quoted prices of the underlying assets owned by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – INTERNAL REVENUE SERVICE STATUS**

The prototype Company has obtained an opinion letter dated March 31, 2014, in which the IRS stated that the prototype Plan document followed applicable requirements under section 401 of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the prototype Plan. The Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations preceding the three-year statute of limitations.

**NOTE 6 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974. Investments held at

December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedule, was obtained, or derived from information supplied to the Plan Administrator and certified as complete and accurate by Standard, the certifying custodian of the Plan.

**NOTE 7 – TRANSACTIONS WITH RELATED PARTIES OR PARTIES IN INTEREST**

Certain Plan investments are in shares of mutual funds and a guaranteed annuity contract managed by Standard. Standard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$5,115 for the year ended December 31, 2024. As discussed in Note 1, Plan expenses were in part reduced by forfeited, non-vested accounts.

**NOTE 8 – RISKS AND UNCERTAINTIES**

Investment Risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – NONEXEMPT PROHIBITED TRANSACTIONS**

During 2024, the Plan's management determined that certain elective deferrals withheld from employees' payroll were not remitted to the Plan by the Company within the time period required by the Department of Labor. The Company determined the lost earnings of these deposits, and such earnings were deposited to the Plan in 2025. These transactions constitute prohibited transactions as defined by ERISA.

**NOTE 10 – SECURE 2.0**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.
