

Note A. Description of the Plan

The following description of the Arquitectonica International Corporation (“Company”) 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of the Company, and its participating affiliates, who have satisfied three months of service and are age twenty-one or older. Upon death or disability, the accrued benefits of the participants will be paid to the beneficiaries as designated by the participants.

John Hancock Life Insurance Company U.S.A. (“John Hancock”) is the custodian of the Plan. John Hancock is also the record keeper of the Plan. Definiti is the Third Party Administrator (“TPA”).

Management of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is also intended as a plan described in Section 401(k) of ERISA.

Investment Options

Upon enrollment in the Plan, a participant may direct elective deferrals into various investment options provided by the Plan. All investments are participant-directed.

Contributions

Each year, participants may make elected deferrals up to one hundred percent (100%) of their pretax annual compensation and bonus, subject to Internal Revenue Service limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers thirty-five (35) mutual funds as investment options for participants. The employer matching contribution is discretionary. During 2024 and 2023, the Company contributed 50% of the first 5% of base compensation that a participant contributed to the Plan. Additional amounts may be contributed at the option of the Company’s board of directors.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocation of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and employer contributions is based on years of continuous service. On January 1, 2014 the Company changed their vesting schedule from participants being immediately fully vested in employer match and profit-sharing contributions to a 5-year graded vesting schedule.

Participants hired prior to January 1, 2014 are immediately fully vested in all sources. Participants hired on or after January 1, 2014, are subject to a 5-year graded vesting schedule. Prior to the five years of service, a participant is entitled only to the Company's matching and employer contributions in accordance with the following schedule:

Less than one year of service	0%
After one year of service	20%
After two years of service	40%
After three years of service	60%
After four years of service	80%
After five years of service	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. To receive a participant loan, a participant must sign a promissory note along with a pledge or assignment of the portion of their account balance to be used as security for the loan. The loans bear interest at 2% above the prime interest rate, which was commensurate with local prevailing rates at the time the loans were initiated. Periodic repayments are required for the participant loans and must be payable generally within five (5) years, or ten (10) years for the purchase of a primary residence. Principal and interest loan repayments are made through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a specified period not to exceed the life or life expectancy of the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. All amounts allocated to participants who elected to withdraw from the Plan as of December 31, 2024 and 2023 were paid prior to year-end.

Forfeitures

Forfeitures of unvested employer contributions and matching from terminated participant accounts are used to first pay Plan expenses and then to offset future employer contributions and matching contributions. The typical use of forfeitures in the Plan is to allocate as additional contributions. Participant forfeitures for the years ended December 31, 2024 and 2023 totaled \$7,580 and \$13,553, respectively. During 2024 and 2023, no employer contributions were reduced from forfeited unvested accounts.

Note B. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

Cash represents forfeitures on deposit in the Plan's interest-bearing cash account. The amounts on deposit are not insured by the Federal Deposit Insurance Corporation. The Plan did not have a cash account balance as of December 31, 2024. The balance of the Plan's cash account as of December 31, 2023 totaled \$15,503.

Investment Valuation and Income Recognition

All investments in mutual funds are recorded at fair value in these financial statements, as prescribed by Accounting Standards Codification No. 820, Fair Value Measurements, (“ASC 820”). ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Additionally, ASC 820 establishes a framework for measuring fair value and expands disclosures about assets and liabilities measured at fair value. For information related to the Plan’s valuation methodologies under ASC 820, see Note D of these financial statements.

The Plan presents, in the statement of changes in net assets available for benefits net appreciation in the fair value of its investments, which consist of realized gains or losses, represented as an excess (shortfall) over market values at the beginning of the year, and unrealized appreciation (depreciation) on investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Excess Contributions

During 2024 and 2023, there were excess employee contributions of \$65,180 and \$120,344, respectively.

Payments of Benefits

Benefits are recorded when payment is made to the participant or beneficiary.

Note C. Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the custodian for the Plan, has certified as to the completeness and accuracy of all the investments and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

Note D. Fair Value Measurements

The Financial Accounting Standard Board Accounting Standards Codification provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical unrestricted assets or liabilities in active markets that the Plan has the ability to access. An active market for the assets or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded and have readily determinable fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E. Related Party and Party-in-Interest Transactions

Certain plan investment options include mutual funds managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, the Plan paid \$136,188 and \$102,504, respectively, in administrative expenses, of which approximately \$5,363 and \$4,842, were for recordkeeping and information management services, respectively. The Plan issues loans to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in interest transactions.

Note F. Plan Amendment or Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The employer has the right to amend the Plan at any time.

Note H. Tax Status

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC, and that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements, or that its impact, if any, would materially affect net assets available for distribution. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

Note I. Contingencies

There were no unusual or infrequent events or transactions occurring subsequent to the balance sheet date that might significantly affect the usefulness of the financial statements in assessing the Plan's present and future ability to pay benefits.

Note J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the financial statements. During the years ended December 31, 2024 and 2023, the fair value of investments appreciated in value by \$2,069,769 and \$2,452,846, respectively, due to market volatility related to economic conditions.

The Plan provides investment options that hold securities of foreign companies, which may involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Note K. Subsequent Events

For the year ended December 31, 2024, Plan management evaluated subsequent events for potential recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
