## Notes to the Financial Statements

### **Note A - Description of Plan**

The following description of the Uchiyama Manufacturing America LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees of the Uchiyama Manufacturing America LLC and Uchiyama Marketing and Development America LLC (Companies) who, effective March 18, 2024, are age 18 or older. Prior to March 18, 2024, employees who were age 21 or older were eligible to participate in the Plan. The Plan is subject to the provisions of ERISA. The Board of Directors is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

#### Contributions

Effective March 18, 2024, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Prior to March 18, 2024, participants could contribute up to 15% of pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make matching contributions on behalf of participants who have at least one year of service. Effective March 18, 2024, matching contributions are made based on a discretionary percentage of a participant's elective deferrals using a tiered system. The tiers currently are 100% of the first 2% of base compensation, plus 50% of the next 2% of base compensation, plus 25% of the next 4% of base compensation. Prior to March 18, 2024, the Companies contributed 25% of the first 8% of base compensation. The Companies may also make discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Companies' matching contributions, as well as allocations of any profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

### Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals and, effective March 18, 2024, in-service distributions to participants who have attained age 59 ½, are allowed by the Plan in accordance with Plan provisions and Internal Revenue Service Regulations.

### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,505 and \$1,590, respectively. These accounts may be used to reduce future employer contributions or pay Plan expenses. No forfeitures were used during 2024 or 2023.

## **Note B - Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from Plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### **Note C – Certified Investments**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and cash held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company and John Hancock Trust Company LLC, which are qualified institutions. ### **Note D – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Stable Value Fund:* Valued at the net asset value ("NAV") of units of a fully benefit-responsive investment contract. The NAV, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The NAV is based on the contract value of the underlying investment assets, less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the issuer requires at least 60 days notification or order to ensure that securities liquidations will be carried out in an orderly business manner.

### **Note E – Related-Party Transactions and Party in Interest Transactions**

Effective March 13, 2024, certain Plan investments are held by John Hancock Trust Company LLC, which serve as the nondiscretionary trustee of the Plan; therefore, these transactions qualify as party in interest transactions.

Prior to March 13, 2024, certain Plan investments were held by Mid Atlantic Trust Company which served as the nondiscretionary trustees of the Plan; therefore, these transactions qualify as party in interest transactions. Also prior to March 13, 2024, the Plan received revenue from mutual fund service providers each month as part of a Master Plan Services Agreement (MSA). This revenue was used to offset amounts owed to AT Retirement Services, LLC (ATR) and Fund Direct Advisors, Inc. for certain administrative and investment services that were provided to the Plan. Income received by the Plan related to the revenue sharing agreement during 2024 and 2023 totaled \$5,748 and \$14,544, respectively.

### **Note F – Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## Notes to the Financial Statements

### Note G - Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
