## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AM General LLC—UAW Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and in accumulated plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate to the best of their knowledge and belief.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Merger**

As discussed in Note 1 to the financial statements, the Board of Directors of AM General LLC, the Plan's sponsor, voted on December 4, 2024, to merge the Plan into AM General Hourly Retirement Plan effective December 31, 2024. All plan assets and accumulated plan benefits were transferred to the control of AM General Hourly Retirement Plan on December 31, 2024. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. #### Note 1. Plan Description

The following brief description of AM General LLC - UAW Retirement Income Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General:** The Plan is a defined-benefit plan covering substantially all employees of AM General LLC (the Company) represented by United Auto Workers Union Local No. 555 (the Union). By agreement with the Union dated September 22, 1997, the Company closed its operations at the Indianapolis Stamping and Assembly Plant on October 31, 1997. All employees at the location were terminated in accordance with the agreement, and the Plan was shut off at that point for new participants.

The Plan participates in AM General LLC Retirement Fund Master Trust (the Master Trust), trustee by The Bank of New York Mellon/BNY Mellon, N.A. (Mellon). The Master Trust is a master trust fund for the Plan, the AM General Salaried Retirement Plan, and the AM General Hourly Retirement Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the Internal Revenue Code (IRC).

Effective December 31, 2024, the Company approved the merger of the Plan into AM General Hourly Retirement Plan (the Hourly Plan), with the Hourly Plan remaining as the surviving plan following the merger date. As a result, net assets of approximately \$8,100,000 and accumulated plan benefit obligations totaling approximately \$6,300,000 were transferred into the Hourly Plan on December 31, 2024. Additionally, the Plan was amended to incorporate the provision that the merger does not impact participant benefits.

**Pension benefits:** All Plan participants are entitled to monthly pension benefits beginning at normal retirement age (65) and completing at least five years of service, as defined by the Plan, at which time they are 100% vested in their benefits. Monthly retirement benefits are calculated based upon the number of years of credited service, as defined, earned by the participant and the basic benefit level in effect at the date of retirement.

The basic benefit level is \$25.25 per month for each year of service. The Plan also provides a Special Benefit, as defined, of \$41.10 per month in addition to the other benefits provided by the Plan.

The Plan also permits early retirement, as defined in the Plan document, with pension benefits reduced by a certain amount, dependent on how early benefits commence prior to the normal retirement age. Also, terminated employees with at least five years of service are entitled to a deferred vested benefit. Employees terminating employment prior to rendering five years of service forfeit the right to receive accumulated plan benefits.

If a participant's vested accrued benefit is \$1,000 or less, the benefit is paid in a lump-sum amount as soon as administratively practicable. All other benefits are provided in the form of an annuity, payable monthly.

The Plan provides for monthly benefit payments to a surviving spouse upon the death of an employee eligible for a vested benefit, regardless of the deceased employee's employment status. The monthly benefit to be received by the surviving spouse is generally equal to 60% of the monthly benefit the deceased employee would have received, assuming the employee retired the day before death. The monthly benefit payments commence the day the deceased employee would have been entitled to receive them and shall continue for the remaining life of the surviving spouse.

**Administration of Plan:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid directly by the Company.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets available for benefits and changes therein and the actuarial present value of accumulated plan benefits and changes therein, at the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

**Investment valuation and income recognition:** Investments that are included in the Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by its investment advisors. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Actuarial present value of accumulated plan benefits:** Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the credited service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries who have earned a deferred vested benefit right, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries.

Benefits under the Plan are accumulated based on employee's compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, which would include retirement, death and/or termination of employment, are included to the extent they are deemed attributable to employee service rendered to the valuation date.

#### **Note 2. Significant Accounting Policies (Continued)**

The actuarial present value of accumulated plan benefits is determined by an independent actuary as of December 31, 2024 and 2023, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations were (a) Mercer Industry Longevity Experience Study (MILES) sex-distinct, Auto, Industrial Goods and Transportation table for retirees with blue collar adjustments applied, projected with mortality improvement scale MMP-2021, a Mercer-modified version of MP-2021, (b) retirement age assumptions starting at age 65 and (c) a discount rate, based on a settlement discount rate, of 5.40% for 2024 and 4.90% for 2023. The primary factors in the change in actuarial assumptions reported in the statement of changes in the accumulated plan benefits for the year ended December 31, 2024, was the change in discount rate assumption. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

#### **Note 3. Risks and Uncertainties**

The Plan, through the investment in the Master Trust, invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of assets available for benefits.

Plan contributions are made, when required, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### **Note 4. Information Certified and Provided by Mellon**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements, obtained by management and agreed to or derived from information certified as complete and accurate to the best of their knowledge and belief by Mellon, a qualified institution.

The Plan's interest in the Master Trust at December 31, 2024 and 2023, \$0 and \$8,482,057, respectively, were provided and certified as complete and accurate to the best of their knowledge and belief by Mellon.

Mellon also certified to the completeness and accuracy to the best of their knowledge and belief of the change in the Plan interest in the Master Trust to be \$329,750 for the year ended December 31, 2024.

#### Note 5. Investments Held in the Master Trust and Fair Value Measurements

All of the Plan's investments are included in the investments of the Master Trust, which was established for the investment of assets of the Plan and several other Company-sponsored retirement plans. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by Mellon.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was 0% and approximately 3%, respectively. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon the amount of the time the Plan's assets were invested in the Master Trust.

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Common collective trust funds:** Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not to be used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

In accordance with Subtopic 820-10, investments that are measured at NAV per share have not been classified in the fair value hierarchy.

**Change in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 6. Pension Protection Act

The Pension Protection Act of 2006 (PPA) as amended by the Worker, Retiree and Employer Recovery Act of 2008 (WRERA) imposes certain benefit restrictions for qualified defined benefit plans that do not meet certain funding thresholds. The at-risk status is referred to as the Funding Target Attainment Percentage (FTAP). A plan's funded percentage is referred to as the Adjusted Funding Target Attainment Percentage (AFTAP). The 2024 AFTAP for the Plan is 121.27%. Because the Plan's AFTAP equals or exceeds 80%, the Plan is not subject to any benefit restrictions.

#### Note 7. Funding Policy

The Company sponsors the Plan for their eligible employees, as described in Note 1. It is their policy to contribute an amount which will meet the annual ERISA minimum funding requirement. For the plan year ended December 31, 2024, no contributions were required, and the Company did not contribute to the Plan.

#### Note 8. Related-Party and Party-in-Interest Transactions

As of December 31, 2024 and 2023, \$258,376,037 and \$293,016,603, respectively, of the Master Trust's investments included shares of common collective trusts managed by Mercer, who provides actuarial services and benefit calculations and also serves as the Plan's Investment Advisor. In addition, Mellon, plan trustee, managed \$2,381,513 and \$2,494,333 of the Master Trust's investments at December 31, 2024 and 2023, respectively. Transactions in these funds qualify as party-in-interest transactions. Fees paid by the Plan to its service providers for the year ended December 31, 2024, totaled approximately \$58,400.

#### **Note 9. Income Tax Status**

The Internal Revenue Service has determined and informed the Plan Sponsor, by a letter dated November 21, 2011, that the Plan, as designed, is qualified and the trust established under the Plan is tax-exempt under the appropriate section(s) of the IRC. The Plan Administrator believes the Plan and trust are currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Actuarial methods for funding

#### Asset methods

The asset valuation method is an average of the adjusted market value for each quarter during the last 2 years preceding the valuation date. The adjusted market value is the market value at each determination date adjusted to the valuation date based on actual cash flows and expected interest at the lesser of the expected rate of return and the third segment rate. This amount is adjusted to be no greater than 110% and no less than 90% of the fair market value, as defined in IRC Section 430.

A characteristic of this asset method is that, over time, it is slightly more likely to produce an actuarial value of assets that is less than the market value of assets than an actuarial value that is greater than the market value.

#### Participant methods

Participants or former participants are included or excluded from the valuation as described below:

- **Participants included:** The plan sponsor provided us with data on all participants as of the valuation date.
- **Participants excluded:** No actuarial liability is included for nonvested participants who terminated prior to the valuation date.
- **Insurance contracts:** The plan does not have any insurance contracts.

#### Minimum funding methods

The funding target for minimum funding calculations is computed using the traditional unit credit method of funding. The objective under this method is to fund each participant’s benefits under the plan as they accrue. Thus, the total pension to which each participant is expected to become entitled at retirement is broken down into units, each associated with a year of past or future credited service.

A detailed description of the calculation follows:

- The plan's valuation date is the beginning of the plan year.
- An individual's **funding target** is the present value of future benefits based on credited service and average pay as of the beginning of the plan year, and an individual's **target normal cost** is the present value of the benefit expected to accrue in the plan year. If multiple decrements are used, the funding target and the target normal cost for an individual are the sum of the component funding targets and target normal costs associated with the various anticipated separation dates.
- The plan's **target normal cost** is the sum of the individual target normal costs, and the plan's **funding target** is the sum of the individual funding targets for all participants under the plan.
