NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Retirement Plan for Employees of Whitney M. Young, Jr. Health Center, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, safe harbor, 401(k) plan covering all employees of Whitney M. Young, Jr. Health Center, Inc. (the Company) who meet certain eligibility requirements. VOYA Retirement Insurance and Annuity Company (VOYA) is the record keeper and custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Participants are eligible to make pre-tax or after-tax (Roth) salary deferral contributions to the Plan immediately following their date of hire. Participants may make contributions up to the maximum percentage of compensation and dollar amounts permissible under the Internal Revenue Code (IRC). Leased employees, non-resident aliens, and self-employed individuals are not eligible to participate in the Plan. Employees must be 21 years of age and become eligible for employer contributions at the beginning of the year of the first of the quarter month following 6 months of service.

Participant Contributions

Effective January 1, 2022, Eligible participants are automatically enrolled with a deferral of 2% from the participant's compensation each payroll period with a 2% annual escalation up to 10% unless the participant makes a contrary election. Participants may make contributions in the form of salary reductions up to 100% of their annual compensation, as defined, subject to certain limitations under the terms of the Plan and Internal Revenue Code (IRC). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make long-term service catch-up contributions, subject to certain limitations of the Internal Revenue Code (IRC). Participants have the option to change their deferral percentage or discontinue deferrals at any time. In addition, participants may contribute rollover contributions received from another qualified retirement plan.

Employer Contributions

The Company makes a matching contribution equal to 200% of the first 2% of participant salary deferral contributions. The Company will also make safe harbor contributions equal to 200% of the first 2% of participant salary deferral contributions.

Participant Accounts

Each participant's account is credited with an allocation of (a) the employee's contributions, (b) the Company's contribution, (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. Benefit payments are deducted directly from each participant's account.

Vesting

Participants are immediately vested in all contribution amounts plus actual earnings/losses thereon.

1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

Upon termination of service, a participant or designated beneficiary may elect to receive the value of the participant's vested interest in his or her account as a lump-sum distribution. Upon reaching normal retirement age, a participant or designated beneficiary may elect to receive the value of the participant's vested interest in their account in installments over a specified period of time or in one of the various forms of annuities offered by the Plan. Participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59 ½. Participants may also withdraw any of their rollover contribution balance at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from elective deferral accounts. All hardship withdrawals must comply with specific rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and non-benefit responsible fixed annuity contracts are reported at fair value. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair Value Measurement

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement (Continued)

The fair value hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds. Valued using closing quoted prices in active markets.

Non-benefit responsive fixed annuity contracts. Value is calculated based on discounted cash flows using risk-adjusted discount rates.

The Plan's investment in non-benefit responsive fixed annuity contracts is comprised of guaranteed insurance contracts established between the Plan and the Plan's custodian. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate. Since the agreement or funding agency has the ability to restrict certain transfers and withdrawals, the contract is not considered fully-benefit responsive.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024, the Plan reclassified certain investments as follows:

- Reclassified its common collective trust account previously measured under net asset value to mutual funds classified within fair value hierarchy as Level 1 investment
- Reclassified its fully benefit-responsive guaranteed investment contract, at contract value to non-benefit responsive fixed annuity contracts classified within fair value hierarchy as Level 2 investment

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement (Continued)

The reclassifications above were due to changes in management's assessment and clarification of inputs being more consistent with the definition of each investment's respective measurement guidance under GAAP. There were no changes in the actual inputs utilized to value the above investments and has been reclassified in the prior year to conform to the current year presentation.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The majority of Plan administrative expenses are paid by the Plan. The primary administrative expenses incurred for 2024 and 2023 were investment advisory/management fees and professional fees.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested. All distributions would be made in accordance with any applicable requirements of the ERISA and the IRC.

6. PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

VOYA is the custodian of the Plan's assets. As such, transactions between the custodian and the Plan qualify as party-in-interest transactions.

7. TAX STATUS

The Plan is designed from a prototype plan offered by Datair Employee Benefit Systems, Inc. The Internal Revenue Service has determined and informed Datair Employee Benefit Systems, Inc., by letter dated June 30, 2020, that the written form of the underlying prototype plan document is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for its own determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
