Independent Auditors' Report

To the Administrative Committee of
Complete Care Community Health Center, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Complete Care Community Health Center, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Complete Care Community Health Center, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted by the Sponsor on January 1, 2017. The Plan is a defined contribution plan covering eligible employees of Complete Care Community Health Center, Inc. (the “Organization” or “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent amendments.

Plan administration - The Organization is the Plan Sponsor and Plan administrator and is responsible for oversight of the Plan and for monitoring investment activity. Allied Consultants, Inc. (the “TPA”) is the Plan’s third-party administrator. John Hancock Life Insurance Company (the “Custodian”) is the custodian of the Plan’s assets and record-keeper and is responsible for maintaining individual participant account balances and holding investments.

Tax status - The Plan document is a non-standardized pre-approved 401(k) profit sharing plan offered by the TPA. The Internal Revenue Service (“IRS”) has determined and informed the TPA by a favorable opinion letter dated June 30, 2020, that the non-standardized profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (the “Code”). The Plan has been amended since adoption; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Participation - An employee is eligible to make contributions to the Plan upon attaining the age of 21 and completion of one year of service. Employees are eligible for Sponsor’s discretionary profit sharing and safe harbor contributions upon attaining the age of 21 and completion of one year of consecutive service. Eligible employees may enter the Plan semi-annually after they satisfy the eligibility requirements.

Participant contributions - Participant salary reduction contributions to the Plan may be deferred as a flat amount or as a percentage of regular compensation. However, the total of these salary deferral contributions may not, in any calendar year, exceed limitations set by the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Sponsor contributions - The Sponsor may make discretionary non-elective profit sharing contributions to the Plan annually. Discretionary profit sharing contributions are allocated as of the last day of the Plan year to eligible participants and are allocated based on a discretionary formula. For the year ended December 31, 2024, the Sponsor contributed \$798,495 to the Plan for discretionary profit sharing contributions. The Sponsor may also make annual ADP test safe harbor contributions equal to 3% of the employee's compensation. Safe harbor contributions are allocated as of the last day of the Plan year to eligible participants. For the year ended December 31, 2024, the Sponsor contributed \$223,870 to the Plan for safe harbor contributions. The discretionary profit sharing and safe harbor contributions totaling \$1,022,365 and \$866,490 are included in Sponsor contributions receivable at December 31, 2024 and 2023, respectively.

Participant accounts - Separate accounts are maintained for each participant's deferred compensation, rollover contributions, and the Sponsor's contributions. All gains, income, or losses are allocated separately to each participant's account, based on the performance of the investments within that account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions into any or all of the investment accounts with the Custodian.

Vesting - Participants are fully vested in their contributions and Sponsor safe harbor contributions plus actual earnings thereon. The Sponsor discretionary profit sharing contributions, plus actual earnings thereon, vest ratably over six years of service in which the employee works at least 1,000 hours during each year, as follows:

Forfeitures - Non-vested Sponsor profit sharing contributions forfeited by participants upon termination are available to reduce future payments of the Sponsor's contributions or Plan administration fees. The total available forfeiture balance to reduce Sponsor contributions as of December 31, 2024 and 2023 was \$0 and \$6,448, respectively. Forfeitures amounting to \$84,244 and \$9,125 were used to reduce Sponsor contributions during the year ended December 31, 2024 and 2023. Additionally, forfeitures from 2025 totaling \$1,478 were used to reduce Sponsor contributions during the year ended December 31, 2024.

Payment of benefits - Upon termination of employment due to termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum distribution or direct transfer to either an Individual Retirement Account or a qualified retirement plan. Other withdrawals from the Plan can be made under certain circumstances, as defined in the Plan agreement. In-service distributions are not permitted by the Plan.

Hardship withdrawals - In the event a participant experiences a financial hardship as defined in the Plan agreement, the participant may be eligible to request a hardship withdrawal. Hardship withdrawals are only available on salary reduction contributions under the Plan. There were no hardship withdrawals during the year ended December 31, 2024.

Notes receivable from participants - Participants may borrow against their accounts in amounts not less than \$1,000 and not to exceed the lesser of \$50,000 or 50% of their vested account balance. Loans to participants are collateralized by the participant's vested account balance. Repayment schedules for notes receivable from participants are as agreed upon by the participant and the Plan administrator, but cannot exceed repayment terms defined by the Code. Generally, notes mature within five years unless the note is for the purchase of a personal residence. Principal and interest are paid ratably through payroll deductions. Interest on new notes is determined by the Plan administrator as the published prime lending rate, at the time of origination.

Plan termination - Although it has not expressed an intent to do so, the Sponsor reserves the right under the Plan, to cease contributions and terminate the Plan, subject to action by the Sponsor's Board of Directors and subject to the provisions of ERISA and the Code. Upon termination of the Plan, all participants become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation - The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value measurements - The Plan measures fair value under a framework that utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs which prioritize the inputs used in measuring fair value are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Realized and unrealized appreciation (depreciation) - Realized and unrealized appreciation (depreciation) is based on the market values of the assets at the end of the Plan year compared to the market values of the assets at the beginning of the Plan year, or at the time of purchase for assets purchased/exchanged during the Plan year. In the Statement of Changes in Net Assets Available for Benefits, the Plan presents the net appreciation or depreciation in the fair value of investments, which consists of realized gains or losses and unrealized market value appreciation or depreciation of investments.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Outstanding notes receivable from participants at December 31, 2024 bear interest at rates between 4.25% and 9.50% and mature through July 2033.

Participant distributions - Benefits paid to participants are recorded when paid.

Plan expenses - Non-investment costs and certain administrative expenses of the Plan are paid by the Sponsor, which is a party-in-interest. These expenses are not reflected in the accompanying financial statements and constitute exempt transactions under ERISA. Investment service fees are paid by the Plan and are netted against the related investment income. Certain administrative expenses are paid by the Plan.

Income taxes - Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

During the year ended December 31, 2024, the Plan did not meet ERISA's bonding requirement threshold. ERISA requires that employee benefit plans be covered by a fidelity bond to protect the Plan from losses due to fraud or dishonesty. In the absence of adequate coverage, the fiduciary and trustee of the Plan can be held personally liable for losses that should have been covered by a fidelity bond. As of the date these financial statements were available to be issued, Plan management is evaluating steps to ensure compliance with the ERISA bonding requirements going forward.

Subsequent events - Subsequent events have been evaluated by the Sponsor through October 14, 2025, which is the date these financial statements were available to be issued.

NOTE 3 - INVESTMENTS AND FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts - The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of financial statement dates and recent transaction prices. Each of the subaccounts of the John Hancock Life Insurance Company pooled separate accounts invests in a single, open-ended mutual fund which is generally identified in the name of the pooled separate sub-account. Each pooled separate sub-account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value ("NAV") per unit. The pooled separate accounts are measured at fair value using NAV (or its equivalent) as a practical expedient. These investments have no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, all fair value investments were valued using NAV as a practical expedient, and accordingly, no fair value hierarchy table was presented.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest, by definition, include a plan sponsor or employee, fiduciaries (including those who provide investment advice or who have discretionary control over Plan assets), and those who provide services to the Plan. Notes receivable from participants qualify as exempt party-in-interest transactions. Plan investments include certain investments in pooled separate accounts' shares managed by the Custodian as of December 31, 2024 and 2023. Transactions with these entities qualify as exempt party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIAN OF PLAN ASSETS (Unaudited)

Management has elected to have the 2023 audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the Custodian of the Plan, has certified that the following investment information is complete and accurate:

- All amounts included as investments and notes receivable from participants in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment income included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- All information in the Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6 - PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Plan did not comply with the regulations concerning the timely remittance of participants' contributions for one significant remittance to the trust containing assets for the Plan, which is a prohibited transaction under ERISA regulations. Accordingly, participants' contributions, including loan repayments, totaling \$20,176 were remitted to the Plan late as described in the supplemental schedule (Schedule H, Part IV, Line 4(a) - Schedule of Delinquent Participant Contributions). The principal amount of the contributions has been remitted to the Plan. However, in order to complete the correction, lost earnings must also be remitted by the employer. The Plan Sponsor will compute the lost earnings and will remit to the Plan in 2025.
