- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets Held at End of Year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements Year Ended December 31, 2024

1. Description of Plan

The following brief description of Lewis-Watkins-Farmer Agency, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Lewis-Watkins-Farmer Agency, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). EPIC Retirement Plan Services is the recordkeeper (the “Recordkeeper”) and, effective May 29, 2024, the Plan’s custodian is Charles Schwab Trust Bank (the “Custodian”). Prior to May 29, 2024, Mid Atlantic Trust Company (the “Former Custodian”) served as the custodian of the Plan. An officer of the Company acts as trustee of the Plan.

Eligibility - Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following their hire dates. Certain employee classes are excluded from participation in the Plan, as defined. A participant must be employed on December 31 and complete a year of service, as defined, to be eligible for a discretionary employer profit-sharing contribution.

Contributions - Eligible employees may authorize the Company to withhold pre-tax and Roth contributions, up to the annual limit established by the Internal Revenue Code (“IRC”). All newly eligible employees are automatically enrolled in the Plan with a pre-tax deferral percentage of 3%, unless the employee changes the election. A participant’s pre-tax and Roth contributions are separately accounted for, as are the gains and losses attributable to each. Participants who have reached fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Company may make a discretionary employer matching and/or profit-sharing contribution. The Company elected to make an employer matching contribution equal to 50% of the first 6% of contributed compensation during the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Notes Receivable from Participants - Notes receivable from participants are not permitted.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on years of credited service. A participant is 100% vested after five years of credited service, as defined, which is earned in 20% increments annually. Participants may also become fully vested upon reaching retirement age, if they become disabled while employed with the Company or terminate employment due to death.

Payment of Benefits - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, partial withdrawals or installments under certain circumstances, or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, distribute separated participants' account balances that are less than \$1,000 in a lump sum or transfer separated participants' account balances that are at least \$1,000 but less than \$7,000 (an increase from \$5,000 effective January 1, 2024) into an individual retirement account. In-service distributions of rollover contributions may be taken at any time. Other in-service distributions, including hardship distributions, are permitted if certain criteria are met.

Forfeitures - Forfeitures by participants of unvested Company contributions are used to pay Plan administrative expenses and to reduce future employer contributions. The forfeiture balances as of December 31, 2024 and 2023 were not significant, nor was the related activity for the year ended December 31, 2024.

Current Legislation - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

2. Significant Accounting Policies

Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the Custodian and Former Custodian (collectively, the "Custodians"), the Recordkeeper and investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions Receivable - Contributions from participants and any related employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation. The Company recognizes an allowance for credit losses based on factors such as the age of the contribution receivable balance, historical experience, current economic conditions, and reasonable and supportable forecasts. There was no allowance for estimated credit losses as of December 31, 2024 or 2023 as management deemed the outstanding contribution receivable balance collectible.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses and Revenue Sharing - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to distributions, recordkeeping and other professional fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

The Plan has revenue sharing arrangements whereby certain investment managers return a portion of the investment fees to the Recordkeeper. These amounts are used by the Recordkeeper to offset the Plan's administrative expenses or to allocate to participant accounts, as defined, with any excess amounts held in an unallocated account to be used in future years. Amounts used by the Company to offset administrative expenses incurred by the Plan were not significant during the year ended December 31, 2024.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan has cash deposited with certain financial institutions and is exposed to credit risk related to the potential inability to access liquidity in financial institutions where its cash is concentrated.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contribution portion of their accounts.

Subsequent Events - The Company evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

3. Information Certified by the Custodians

Certain information in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments held as of December 31, 2024 and 2023, and the related net investment gain during the year ended December 31, 2024, was obtained by management and agreed or derived from information certified as complete and accurate by the Custodian and Former Custodian, which are qualified institutions.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Common/collective trusts are pooled investment vehicles designed primarily for certain qualified retirement plans. The fair values of these investments have been estimated using the net asset values per unit as a practical expedient, as provided by the fund managers, and are based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported net asset values. There are no restrictions on redemptions, units may be redeemed daily and there are no unfunded commitments. If the Plan initiates a redemption of more than \$1,000,000 from any common/collective trust, the issuer requires a five-business day advance written notice prior to distribution.

Interest-bearing cash: Interest-bearing cash is stated at cost, which approximates fair value.

5. Tax Status

The Company has adopted a pre-approved plan document from the Recordkeeper that received an Internal Revenue Service ("IRS") opinion letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest and Related Party Transactions

Fees earned by the Custodians, Recordkeeper and investment advisor are included in administrative expenses and net appreciation in fair value of investments, as applicable. Certain investment managers return a portion of the investment fees to the Recordkeeper, which are used to offset administrative expenses or to allocate to participant accounts, as defined. Transactions such as these qualify as exempt party-in-interest transactions. The Company pays directly certain other fees related to the Plan's operations.
