Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ABARTA, Inc. Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet(s) the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the trustees of the Plan approved a plan to terminate the Plan effective April 24, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from



error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements

1. Description of the Plan

The following description of the ABARTA, Inc. Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan is a noncontributory, defined benefit pension plan which provides for pension, disability and preretirement spouses' death benefits for substantially all non-union employees of ABARTA, Inc. (the Company and Plan Sponsor) and its subsidiaries: The Cleveland Coca-Cola Bottling Company, Inc.; Coca-Cola Bottling Company of the Lehigh Valley; Coca-Cola Bottling Company of Chester County, Inc.; ABARTA Coca-Cola Beverages, LLC and ABARTA Oil & Gas Company, Inc. Additionally, the Plan includes employees who are members of the Pipefitters Local 120. The Company is the plan sponsor and administrator that controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (FMTCC) serves as the trustee of the Plan's investments. The Plan's investments are maintained within the ABARTA, Inc. Master Trust (Master Trust) concurrently with those of two other pension plans of the Company.

Prior to August 31, 2015, employees became eligible upon completion of one year of continuous service, as defined by the Plan, and attaining age 21. Entry dates were the first day of January and July. Eligible employees accumulated years of service for vesting purposes from the date of hire to the date of retirement. Participants became fully vested upon completion of five years of continuous service, as defined by the Plan.

Effective August 31, 2015, benefits for existing participants with less than five years of service were frozen and no additional benefits are earned for future services. Additionally, no new employees are eligible to participate in the Plan.

Effective July 1, 2018, benefits for all existing participants who were not subject to a collective bargaining agreement were frozen and no additional benefits are earned for future services.

Effective September 1, 2018, benefits for all existing participants who were members of Pipefitters Local 120 were frozen and no additional benefits are earned for future services.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On April 24, 2024, the Board of Directors of ABARTA, Inc. approved to terminate the Plan effective immediately and directed the plan administrator to proceed with the termination process in accordance with applicable legal requirements. The net assets of the Plan will be allocated for payment of plan benefits to the participants in an order of priority determined in accordance with ERISA, applicable regulations thereunder and the plan agreement. All participants became fully vested at the termination date. Until termination of the Plan is complete, the Plan will continue to operate as usual.

Notes to the Financial Statements (Continued)

Upon adoption of the liquidation basis of accounting, the plan recorded accrued expenses expected to be incurred in liquidation of \$273,695. Current liabilities are expected to be settled with existing Plan assets.

All participants were offered an option to receive a lump sum distribution. For all participants who did not elect a lump sum distribution, the Plan purchased an annuity from a third-party insurance company which will make all future benefit payments to participants included in the contract. The Plan was fully liquidated as of September 30, 2025.

Pension Benefits

Participants are entitled to receive distributions of their benefits upon retirement at age 65 or a later actual retirement date. The Plan also contains provisions for early retirement, generally with reduced benefits.

Benefits are calculated based on years of service multiplied by a percentage of average monthly earnings and excess covered compensation as described in the plan document.

Upon retirement, participants receive the value of their benefits in the form of a monthly payment over the remainder of their lives with a reduction in benefits for those participants who have chosen a joint surviving spousal benefit option. The Plan also provides for a life annuity, joint and survivor annuity or lump-sum payment as optional forms of benefit payment.

An employee covered by a prior plan of the Company, as defined by the Plan, will receive a benefit equal to the greater of the benefit calculated under the Plan or the benefit calculated under the prior plan of the Company.

Funding Policy

Contributions to provide benefits under the Plan are made solely by the Company. The Company's funding policy is to make cash contributions to the Plan in amounts determined by the Plan's actuary. The actuarial assumptions utilized have been designed to provide sufficient funds to pay benefits as they become eligible under the Plan. The Company met the minimum funding requirements of ERISA for the years ended December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

The 2024 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, Liquidation Basis of Accounting. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on April 24, 2024. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting,

including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, the actuarial present value of accumulated plan benefits, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits and changes in actuarial present value of accumulated plan benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Master Trust investments are reported at fair value. Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds are valued at quoted market prices, which represent the Net Asset Value (NAV) of shares held at year end and are classified within Level 1 of the fair value hierarchy.

Commingled funds are valued at NAV based on the fair value of the underlying net assets as determined by the fund managers. The NAV is used as a practical expedient to estimate fair value. The NAV is provided by the fund manager and is based on the fair value of the underlying investments held by the funds less their liabilities. Were the Plan to initiate a full redemption of a collective trust, the investment advisor generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments.

Notes to the Financial Statements (Continued)

Hedge funds are valued using NAV, which approximates fair value. NAV is based on the unit values of the interests. Unit values are determined by the issuer sponsoring such interests by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Fees and Expenses

Administrative fees and expenses are paid by the Plan, as provided in the plan document. However, services provided by the actuary are paid for by the Company.

Benefit Payments

Benefits are recorded when paid.

Consideration of Subsequent Events

Plan management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 15, 2025, the day the financial statements were approved and authorized for issue.

3. Accumulated Plan Benefits

Accumulated plan benefits are those future benefit payments attributable under the Plan's provisions for service that employees have rendered. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the benefit information dates and the expected payment dates. The effect of plan amendments on accumulated plan benefits is recognized during the year in which the amendments become effective.

- (b) *Hedge Fund* - The investment objective of this partnership is to make investments in less liquid and/or longer-duration private and public securities and other financial instruments (including, without limitation, senior, secured and unsecured bank debt and public debt, junior debt, bonds, trade claims, equities and convertible securities, options, swaps (including credit default swaps) and other derivatives of U.S. and non-U.S. companies that are (i) experiencing financial distress; (ii) attempting to complete an out-of-court restructuring, including spin-offs and recapitalizations; (iii) involved in a bankruptcy, liquidation or similar proceeding; (iv) involved in substantial litigation; and/or (v) expected to have an investment horizon greater than two years). The fair value of equity securities, fixed income investments, over-the-counter derivative contracts and mortgage-backed securities is determined based on quoted market prices. The fair value of bank debt and trade claims is determined based upon indicative quotes and bids or recent trades obtained from the principal market makers and market data providers using the average “bid” price. The fair value of special purpose entities is valued based on the underlying investments within each SPE using valuation techniques consistent with the fund. Distributions to the plan sponsor are provided within 30 days after the end of each fiscal quarter, subject to the general partner’s sole discretion. The general partner commenced with the dissolution of the fund on February 5, 2020.

Certain investments will remain in the portfolio for an undetermined period as the fund looks to maximize return on investments. The Plan has no unfunded commitments relating to the fund at December 31, 2024 or 2023.

- (c) *Private Equity* - The investment objective of these partnerships is to achieve long-term capital appreciation through a diversified portfolio of regional venture capital opportunities. Fair value is determined through valuation techniques provided by the investment manager. Each of the underlying partnerships has an approximate ten-year life, and there is no ability for the plan sponsor to redeem prior to the conclusion of the partnership. The Plan has no unfunded commitments relating to the fund at December 31, 2024 or 2023.

6. Certification of Financial Information

Certain information disclosed in the accompanying financial statements related to investments held in the Master Trust as of December 31, 2024 and 2023, and the Plan’s interest in net investment income of the Master Trust for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

7. Related Parties and Exempt Parties-in-interest Transactions

Certain plan assets are invested in investments managed by the trustee of the Plan. Additionally, the Plan paid certain administrative fees and expenses to the trustee, third-party administrator, and various investment managers. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

8. Income Tax Status

The Internal Revenue Service determined and informed the Company by letter dated March 6, 2017, the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

10. Purchase of Annuities

In October 2023, the Plan entered into an annuity buyout agreement with an insurance company to sell a portion of the Plan's assets and liabilities. The insurance company will make all future benefit payments to participants specified in the contract that applied to certain retired participants. As a result, approximately \$7.7 million was paid to a third-party insurance company from plan assets.

In November 2024, the Plan entered into an annuity buyout agreement with an insurance company to sell a portion of the Plan's assets and liabilities. The insurance company will make all future benefit payments to participants specified in the contract that applied to certain retired participants. As a result, approximately \$25.5 million was paid to a third-party insurance company from plan assets.
