Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Fruhauf Uniforms, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Fruhauf Uniforms, Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan prototype plan and adoption agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering employees of the Company who are age twenty-one or older and have one year of service consisting of a minimum of 1,000 hours. Leased employees, employees covered under collective bargaining agreements and non-resident alien employees who do not have income from U.S. sources are not eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The board of trustees oversees governance of the Plan. The Plan's Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

b. Contributions

Participants may contribute a percentage of their compensation to the Plan, not to exceed the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company will make a matching contribution equal to 25% of the participant's contributions up to 4%, for a maximum employer contribution of 1%. The Company may make an additional profit sharing contribution at its own discretion. Participants direct the investment of both participant and employer contributions. Contributions are subject to certain statutory limitations.

The Plan also permits rollover contributions from plans of eligible employees who have not yet satisfied certain age and eligibility service requirements.

c. Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Company's matching contributions, Plan earnings, and administrative fees. Forfeitures in excess of administrative expenses can be allocated to participants' accounts in lieu of Company contributions. Allocations are based on participant earnings or account balances, as defined. The participant is entitled to a benefit equal to his or her vested account balance.

Participants may choose from various funds, as listed in the financial statements, in which to invest their accounts. Participants may change their investment options at any time throughout the year via direct phone access or the Plan's third-party administrator.

d. Investment Elections

The participant contributions and the Company matching contributions are allocated to the various investment options offered by the Plan as directed by participants. The Plan currently offers registered investment accounts (mutual funds) and guaranteed investment accounts, principally run by Nationwide Trust Company, as investment options for participants

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service, as follows:

f. Notes Receivable from Participants

Loans to participants are not permitted.

g. Payment of Benefits

On termination of service, a participant may elect to receive either a lump sum equal to the value of the participant's vested interest in his or her account, or in various installment payments in the year following termination. Vested account balances of \$1,000 or less will be distributed in a lump sum without the consent of the participant. Additionally, participants will begin receiving distributions from their accounts upon the attainment of age 70 ½ (or later depending on birthdate) or termination of employment, whichever is later.

h. In-Service Withdrawals

Participants may make withdrawals of any or all of their vested account balances upon attainment of age 59 ½ or normal retirement age.

i. Forfeited Accounts

Forfeitures from the non-vested account balances of terminated participants are used to reduce employer contributions for a Plan year. As of December 31, 2024 and 2023, the forfeiture account balances were \$-0- and \$141, respectively. In 2024, \$147 of the forfeitures were used to reduce employer contributions.

j. SECURE Act 2.0

In December 2022, the President signed into law the Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE Act 2.0), which expands retirement coverage and saving opportunities. Some of the significant changes that will take effect January 1, 2025, include the following:

- Automatic enrollment of participants and escalation features for employee contributions
- Reduced the requirement to allow long-term, part-time workers to participate in employers' 401(k) plans to two years

j. SECURE Act 2.0 (continued)

- Increase catch-up limits for individuals who have attained the age of 60-63 during the calendar year

The Plan must be amended to reflect the changes resulting from Secure Act 2.0 by December 31, 2026.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan’s valuation policy. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

d. Benefits

Benefits are recorded when paid.

e. Plan Administrative Expenses

Officers or employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan.

3. Fair Value Measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies (mutual funds) are categorized as level 1. Fair value is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

4. Investment Information Prepared and Certified by Custodian

The Plan has entered into a contract with Nationwide Life Insurance Company for the investment of funds and the payment of benefits provided by the Plan. The Plan offers investments in various registered investment companies which are maintained and administered by Nationwide Trust Company. Participants elect the funds to which their contributions are allocated.

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4i – Schedule of Assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Guaranteed Investment Contracts with Insurance Company

The Plan entered into traditional guaranteed investment contracts with Nationwide Life Insurance Company. Nationwide Life Insurance Company maintains the contributions in its general account and is credited on a daily basis. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than .5%. In 2024, guaranteed interest income was \$11,827.

Since the investment contracts are not fully benefit responsive, they are reported at fair value of \$584,437 and \$529,727 as of December 31, 2024 and 2023, respectively. The Form 5500 reports the contracts at contract value, which was \$664,889 and \$617,038 as of December 31, 2024 and 2023, respectively.

6. Reclassification

The investments at December 31, 2023 were reported as pooled separate accounts. It has subsequently been determined that the investments should have been categorized as registered investment companies. The 2023 investments have been reclassified to reflect this change.

7. Allocated Distributions

Net assets available for benefits at December 31, 2024, include \$154,200 allocated to the accounts of persons who as of or prior to that date had withdrawn from participating in the earnings and operations of the Plan, and \$92,438 allocated to the accounts of persons who as of that date are still participating in the plan. The \$246,638 is payable to former and current employees in 2024.

8. Related Party Transactions

Certain Plan investments are shares of registered investment companies managed by Nationwide Trust Company and guaranteed investment accounts managed by Nationwide Life Insurance Company. Nationwide is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Nationwide for recordkeeping services were \$12,632 for the year ended December 31, 2024.

DeMars Pension Consulting Service, Inc. (DeMars) is the third party administrator. Fees paid by the Company to DeMars for investment management services amounted to \$6,934 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

10. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 22, 2021 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that will more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

11. Concentration of Credit Risk

At December 31, 2024, all of the Plan's investments in registered investment companies and guaranteed investment accounts were held by one financial institution.

12. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

13. Subsequent Events

The Plan Administrator has evaluated events through October 14, 2025 the date the financial statements were available to be issued and determined that there have been no events that have occurred that would require adjustment or disclosure.
